Our success in Africa depends upon having adequate financing to complete the deployments there. Due to the nature of the economic ecosystem, the deployments require local teams to onboard both Merchants and Consumers.

Our future success depends upon capturing early market share in the payment aggregator and Remittance as a Service space. Since we are merging two industries to make it convenient for consumers and merchants to remotely and securely transact with each other, failure to obtain significant early market share will adversely impact revenues.

Our future in Africa depends upon being able to meet the government rules and licensing regulations of multiple countries. Local government laws in Africa vary greatly from nation to nation and there are often many expenses involved in doing business in each country.

The COVID-19 pandemic has disrupted certain business practices between local merchants and customers. This has accelerated the need for digital transformation which requires a learning curve. Our success depends upon the merchants learning how to leverage our products and services for maximum benefit, and also upon consumer acceptance.

Our financial projections are based on our market knowledge and experience in operating in the United States and Africa and upon the past performance of our systems and products. However, because actual future performance depends upon market conditions and events, these projections should not be relied upon solely for the purpose of making investment decisions.

As with any investment, participating in this fundraiser involves a certain degree of risk that you may not realize a significant return, or any return at all, and that you could possibly lose your entire investment

This offering is being conducted on an expedited basis due to circumstances relating to COVID-19 and pursuant to Reg. CF Temporary Rule 201(2)(3), which provides temporary relief from certain financial information requirements by allowing issuers to provide financial information certified by the principal executive officer of the issuer instead of financial statements reviewed by a public accountant that is independent of the issuer.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **Preferred Stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, Investors will receive a number of Preferred Stock calculated using the method that results in the greater number of Preferred Stock:

1. the total value of the Investor's investment, divided by
 1. the price of Preferred Stock issued to new Investors multiplied by
 2. the **discount rate (80%)**, or
2. if the valuation for the company is more than **\$12,000,000.00 (the "Valuation Cap")**, the amount invested by the Investor divided by the quotient of
 1. the Valuation Cap divided by
 2. the total amount of the Company's capitalization at that time.
3. for investors up to the first **\$75,000.00** of the securities, investors will receive a valuation cap of **\$10,000,000.00** and a discount rate of **80.0%**.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving Preferred Stock, Investors will receive proceeds equal to the greater of

1. the Purchase Amount (the "Cash-Out Amount") or
2. the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
2. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
3. Senior to payments for Common Stock.

Irrevocable Proxy. The Investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, will appoint XX Team LLC ("XX Team") as the Investor's true and lawful proxy and attorney (the "Proxy"), with the power to act alone and with full power of substitution, on behalf of the Investor to:

1. direct the voting of all securities purchased through wefunder.com, and to direct the exercise of all voting and other rights of Investor with respect to the Company's securities, and
2. direct, in connection with such voting power, the execution of any instrument or document that XX Team determines is necessary and appropriate in the exercise of its authority. Such Proxy will be irrevocable. If an Investor has entered into the Custodial and Voting Agreement with XX Investments LLC ("XX Investments"), then XX Investments will be the entity that XX Team directs to vote and take any other actions in connection with such voting (including the execution of documents) on behalf of such investor.

Repurchase. If the Company determines, in its sole discretion, that it is likely that within six months the securities of the Company will be held of record by a number of persons that would require the Company to register a class of its equity securities under the Securities Exchange Act of 1934, as amended ("Exchange Act"), as required by Section 12(g) or 15(d) thereof, the Company shall have the option to repurchase the securities from each Investor for the greater of

1. the purchase price of the securities, and
2. the fair market value of the securities, as determined by an independent appraiser of securities chosen by the Company. The foregoing repurchase option will terminate upon a Change of Control or Dissolution Event (each as

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering). These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents. To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. In addition, as discussed above, if a majority-in-interest of holders of securities with voting rights cause the Company to issue additional equity, an Investor's interest will typically also be diluted. Based on the risk that an Investor's rights could be limited, diluted or otherwise qualified, the Investor could lose all or part of his or her investment in the securities in this offering, and may never see positive returns. Additional risks related to the rights of other security holders are discussed below, in Question 20.

Overview

Our company provides digital payments and customer engagement platforms that connect consumers with merchants regardless of their geo location and currency.

With our award winning customer engagement platform, businesses are able to engage with their customers digitally creating repeat customers and boosting spend with every transaction.

Our company also offers logistics including on demand and last mile deliveries to the most rural places for goods ordered through our payments system.

Our goal is to be the global leader in customer engagement, payments (including remote payments), and logistics solutions for small to medium sized businesses. These projections are not guaranteed.

Milestones

Social Media Gateways, Inc. was incorporated in the State of Delaware in April 2012.

Since then, we have:

- Veteran executive team that has the backing of multiple VC's and Angels
- We have an established, functioning infrastructure in East Africa, including our logistics and fintech partners
- We have raised \$2.7+ Million since our Founding
- Deployed successful solutions for over 20 clients, including OfficeMax & HP, increasing their customer engagement by 30%

Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$56,300 compared to the year ended December 31, 2019, when the Company had revenues of \$47,630. Our gross margin was 55.6% in fiscal year 2020, compared to 37.01% in 2019.

- *Assets.* As of December 31, 2020, the Company had total assets of \$383,160, including \$3,969 in cash. As of December 31, 2019, the Company had \$358,190 in total assets, including \$4,266 in cash.

- *Net Loss.* The Company has had net losses of \$43,629 and net losses of \$67,180 for the fiscal years ended December 31, 2020 and December 31, 2019, respectively.

- *Liabilities.* The Company's liabilities totaled \$369,570 for the fiscal year ended December 31, 2020 and \$344,600 for the fiscal year ended December 31, 2019.

Liquidity & Capital Resources

To-date, the company has been financed with \$2,784,500 in convertibles and \$357,200 in debt.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 1 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Social Media Gateways, Inc. cash in hand is \$21,545, as of January 2021. Over the last three months, revenues have averaged \$5,000/month, cost of goods sold has averaged \$2,500/month, and operational expenses have averaged \$3,070/month, for an average burn rate of \$570 per month. Our intent is to be profitable in 6 months.

Whereas in the past we focused primarily on an enterprise SaaS model in the US, we have recently transitioned to a transactional model with operations in the USA and Africa.

We have raised \$2M+ over a period of 8 years. All our raises were tranching over this period of time (years) and not given out at once, which made it very difficult to plan accordingly. Because we were focused on enterprise business, it took a lot of cash to close enterprise brands. Without adequate funding, closing enterprise brands is very difficult.

Overall, being tranching over a period of years by getting just the minimum, and sometimes even less, has held us back from accelerating and moving our enterprise business forward. We decided to pivot to B2C because the onboarding cost is way cheaper than the enterprise onboarding cost. Thus, while we have been operational for the past 8 years, revenues have remained low and we are now gearing up for a pivot and rapid acceleration of the business.

Assuming we raise our max target of \$250K, we project gross revenues of \$750,000 ARR from both our revenue models: Percentage on transactions and SaaS monthly revenue. Accompanying expenses are projected to be around \$450,000 ARR.

We are looking to raise \$3M+ for Series A round, immediately following this bridge round. We do have soft commitments to participate, but no exact amount has been discussed yet. If necessary, founders will finance the Company's operations during the Wefunder raise.

XX Investments does charge the Company \$1,000/year for services; however, those fees may be paid by Wefunder Inc. on behalf of the Company.

As noted, XX Team holds a power of attorney from each Investor that has entered into the Investor Agreement to make voting decisions on behalf of that Investor. Pursuant to the power of attorney, XX Team will make voting decisions and then direct XX Investments to vote and take any other actions in connection with the voting on Investors' behalf. XX Team will act, with respect to the Company, through our Lead Investor, who is a representative of XX Team. As compensation for its voting services, each Investor authorizes XX Investments to distribute to XX Team 10% of any distributions the Investor would otherwise receive from the Company. XX Team will share its compensation with our Lead Investor. XX Team, through our Lead Investor, may also provide consulting services to the Company and may be compensated for these services by the Company; although, fees owed by the Company may be paid by Wefunder Inc. XX Team will share its consulting compensation with our Lead Investor.

The Lead Investor is an experienced investor that we choose to act in the role of Lead Investor, both on behalf of the Company and on behalf of Investors. As noted, the Lead Investor will be a representative of XX Team and will share in compensation that XX Team receives from the Company (or Wefunder Inc. on the Company behalf) or from Investors. The Lead Investor will be chosen by the Company and approved by Wefunder Inc., and the identity of the Lead Investor must be disclosed to Investors before Investors make a final investment decision to purchase the Company's securities. Investors will receive disclosure regarding all fees that may be received by the Lead Investor. In addition to the fees described above, the Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a special purpose vehicle ("SPV") for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such a circumstance, the Lead Investor may act as a portfolio manager for that SPV (and as a supervised person of Wefunder Advisors) and may be compensated through that role. Although the Lead Investor may act in multiple roles and be compensated from multiple parties, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of the Company's securities. As a result, the Lead Investor's interests should always be aligned with those of the Investors.

Investors that wish to purchase the Company's securities through Wefunder Portal must agree to (1) hire XX Investments to serve as custodian, paying agent, and proxy agent with respect to the Company's securities; (2) give a power of attorney to XX Team to make all voting decisions with respect to the Company's securities; and (3) direct XX Investments to share 10% of the Investor's

distribution from the Company with XX Team. The Company may waive these requirements for certain investors with whom the Company has a pre-existing relationship.

The XX arrangement described above is intended to benefit the Company by allowing the Company to reflect one investor of its capitalization table (XX Investments) and by simplifying the voting process with respect to the Company's securities by having one entity (XX Team), through one person (the Lead Investor), make all voting decisions and having one entity (XX Investments) carry out XX Team's voting instruments and any take any related actions. The XX arrangement also is intended to benefit Investors by providing the services of an experienced Lead Investor (acting on behalf of XX Team) who is expected to make value-maximizing decisions regarding Investors' securities. XX Team (acting through the Lead Investor) may further benefit both the Company and Investors by providing consulting services to the Company that are intended to maximize both the value of the Company's business and also the value of its securities.
