We are currently involved in litigation with New York University relating to a prior intellectual property license, and the matter may involve costs, liabilities, or other impacts on our business.

New York University ("NYU") has filed a lawsuit concerning a license agreement originally entered into in 2012 with NYU Poly and later modified. NYU asserts that we owe minimum royalty payments and certain patent-related expenses under that agreement and related arrangements.

We dispute NYU's claims and believe we have defenses and potential counterclaims. The outcome of the litigation is uncertain, and we cannot predict how or when the matter will be resolved.

This litigation may result in legal expenses, management time, and potential monetary exposure, including the possibility of settlement or other resolutions. Regardless of the outcome, the process of responding to and defending against the lawsuit could affect our financial condition, results of operations, or ability to raise additional capital.

Investors should carefully consider the risks associated with this litigation when evaluating an investment in our securities.

The Company previously resolved a dispute with a former executive pursuant to a settlement agreement, under which the Company agreed to pay approximately \$322,000, subject to applicable taxes and withholdings. The

Company has recently received communications relating to potential non-payment under that agreement, and there is a possibility that the former executive may seek to assert or reassert claims arising out of or relating to the underlying dispute and settlement. As of the date of these financial statements, no new litigation has been initiated.

The Company is involved in a lawsuit initiated by USAR Labs in the Supreme Court of the State of New York, New York County, relating to disputes over technology services, infrastructure access, and related contractual arrangements. In January 2026, the court issued a decision determining that the Company is liable for a portion of the amounts claimed by USAR Labs, corresponding to certain invoices within a defined period. The court declined to enter final judgment on those amounts pending resolution of the Company's counterclaims, which may offset, in part or in whole, the amounts otherwise payable. The ultimate amount of liability, if any, will depend on the outcome of the remaining litigation.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

HEVO Inc. is offering up to 2,211,441 shares of Series A-2 Preferred Stock, at a price per share of \$1.9991.

The campaign maximum is \$4,420,892.00 and the campaign minimum is \$50,000.00.

## **Securities Issued by the SPV**

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. While the Issuer may be required to pay an annual administrative fee for the maintenance of the SPV, investors should note the Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

## **Voting Rights**

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

## **Proxy to the Lead Investor**

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

Holders of the Preferred Stock are entitled to dividends on an as-if-converted basis in the same form as any dividends actually paid on shares of Common Stock. In the event of a liquidation event, the holders of Preferred Stock are entitled to be paid out of the Company assets available for distribution before Common Stockholders at the greater of i) 1 times the original issue price for the Preferred Stock and ii) the amount per share that would have been payable had the Preferred Stock been converted to Common Stock immediately prior to such liquidation event.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

HEVO, Inc. was organized under the laws of the State of Delaware on November 1, 2011. The Company was founded to provide safe, seamless, and universal wireless charging equipment and software that can improve the efficiency of charging electric vehicles (EV). The Company's product, the Rezonant E8 is an 8kW Level 2 charger is the "only wireless and plug-in capable electric vehicle charger in the world". The Rezonant E8 is the "wireless charger that has met SAE-J2954 specifications and has also completed UL-2750 safety testing". The Company's headquarters are in Brooklyn, New York.

## Milestones

HEVO Inc. was incorporated in the State of Delaware in November 2011.

Since then, we have:

- Partnering with Stellantis: Developing wireless charging products to integrate with Stellantis EV
- More Major Automakers Onboard: HEVO chosen as reference design for multiple new EV platforms

- Team with multiple exits in EV space and leadership experience at Tesla, Rivian, BMW, Ford, and GM.
- \$18M+ raised, including \$4M+ from 3,700 investors in previous crowdfunding raises
- Strong IP portfolio with 17 patent families
- EV Charging Market Growing 45.5% per year, expected to hit \$414B by 2033, from \$21.8B today

## Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2025, the Company had revenues of \$108,430 compared to the year ended December 31, 2024, when the Company had revenues of \$325,291.
- *Assets.* As of December 31, 2025, the Company had total assets of \$893,817, including \$268 in cash. As of December 31, 2024, the Company had \$1,173,662 in total assets, including \$27,940 in cash.
- *Net Loss.* The Company has had net losses of \$1,098,694 and net losses of \$3,029,332 for the fiscal years ended December 31, 2025 and December 31, 2024, respectively.

## Liquidity & Capital Resources

To-date, the company has been financed with \$1,233,640 in debt, \$5,140,820 in equity, \$4,811,167 in convertibles, and \$9,155,909 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 3 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 3 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

### **Runway & Short/Mid Term Expenses**

HEVO Inc. cash in hand is \$244,714.33, as of September 2025. Over the last three months, revenues have averaged \$36,000/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$90,000/month, for an average burn rate of \$54,000 per month. Our intent is to be profitable in 36 months.

Since the date of our financials, we have had SAFE notes from existing accredited investors that we plan to finalize by end of December 2025. Those internal Regulation D 506(b) investors have the option to redeem the SAFE with interest. The targeted funding for this private offering is \$250K total.

We have an existing agreement with a major automaker for approximately \$217K that will expect to be paid in the next 3-6 months. We anticipate incurring approximately \$115k in monthly expenses during the same time period.

We are not profitable and our financial projections show that the company needs to raise a total of approximately \$30M to reach profitability.

For additional sources of capital, we have over 300 accredited investors and over 3,000 non-accredited investors with many that we anticipate will participate in this Reg CF offering.

Wefunder Advisors LLC forms a fund (“Fund”) for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. 4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
