- Our distributor, Acort International may not make perform the amount of domestic and foreign film licenses that they initially projected. As well, these potential domestic and foreign film sub-licensors may not, for whatever reason, remit the actual agreed upon funds to Acort International.

- This film, Devil's Junction: Handy Dandy's Revenge, may perform very poorly and not generate the full investment return.
- World wide distribution may result in currency fluctuations if any deals are not made in US dollars. This could result in lower funds received from those specific contracts.
- Because this is a horror film, it may or may not be accepted in certain countries that might normally accept a different genre American-made film. This may result in lower world wide revenue.
- Donald Borza II is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.
- Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.
- Acort International may cease to do business and not remit in full license fees owed to MJE Handy Dandy Productions, LLC.

USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

MJE Handy Dandy Productions, LLC, is offering up to 74 Class A Units, at a unit price of \$1,000.

Investors will also receive distributions of net cash proceeds, if any, from any of the Company's investments will be made in the following order of priority: first, on a pro-rata basis to the Investors holding Class A Units until such Investors receive one hundred ten percent (110%) of their original investment; and thereafter, sixty percent (60%) on a pro-rata basis to Investors holding Class A Units and forty percent (40%) to the holder of the Class B Unit.

These Class A Units do not have voting rights.

Purchaser irrevocably constitutes and appoints Don Borza, with the full power of substitution, his, her or its true and lawful attorney to make, execute, swear to, acknowledge, deliver and file in his name.

The Investor hereby agrees to take any and all actions determined by the Company's board of directors in good faith to be advisable to reorganize this instrument and any Class A Units issued pursuant to the terms of this instrument into a special-purpose vehicle or other entity designed to aggregate the interests of unitholders.

If the Company determines, in its sole discretion, that it is likely that within six months the securities of the Company will be held of record by a number of persons that would require the Company to register a class of its equity securities under the Securities Exchange Act of 1934, as amended, as required by Section 12(g) thereof, the Company shall have the option to repurchase this instrument from the Investor for the greater of (i) the Purchase Amount and (ii) the fair market value of this instrument, as determined by an independent appraiser of securities chosen by the Company (such repurchase, the "Repurchase," and such greater value, the "Repurchase Value"); provided, however, that, in the event an Equity Financing occurs within three months after the Repurchase and the Repurchase Value is less than the Aggregate Value (as defined below) of the Class A Units, the Investor would have received had the Repurchase not occurred (where such value is determined by multiplying the number of Class A Units by

the Unit Price and is referred to as the "Aggregate Value"), the Company shall pay to the Investor an amount equal to the difference between the Aggregate Value and the Repurchase Value promptly following the consummation of the Equity Financing. Such independent appraiser shall be regularly engaged in the valuation of securities. The foregoing repurchase option terminates upon a Change of Control or Dissolution Event.

Because the Investor holds no voting rights, the holders of a majority-in-interest of voting rights in the Company could limit the Investor’s rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company’s operations or cause the Company to engage in additional offerings (including potentially a public offering or sale).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. As holders of a majority-in-interest of voting rights in the Company, **the unitholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the unitholders** may change the terms of the articles of incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The unitholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. Other holders of securities of the Company may also

have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

The unitholders have the right to redeem their securities at any time. **Unitholders** could decide to force the Company to redeem their **securities** at a time that is not favorable to the Investor and is damaging to the Company. Investors' exit may affect the value of the Company and/or its viability.

The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby. In the future, we will perform valuations of our common units that take into account factors such as the following:

- unrelated third party valuations of our common units;

Milestones

MJE Handy Dandy Productions, LLC was incorporated in the State of Ohio in April 2018.
