RISK FACTORS

8. The material factors that make an investment in the issuer speculative or risky is listed below:

1. Though the owner, Dick Ewing, has experience in managing a finance & insurance business, he has not been in charge of a brewery taproom before.

2. Big Belly Brewing is a new entity with no prior operations and no cash flow from operations. The craft brewing industry is becoming highly competitive and there is no guarantee the company can meet its forward-looking projections.

3. Investors will have limited control of the company's operations and will depend on the management to make business decisions. The company will need to get a brewery license to sell beer, and there's no guarantee they'll be able to procure one.

4. Company Intends to Obtain Bank Financing. Company has had preliminary talks with the banks. This loan will be used in addition to the money raised in this offering in order to sufficiently capitalize the business. Though no terms are agreed to, it is likely any bank who extends a loan to the Company will have a lien on significant assets of the Company, including the brewing equipment.

5. The construction comes with risks to the build-out and timeline of the general contractor, subcontractor, architects, licensing, and other third parties who are contracted to complete the effort. While there is a milestone schedule to complete the project, the schedule is subject to getting financing, completing the build-out and getting the business fully operational

THE OFFERING

9. What is the purpose of this offering?

Big Belly Brewing, LLC dba Lost Rail Road Brewing Company intends to raise \$10,000 minimum to finance some of their equipment under a Security Agreement for Future Equity, attached in the form c filing. Investors may subscribe up to \$600,000 in this round to help finance equipment, marketing, legal, inventory, working capital, salaries, and furniture/fixtures.

OWNERSHIP AND CAPITAL STRUCTURE

The Offering

13. Describe the terms of the securities being offered.

Big Belly Pub LLC will give the right to future shares in their company. An investor will get a 30% discount on those shares. Big Belly Pub LLC is speculating that they will be worth more than \$2,800,000 in the future. These shares will convert at the next round of capital or liquidity event.

14. Do the securities offered have voting rights?

15. Are there any limitations on any voting or other rights identified above?

Yes, the offered securities do not have voting rights, informational rights, or dividend rights. The shares being offered only represent a percentage ownership that a minority shareholder may hold in the issuer.

16. How may the terms of the securities being offered be modified?

The offered securities may be modified any time before the end of the campaign. If the issuer decides to modify the offered securities, then investors will need to reconfirm their investment in the issuer or their investment will be cancelled. These securities will convert to equity at the next capital raise, and be eligible for buyback rights after one year.

Description of Issuer's Securities

17. What other securities or classes of securities of the issuer are outstanding?

The principal shareholder, Richard Ewing, has preferred shares in the company. The companies preferred shareholders will retain voting rights during this offering, and make decisions for the business.

18. How may the rights of the securities being offered be materially limited, diluted, or qualified by the rights of any other class of security identified above?

The rights of the securities being offered will not have voting, dividend, or a right to a percentage of revenue. The securities being offered simply reflect the percentage that a minority shareholder would hold with the company. The securities that management retains have access to these rights, and will retain decision making rights.

19. Are there any differences not reflected above between the securities being offered and each other class of security of the issuer? If so, please explain below:

Outside of the lack voting rights, distribution, and a right to a percentage of the revenue that the company may generate, there are not differences. The securities being offered are only representative of the percentage of the company that a minority owner may hold in the company.

20. How could the exercise of rights held by the principal shareholders identified in Question 6 above affect the purchasers of the securities being offered?

The officers of the company will retain decision, voting, and dividend rights. The company has full decision rights in the company without a sign-off from non-voting shareholders.

21. How are the securities being offered being valued? Include examples of methods for how such securities may be valued by the issuer in the future, including during subsequent corporate actions.

The securities are being valued at the issuers discretion.

A minority owner will forfeit voting rights to the company, and the company will retain buyback rights after one year. As a minority shareholder without voting rights, you will rely upon the majority shareholders to make decisions that increase the value of your investment.

Minority ownership requires one to hold onto the securities for at least 1 year. After that period, owners can sell their shares at a fair market value, but the company has buy back rights on these securities before they can be offered to another investor who must be an accredited investor.

Lastly, all the equity based securities on the Wunderfund.co funding portal are prohibited for resale based on the terms and conditions set by Big Belly Pub LLC to protect the number of shareholders on their cap table.
