Mainstem has a limited operating history and remains in an early stage of growth. The company's continued success is dependent on a small leadership team's ability to recruit, retain, and adequately support the talent it needs to scale.

Mainstem faces significant competition from existing and incoming players, many of which are and could become far more capitalized than Mainstem.

Mainstem operates in a specialty agricultural niche within a greater commodity malt industry. As such, volatility in commodity markets has the potential to disrupt Mainstem's crop sourcing model and their downstream supply chains.

Mainstem is a B2B company with a relatively small number of potential accounts and is highly exposed to shifting industry trends, for better or for worse.

Mainstem currently outsources 100% of its processing needs, which could result in temporary loss of key services that are required for the company to operate and generate revenue.

Mainstem currently generates over half of its revenue from its largest account. While the relationship is currently very positive and promising, any chance of instability with this account presents a substantial risk to Mainstem.

Stock in Mainstem will hopefully be worth a lot to many different people someday. But for the time being, the value of the stock is determined by a relatively small number of people who believe strongly in the company's future potential. This dynamic, in addition to the fact that stock in Mainstem is not readily transferable and transferable on an open market, makes the investment in Mainstem relatively illiquid compared to other common investments (e.g., publicly traded companies, real estate, gold).

Mainstem may require additional financing to continue its operations. While its primary goal is to increase shareholder equity, subsequent financing may come at the cost of current shareholder equity. Such financing may also never materialize, rendering Mainstem insolvent.

Covid-19 has deeply impacted the industries in which Mainstem operates, from its customer base that thrives on social interaction, to the interstate supply chains it manages. The challenges presented by Covid-19 are also evolving in ways that are difficult to predict. Consequently, Mainstem faces continued risk that Covid-19 will negatively impact its revenue, cost structure, and access to capital.

Alyssa Martinez Neumann is currently a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case, and changes to this arrangement will be important to allow the company to grow to its full potential.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Mainstem Malt, SPC is offering up to 3,272,827 shares of Class A Preferred Stock, at a price per share of \$0.31513.

Investors in the first \$250,000.24 of the offering will receive stocks at a price per share of \$0.28, and a pre-money valuation of \$4,442,666.76.

The campaign maximum is \$999,999.86 and the campaign minimum is \$50,000.16.

Information Rights:

During any period in which the Company is not subject to Section 13 or 15(d) of the Exchange Act and any shares of Series A Preferred Stock are outstanding, the Corporation will (a) transmit by mail to all holders of Class A Preferred Stock (except direct or indirect competitors), as their names and addresses appear in the Corporation's record books and without cost to such holders, annual unaudited financial statements within ninety (90) calendar days after the close of the Company's fiscal year and quarterly unaudited profit and loss statements within forty-five (45) calendar days after the close of each fiscal quarter. This Section will terminate immediately prior to the Company's Initial Public Offering or Sale Transaction.

Tag-Along Rights:

In the event that any party holding 10% or more of the Company ("Selling Party") proposes to sell their shares to a third party ("Third Party"), the Selling Party agrees not to make the sale unless Third Party includes an offer to purchase the shares of the Investors on the same terms. If Third Party has specified a maximum number of shares that they are willing to buy, then the Selling Party and interested Investors may sell their pro-rata share of the amount to be purchased by Third Party.

Drag-Along Rights:

In the event that a majority of each of the Common and Preferred shareholders, voting separately as a Class ("Selling Party") proposes to sell their shares or all or substantially all of the assets of the Corporation, then the voting majorities may compel the minorities to sell their interests in the Company on the same terms offered to that Class of Stock.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to

issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

Preferred A is voting stock provided for our previous priced round and SAFE round investors. Common A is founder round voting stock. Common B is voting stock for the Mainstem option pool.

Preferred stock holds the additional benefit over Common of a 1x liquidation preference.

5,000,000 shares of Common B stock options have been authorized. Options totaling 800,000 shares have been granted as of 4/29/2021, leaving 4,200,000 shares authorized but not yet granted. No options have been exercised and converted to Common B stock at this time.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

Management's Discussion and Analysis of Financial Condition and Results of Operations

Overview

We contract for special lots of grain from conservation-minded family farmers, malt it at partnering craft malt houses, sell the finished malt to brewers and distillers, and help share a compelling supply chain story with beer and spirits fans globally.

We're also developing a tech platform: Headwaters. Its primary goals are to engage consumers with compelling supply chain story, manage market opportunities for artisan products made with our malt, and accelerate progress in our industry.

In 5 years, we hope to be one of the largest craft malt companies in the world, with a Northwest flagship location and a satellite location in Alaska. We will be among the lead innovators in regenerative grain farming, the terror of grains, and

applied malt science. We will be actively using our novel tech platform to engage consumers and accelerate progress in our industry.

These projections cannot be guaranteed.

Milestones

Mainstem Malt was originally organized as an LLC in 2015, but later reorganized as a Washington SPC in 2018.

Since then, we have:

- We sell the #1 non-water ingredient in craft beer (\$29B+ US market) and single malt whiskeys.
- \$1.08MM+ lifetime malt sales w/ 63+ accounts nationally. ~\$500k contracted 2021 sales and growing.
- A new processing partnership cuts our historical COGS by 50%+ and unlocks big growth opportunities.
- We think bigger, beyond malt sales, to tech-enabled supply chain & marketing support for artisans.
- The world's first B Corp maltster, committed long-term to deep sustainability in agriculture.
- Engaged in the craft malt community since 2014; Phil's an active Craft Maltsters Guild board member.
- The "mainstem" is the longest channel in a river network. It's also our metaphor for collaboration.

Historical Results of Operations

Our company was organized in May 2018 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$435,792 compared to the year ended December 31, 2019, when the Company had revenues of \$379,529. Our gross margin was 7.97% in fiscal year 2020, compared to 14.34% in 2019.
- *Assets.* As of December 31, 2020, the Company had total assets of \$270,569, including \$27,461 in cash. As of December 31, 2019, the Company had \$630,264 in total assets, including \$98,887 in cash.
- *Net Loss.* The Company has had net losses of \$146,017 and net losses of \$184,832 for the fiscal years ended December 31, 2020 and December 31, 2019, respectively.
- *Liabilities.* The Company's liabilities totaled \$112,504 for the fiscal year ended December 31, 2020 and \$233,179 for the fiscal year ended December 31, 2019.

Liquidity & Capital Resources

To-date, the company has been financed with \$193,102 in debt, \$325,000 in equity, and \$200,000 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 4 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 2 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Mainstem Malt, SPC cash in hand is \$25,743.70, as of April 2021. Over the last three months, revenues have averaged \$1,727.20/month, cost of goods sold has averaged \$1,389.36/month, and operational expenses have averaged \$12,279.73/month, for an average burn rate of \$11,941.89 per month. Our intent is to be profitable in 12 months.

In January 2021, we signed a service agreement and MOU with a new processing partner, Montana Craft Malt (MCM). The new processing partnership with MCM reduces our COGS by over 50% versus the 2016-2021 supply chains with our two other processing partners, and dramatically improves our positioning in the 2021 market.

During 2021 Q1, we faced limited, aging inventory, and made the decision to suspend malt sales until new inventory could be created through our partnership with MCM. This decision has resulted in a temporary loss of spot (non-contracted) revenue, but has also allowed us to refocus our operations energy on: (1) service to existing contracted customers with Covid-delayed deliveries starting in Q2; (2) preparing our new core products to launch in Q2.

The move to processing at MCM is supported primarily by our malt supply agreement (signed December 2020) to serve our largest customer (Westland Distillery) with more affordable malt. Additional business is already following. By 2022, we expect (but not guarantee) that 90%+ of our malting will be performed at Montana Craft Malt at the reduced cost structure. We expect this dramatic reduction in COGS will unbound our revenue, with no near-term limiting factors beyond effective sales and marketing.

We hope to have moderate revenue gains through 2021, with year end revenues ranging from \$700,000 to \$900,000, at a 15-25% gross margin. By default, operating expenses will be scaled with the goal of reducing our losses compared to 2020. If we raise sufficient capital, we are comfortable continuing to maintain constructive losses near or above 2020 levels.

Note that despite near-zero 2021 Q1 revenue, we are on track to deliver \$500k+ of malt to existing contracts through year end, plus any new spot and contract business that materializes following the mid-Q2 release of our new core products.

We believe we can reach profitability in 2022 with as little as \$250k of additional capital, and may choose to delay profitability to 2023 if we raise sufficient additional capital.

These projections cannot be guaranteed.

Beyond a modest cash reserve, we have a \$60,000 line of credit with a local lender in Walla Walla, Washington and a \$85k limit on our Chase credit card. As of 4/13/2021, the line of credit is currently fully drawn and the credit card has a balance of \$4,624.75.

Deliveries for our \$500k+ of contracted sales have only just started this year, and most of our COGS for these deliveries have already been paid for and the gross margin is pretty comfortably in the 15% ballpark. Accordingly, we believe that this current time reflects the peak of our 2021 cash flow crunch.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such a circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

Tax Filings. In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the Investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.

INSTRUCTIONS TO QUESTION 30: If information is presented to investors in a format, media or other means not able to be reflected in text or portable document format, the issuer should include:
(a) a description of the material content of such information;
(b) a description of the format in which such disclosure is presented; and

ONGOING REPORTING

32. The issuer will file a report electronically with the Securities & Exchange Commission annually and post the report on its website, no later than:

120 days after the end of each fiscal year covered by the report.

1. the issuer is required to file reports under Exchange Act Sections 13(a) or 15(d);

3. the issuer has filed at least three annual reports and has total assets that do not exceed \$10 million;
4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt

securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
