Summarizing the New Reg A Plus Rules Tier 1: -Can raise up to \$20 million in Reg A offerings in any 12-month period (no more than \$6 million in resales by affiliates; no more than 30% of the aggregate of the initial offerings and subsequent offerings for first 12 months may be affiliate resales) -Sold securities are unrestricted (subject to Rule 144) -Subject to basic eligibility and disclosure requirements under previous Reg A -Must file Form 1-A < ...see more
