- Our future success currently depends on the efforts of a small management team (but ideally that will change with a successful investment round). For now, the services of the members of the management team are not fully available at all times, which may have an adverse effect on the company. Additionally, there can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.
- We are creating premium breast pump accessory products. This has not been done before. We know there will be copycats, and our ability to stay ahead of the pack will depend in part on the strength of our IP. Our patent attorneys believe the pending utility patent for our first product will be accepted by the USPTO. But there's no guarantee that it (or any patent generally) will be accepted.
- Compared to other developed countries, U.S. law is pathetic when it comes to family leave policy for working parents. If the legal landscape were to significantly change - for example, if moms were allowed take 1 year of paid leave after the birth of their kids in order to nurse at home (and, therefore, likely obviate the need to pump for most) - it would reduce sales of our products.
- There are many reasons we decided to manufacture in the U.S. Among them is our attempt to cut out various supply chain risks (e.g., political or economic instability of foreign governments; environmental risks; materials integrity/quality). That said, even with domestic manufacturing there are supply chain risks; unanticipated, significant changes to the costs and duration of the manufacturing process are likely to have a negative impact on our company.
- Joe Venti is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.
- Amber Lee Venti is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.
- Large companies in the breast pump space could start innovating the accessory space. Being that these establishment brands have significantly more resources, this competition threat could interfere with our revenues.
- There is a high failure rate for new businesses. While our products have been tested and are extremely reliable, especially when compared to analogous companies, an unexpected product failure can hurt our image and gross sales.

Investors: A “Major Investor” shall be an Investor that purchases a Note or Notes with an aggregate original principal balance of \$20,000.00 or more.

Interest Rate: Interest shall accrue on the unpaid principal amount at a rate equal to 4% per annum, compounded annually, from the actual date funds were received by the Company and shall payable at the Maturity Date (defined hereafter).

Conversion and Repayment

(a) Conversion upon a Qualified Financing. In the event that (i) the Company issues and sells units or shares of the Company’s most senior class or series of units or shares outstanding as of the relevant date (the “Senior Securities”) to investors in a bona-fide arms-length transaction in an aggregate amount of at least \$1,000,000, exclusive of the conversion of this Note (a “Qualified Financing”) and (ii) this Note has not been paid in full, then, the amount invested by a Holder for the purchase of such Holder’s Note (the “Investment Amount”) shall automatically convert into the Senior Securities sold in the Qualified Financing at the Conversion Price (as defined below). The total number of Senior Securities to which a holder of a Note shall be entitled upon conversion of such Note shall be determined by dividing (i) the Investment Amount by (ii) the Conversion Price (the “Total Number of Senior Securities”). For Holders who are not Major Investors, the Conversion Price means the lesser of (x) 80% of the price per unit or share paid for the Senior Securities in the Qualified Financing and (y) the price obtained by dividing \$2,500,000 by the Company’s Fully Diluted Capitalization (as defined below) immediately prior to the Qualified Financing (which in all cases excludes any units or shares issued upon conversion of convertible debt). For Holders who are Major Investors, the Conversion Price means the lesser of (x) 80% of the price per unit or share paid for the Senior Securities in the Qualified Financing or \$500,000, whichever is greater, and (y) the price obtained by dividing \$2,500,000 by the Company’s Fully Diluted Capitalization (as defined below) immediately prior to the Qualified Financing (which in all cases excludes any units or shares issued upon conversion of convertible debt). The Total Number of Senior Securities shall consist of that number of units or shares of Senior Securities obtained by dividing (a) the Investment Amount by (b) the price per unit or share paid by other purchasers in the Qualified Financing (the “Number of Senior Securities”). For purposes of this Note, “Fully Diluted Capitalization” means the sum of (i) all units or shares of the Company’s equity securities (on an as-converted basis) issued and outstanding, assuming exercise or conversion of all options, warrants and other convertible securities,

excluding this Note, and (ii) all units or shares of the Company's equity securities reserved and available for future grant under any equity incentive or similar plan of the Company.

(b) **Corporate Transaction.** If the Company consummates a Corporate Transaction (as defined below) while this Note remains outstanding, the Company shall repay any Holder who is not a Major Investor, in cash in an amount equal to amount equal to two hundred percent (200%) of the principal balance of such Holder's Note then outstanding, plus unpaid accrued interest thereon through the date of such Corporate Transaction. If the Company consummates a Corporate Transaction (as defined below) while this Note remains outstanding, the Company shall repay any Holder who is a Major Investor, in cash in an amount equal to amount equal to two hundred and fifty percent (250%) of the principal balance of such Holder's Note then outstanding, plus unpaid accrued interest thereon through the date of such Corporate Transaction. For purposes of this Note, a "Corporate Transaction" means (i) a sale, lease or other disposition of all or substantially all of the Company's assets or (ii) a consolidation or merger of the Company with or into any other entity or person, or any other corporate reorganization, in which the equity holders of the Company immediately prior to such consolidation, merger or reorganization own less than fifty percent (50%) of the voting power of the surviving entity immediately after such consolidation, merger or reorganization; provided that a Corporate Transaction shall not include any transaction or series of transactions principally for bona fide equity financing purposes in which cash is received by the Company or any successor, indebtedness of the Company is cancelled, or converted or a combination thereof. The Company shall give the Holder notice of a Corporate Transaction not less than ten (10) days prior to the anticipated date of consummation of the Corporate Transaction.

(c) **Procedure for Conversion.** In connection with any conversion of this Note, the Holder shall surrender this Note to the Company and deliver to the Company any documentation reasonably required by the Company (including, in the case of a Qualified Financing, all financing documents executed by other investors in connection with such Qualified Financing). The Company shall not be required to issue or deliver the Senior Securities, into which this Note may convert until the Holder has surrendered this Note to the Company and delivered to the Company any such documentation. Upon the conversion of this Note into Senior Securities pursuant to the terms hereof, in lieu of any fractional units or shares to which the Holder would otherwise be entitled, the Company shall pay the Holder cash equal to such fraction multiplied by the price at which this Note converts. To secure the Holder's obligations to execute and deliver the documentation required by this paragraph, the Holder hereby appoints the Chief Executive Officer of the Company as the Holder's true and lawful attorney, with the power to act alone and with full power of substitution, to execute and deliver all such documentation required by this

paragraph if, and only if, the Holder fails to execute or deliver such documentation as required by this paragraph. The power granted by the Holder pursuant to this paragraph is coupled with an interest and is given to secure the performance of the Holder's duties under this Note, and is irrevocable and will survive the death, incompetency, disability, merger or reorganization of the Holder.

(d) Interest Accrual. If a Corporate Transaction or Qualified Financing is consummated, all interest on this Note shall be deemed to have stopped accruing as of ten (10) days prior to the signing of the definitive agreement for the Corporate Transaction or Qualified Financing.

In 5 years, we want to be developing our fourth and fifth products while the first three are flying off the e-shelves.

Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future, if any.

To date, the company has been financed with \$7,000 in debt. All \$7,000 has been repaid with interest.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 12 months. Except as otherwise described in this Form C, we currently do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Pippy Sips LLC cash in hand is \$33,625.73, as of October 17, 2019. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$15,000/month, for an average burn rate of \$15,000 per month. If need be, we will pause operations until the conclusion of this Offering to limit burn rate. Our intent is to be profitable in 24 months.

In 2019, we partnered with a contract manufacturing partner in Eagleville, PA called Inteprod. Our development expenses have, relatedly, significantly increased. More specially, by the end of October 2019, we anticipate having paid Inteprod a total of approximately \$50,000 for engineering, supply-chain management, and other services.

In the next few months, we will incur substantial one-time tooling expenses. Separate from our equity raise, and in addition to funds in the company bank account, we will if necessary and possible inject capital into the business using personal funds and traditional bank lending. We expect to generate revenue in December when we have first units and can offer them up for sale. We will need to spend approximately \$155,000 to go to market in December. We, the Founders, will self-fund, secure loans, and/or solicit investment from accredited investors to raise any shortfall after this Offering.

4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
