Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

ASK (Acquire Skills and Knowledge Education Inc) Education is a new company founded in Fall 2019. The founders of the company are committed to advancing formal and informal education by building educational tools for the PreK-12 learner that will be adopted for use by school systems, educators, parents/guardians and the learner. The ASK difference is in

the approach and assessment of learning. ASK Education is (Software as a Service) an educational technology company focused on creating and developing new tools to advance education and assessment for the 21st Century Skills and Health literacy in the Pre-K through 12 grades. Our goal is to provide products that invigorate Pre-K through 12 education in the US and globally - we see this as essential to transforming the current system. Educational tools, serious games and a virtual world environment for learning could provide a platform for learners to gain and improve the 21st-century skills of collaboration, creativity, problem-solving, ethics, information tech literacy, and communication. Our vision is to develop and deploy educational tools - serious games and modules relating to public health and wellness, disease and self-care, and health professions topics and expanding into other areas as the corporation grows. Both individual and team tools and games will be developed and distributed initially focused on grades 6 to 12 in the educational systems. In addition to the tools for the learner that include an assessment portal and social learning network, the aim is to provide tools and training for the parent/guardian and the educator. The system should provide immersive learning, communication and leadership opportunities for the learner, parents/guardians, and educators. This is a B2B company. Tools developed we believe might be sold to school systems across the US and Canada. There is also a B2C component of the company that we believe could be sold to the Home School segment of learners in both the US and Canada. The cost of goods is approximately \$35.00 per student per year. There are 5,600,000 learners in the top 30 largest school districts in the United States. The company is in the process of collecting data from parents, teachers, and learners to determine if they believe there is a need for mental health education, community wellness, nutrition, and other health topics. To date among parents and teachers, they have an over 90% desire to see mental health education provided to the K-12 population as well as college. The State of Florida has just mandated mental health education for all learners in grades 6-12 every year. The company owners have backgrounds in health, business/entrepreneurship, technology, game design, and education.

ASK Education currently has 3 employees.

Risk Factors

7. Material factors that make an investment in Acquire Skills and Knowledge Education Inc. speculative or risky:
 1. Any valuation at this stage is difficult to assess. Unlike listed companies that are valued publicly through market-driven stock prices, the valuation of private companies, especially startups, is difficult to assess and you may risk overpaying for your investment. In addition, there may be additional classes of equity with rights that are superior to the class of equity being sold.

2. Intense competition in the markets in which we compete could prevent us from generating or sustaining revenue growth and generating or maintaining profitability. Our business is competitive, and we expect it to become increasingly competitive in the future as more startups enter the industry. We may also face competition from large companies, any of which might have more capital than we have, and launch its own business that competes with us.
3. We are highly dependent on the services of our founder. Our future business and results of operations depend in significant part upon the continued contributions of our CEO and founder. If we lose those services or if he fails to perform in his current position, or if we are not able to attract and retain skilled employees in addition to our CEO and the current team, this could adversely affect the development of our business plan and harm our business. In addition, the loss of any other member of the board of directors or executive officers could harm the Company's business, financial condition, cash flow and results of operations.
4. Our management may not be able to control costs in an effective or timely manner. The Company's management anticipates it can use reasonable efforts to assess, predict and control costs and expenses. However, implementing our business plan may require more employees, capital equipment, supplies or other expenditure items than management has predicted. Likewise, the cost of compensating employees and consultants or other operating costs may be higher than management's estimates, which could lead to sustained losses.
5. Start-up investing is risky. Investing in early-stage companies is very risky, highly speculative, and should not be made by anyone who cannot afford to lose their entire investment. Unlike an investment in a mature business where there is a track record of revenue and income, the success of a startup or early-stage venture often relies on the development of a new product or service that may or may not find a market. 6. If we do not respond to technological changes or upgrade our site and technology systems, our growth prospects and results of operations could be adversely affected. To remain competitive, we must plan to enhance and improve the functionality and features of our technology infrastructure. As a result, we will need to continue to improve and expand our hosting and network infrastructure and related software capabilities. These improvements may require greater levels of spending than we have experienced in the past. Without such improvements, our operations might suffer from unanticipated system disruptions, slow application performance or unreliable service levels, any of which could negatively affect our reputation and ability to attract and retain customers and contributors. Furthermore, in order to continue to attract and retain new customers, we are likely to incur expenses in connection with continuously updating and improving our user interface and experience. We may face significant delays in introducing new services, products, and enhancements. If competitors introduce new products and services using new technologies or if new industry standards and practices emerge, our existing websites and our proprietary technology and systems may become obsolete or less competitive, and our business may be harmed. In addition, the expansion and improvement of our systems and infrastructure may require us to commit substantial financial, operational and technical resources, with no assurance that our business will improve.
7. Public health epidemics or outbreaks could adversely impact our business. In December 2019, a novel strain of coronavirus (COVID-19) emerged in Wuhan, Hubei Province, China. While initially the outbreak was largely concentrated in China and caused significant disruptions to its economy, it has now spread to several other countries and infections have been reported globally. The extent to which the coronavirus impacts our operations will depend on future developments, which are highly uncertain and cannot be predicted with confidence, including the duration of the outbreak, new information which may emerge concerning the severity of the coronavirus and the actions to contain the coronavirus or treat its impact, among others. In particular, the continued spread of the coronavirus globally could adversely impact our operations, and could have an adverse impact on our business and our

financial results.

9. *Neither the Offering nor the Securities have been registered under federal or state securities laws, leading to an absence of certain regulation applicable to the Company.*

The securities being offered have not been registered under the Securities Act of 1933 (the "Securities Act"), in reliance on exemptive provisions of the Securities Act. Similar reliance has been placed on apparently available exemptions from securities registration or qualification requirements under applicable state securities laws. No assurance can be given that any offering currently qualifies or will continue to qualify under one or more of such exemptive provisions due to, among other things, the adequacy of disclosure and the manner of distribution, the existence of similar offerings in the past or in the future, or a change of any securities law or regulation that has retroactive effect. If, and to the extent that, claims or suits for rescission are brought and successfully concluded for failure to register any offering or other offerings or for acts or omissions constituting offenses under the Securities Act, the Securities Exchange Act of 1934, or applicable state securities laws, the Company could be materially adversely affected, jeopardizing the Company's ability to operate successfully. 10. *The Company has the right to extend the Offering Deadline, conduct multiple closings, or end the Offering early.*

The Company may extend the Offering Deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the Minimum Amount even after the Offering Deadline stated herein is reached. While you have the right to cancel your investment up to 48 hours before an Offering Deadline, if you choose to not cancel your investment, your investment will not be accruing interest during this time and will simply be held until such time as the new Offering Deadline is reached without the Company receiving the Minimum Amount, at which time it will be returned to you without interest or deduction, or the Company receives the Minimum Amount, at which time it will be released to the Company to be used as set forth herein. 11. *The Company's management may have broad discretion in how the Company uses the net proceeds of the Offering.*

Despite that the Company has agreed to a specific use of the proceeds from the

Offering, the Company's management will have considerable discretion over the allocation of proceeds from the Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

12. *The Securities issued by the Company will not be freely tradable until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities regulations may apply, and each Investor should consult with his or her attorney.*

You should be aware of the long-term nature of this investment. There is not now and likely will not be a public market for the Securities. Company equity securities will be subject to dilution. Company intends to issue additional equity to future employees and third-party financing sources in amounts that are uncertain at this time, and as a consequence, holders of Securities will be subject to dilution in an unpredictable amount. Such dilution may reduce the purchaser's economic interests in the Company.

15. The amount of additional financing needed by Company will depend upon several contingencies not foreseen at the time of this Offering. Each such round of financing (whether from the Company or other investors) is typically intended to provide the Company with enough capital to reach the next major corporate milestone. If the funds are not sufficient, Company may have to raise additional capital at a price unfavorable to the existing investors. The availability of capital is at least partially a function of capital market conditions that are beyond the control of the Company. There can be no assurance that the Company will be able to predict accurately the future capital requirements necessary for success or that additional funds will be available from any source. The offering price was not established in a competitive market. We have arbitrarily set

the price of the Securities with reference to the general status of the securities market and other relevant factors. The Offering price for the Securities should not be considered an indication of the actual value of the Securities and is not based on our net worth or prior earnings. We cannot assure you that the Securities could be resold by you at the Offering price or at any other price.

17. In addition to the risks listed above, businesses are often subject to risks not foreseen or fully appreciated by the management. It is not possible to foresee all risks that may affect us. Moreover, the Company cannot predict whether the Company will successfully effectuate the Company's current business plan. The Offering

Acquire Skills and Knowledge Education Inc. ("Company") is offering securities under Regulation CF, through Netcapital Funding Portal Inc. ("Portal"). Portal is a FINRA/SEC registered funding portal and will receive cash compensation equal to 4.9% of the value of the securities sold through Regulation CF. Investments made under Regulation CF involve a high degree of risk and those investors who cannot afford to lose their entire investment should not invest.

The Company plans to raise between \$10,000 and \$106,999 through an offering under Regulation CF. Specifically, if we reach the target offering amount of \$10,000, we may conduct the first of multiple or rolling closings of the offering early if we provide notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Oversubscriptions will be allocated on a first come, first served basis. In the event The Company fails to reach the offering target of \$10,000, any investments made under the offering will be cancelled and the investment funds will be returned to the investor.

The funds raised should be divided among operations, marketing and sales, and staff support and salaries. We are a software company hence the footprint and corporate office expenses should be reduced for the time being. This allows for a larger portion of the proceeds to be invested in the human capital. The software and technology platforms used require less investment prior to product sales and should ramp in costs with sales and users. The bulk of the raise we aim to invest in designers and developers in order to get the product to market. Beta testing costs classified as a part of our marketing expenses. We aim to improve user experience through by early testing for quality.

10. How will the issuer complete the transaction and deliver securities to the investors?

In the year ended December 31, 2020, the company successfully closed net proceeds of \$8,522 via Reg CF Common Stock Offering which is still ongoing. The company plans to continue its raise efforts until further notice. During the same period, the company received an additional \$4,978 in related-party loans from an officer of the company. Total expenses for the same period were \$6,561 which resulted in a (\$6,561) loss. We plan to raise \$107,000 in our first offering. We incorporated on June 11, 2019, and have not had any significant operations. We incurred expenses for organization costs and stock-based compensation in 2019 totaling \$10,051. We received a loan from a shareholder to pay \$3,151 in organizational costs. Valuation: The first potential for sales is 2,600,000 students in the state of Florida. Sales from 5% of that population are 130,000 licenses. (There are over 130,000 students in 3 counties of Broward, Miami-Dade, and Palm Beach in Florida). 130,000 licenses at \$35.00 per license are approximately \$4,500,000. Being conservative the first valuation is calculated at less than half of that at \$2,250,000 and increases with increased development and distribution of the product. The estimated annual budget to bring the company to full operating capacity and design the full educational tool, 3 portals and backend is \$1,500,000. In order to get started with the build, the first raise is \$107,000. We believe that funding of \$107,000 will enable us to hire consultants to build the first tool for the learner in the area of community wellness and begin the mental health content. We plan to immediately move to other raises after the \$107,000 to get to the annual budget needed. We plan to keep a very small building footprint so that almost all the money raised will be used for human capital, beta testing, and marketing and sales.
