





The InfiniteVR concept was created by a passionate entrepreneur and veteran angel investor at a dinner in Guangzhou, China.




● Sep, 2016

The idea transformed into a plan and was executed rapidly with three pilot locations in Texas, which were chosen according to their diverse demographics and socio-economic status.




● **Dec, 2016**

First franchise location opened in Dallas, Texas.







As a first-time attendee at one of the most acclaimed trade fairs in Vegas, InfiniteVR received interest beyond expectations.



As a result of such exceedingly success, we opened our first out-of-state franchise in Nashville, TN and Miami, FL.


InfiniteVR became the only VR company in United States to hold accounts with three biggest shopping mall development companies.




Expansion Map

For the remainder of 2018, InfiniteVR continued to grow at a slower pace due to stabilization efforts.




Our first out-of-country free agent location opened in Istanbul, Turkey.

● Nov, 2019




Following successful meetings, we signed LOI and MOU with one of the largest investment groups in China; aiming to elevate infinite VR an entirely global firm.
