We acquire our properties from our network of real estate agents, investors, and property owners. We partner with Epic Development Partners to rehab and maintain properties to our quality standards. We seek out families that are suitable for our properties with a background check and income verification to ensure the families can get into the homes and afford to stay there. We then offer financial counseling to put them in position to be able to afford to purchase the home creating long term wealth.
