Our future success, as an early-stage company, is not guaranteed. The average start-up at this stage faces significant and existential risks and will likely continue to do so for the foreseeable future. There can be no assurances around the return you may or may not make in this investment. The best mind-set is to invest in the company with the expectation that you have a high potential upside but are also likely to lose your investment altogether.

We depend on our senior management team and the loss of one or more key personnel or an inability to attract and retain highly skilled personnel may impair our ability to grow our business, particularly those with experience in the fertility or healthcare industries. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

We have a limited operating history and may be unable to achieve or sustain profitability or accurately predict our future results. We were formed in 2018. As such, we have a very limited operating history of selling our products and professional services to third parties. Our limited operating history makes it difficult to evaluate our current business and future prospects and may increase the risk of your investment. Our future success is affected by the growth of the fertility industry, demand for fertility-related products, and demand for male fertility products. There can be no assurance that the industry will sustain enough demand for our product for us to continue to operate. You should not consider our recent growth in revenue as indicative of our future performance, and we cannot assure you that we will achieve profitability in the future, nor that if we do become profitable, we will sustain profitability.

Our future success is dependent on our ability to continue to build upon the legitimacy of our product. This requires the input and support of an Advisory Board, medical experts, and others. While we have a robust Advisory Board today, there can be no assurance that it will grow or even maintain its size in the future.

If the market for fertility products and services develops more slowly than we expect, or declines, our business could be adversely affected. Our future success is dependent on remaining a market leader, or the market leader in the male fertility industry. There can be no assurance that new competitors will not emerge, that existing competitors will out-compete us, or that changes in the industry (e.g. consolidation) may affect our ability to raise funds or operate a profitable business. Further, any disruption of service at the centers that store our clients' semen, or errors & omissions caused by any clinics we work with, could harm our business and open us up to potential legal challenges.

If we are unable to increase market awareness of our company and our products, our revenue may not continue to grow, or may decline. Market awareness of our company and our applications is essential to our ability to generate new leads for expanding our business and our continued growth. If we fail to sufficiently invest in our marketing programs or they are unsuccessful in creating market awareness of our company and our applications, our revenue may grow more slowly than expected or may decline and our financial performance may be adversely affected.

Security breaches may harm our business. Our applications involve the storage and transmission of our customers' proprietary and confidential information, including personal or identifying information regarding their employees and customers. Any security breaches, unauthorized access, unauthorized usage, virus or similar breach or disruption could result in loss of confidential information, damage to our reputation, early termination of our contracts, litigation, regulatory investigations, indemnity obligations or other liabilities. If our security measures or those of our third-party data centers are breached as a result of third-party action, employee error, malfeasance or otherwise and, as a result, someone obtains unauthorized access to customer data, our reputation will be damaged, our business may suffer and we could incur significant liability. Because the techniques used to obtain unauthorized access or sabotage systems change frequently and generally are not identified until they are launched against a target, we may be unable to anticipate these techniques or to implement adequate preventative measures. Any or all of these issues could negatively affect our ability to attract new customers, cause existing customers to elect not to renew or upgrade their subscriptions, result in reputational damage or subject us to third-party lawsuits, regulatory fines or other action or liability, which could adversely affect our operating results.

Our success depends on our ability to adapt to technological change and continue to innovate. The overall market for fertility products is rapidly evolving and subject to changing technology, shifting customer needs and frequent introductions of new products & services. Our ability to attract new customers and increase revenue from existing customers will depend in large part on our ability to develop or acquire new products & services and enhance and improve existing products & services. To achieve market acceptance for our applications, we must effectively anticipate and offer products & services that meet changing customer demands in a timely manner. Customers may require features and capabilities that our current products & services do not have. We may experience difficulties that could delay or prevent our development, acquisition or implementation of new products & services.

If we are unable to successfully develop or acquire new capabilities and functionality, enhance our existing products & services to anticipate and meet customer preferences, sell our products & services into new markets or adapt to changing industry standards in the fertility industry, our revenue and results of operations would be adversely affected.

Adverse economic conditions may reduce our customers' ability to spend money on fertility products & services, or our customers may otherwise choose to reduce their spending on fertility products & services, which may adversely impact our business.

If we fail to develop and maintain relationships with third parties, our business may be harmed.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If we reach our target offering amount prior to the deadline, we may conduct an initial closing of the offering early if we provide notice about the new offering deadline at least five business days prior to the new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Wefunder will notify investors if we conduct an initial closing. Thereafter, we may conduct additional closings from time to time at our and Wefunder's discretion until the deadline date.

7. **Book Entry.** Investments may be in book entry form. This means that the Investor may not receive a certificate representing his or her investment. 12. How can an investor cancel an investment commitment?

The intermediary will notify investors when the target offering amount has been met. If the issuer reaches the target offering amount prior to the deadline identified in the offering materials, it may close the offering early if it provides notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment).

If an investor does not cancel an investment commitment before the 48-hour period prior to the offering deadline, the funds will be released to the issuer upon closing of the offering and the investor will receive securities in exchange for his or her investment.

If an investor does not reconfirm his or her investment commitment after a material change is made to the offering, the investor's investment commitment will be cancelled and the committed funds will be returned.

**An Investor's right to cancel.** An Investor may cancel his or her investment commitment at any time until 48 hours prior to the offering deadline.

If there is a material change to the terms of the offering or the information provided to the Investor about the offering and/or the Company, the Investor will be provided notice of the change and must re-confirm his or her investment commitment within five business days of receipt of the notice. ## Ownership and Capital Structure

THE OFFERING

13. Describe the terms of the securities being offered.

To view a copy of the SAFE you will purchase, please see [Appendix B, Investor Contracts](#). The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **preferred stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

*Conversion to Preferred Equity.* Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, **Investors will receive a number of shares of Preferred Stock** calculated using the method that results in the greater number of **Preferred Stock**:

(i) the total value of the Investor's investment, divided by the price of **Preferred Stock** issued to new Investors, or  
(ii) if the valuation for the company is more than **\$15 million** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of (a) the Valuation Cap divided by (b) the total amount of the Company's capitalization at that time.

*Additional Terms of the Valuation Cap.*

For purposes of option (ii) above, the Company's capitalization will be measured as all **shares of stock** outstanding at the time, not including any SAFEs or convertible notes, plus any **common stock** reserved and available for future grant under any equity incentive or similar plan of the Company or to be created or increased in connection with our equity offering at that time.

Investors who receive shares subject to the Valuation Cap will receive a per share liquidation preference and conversion price designed to provide protection against the price of the **Preferred Stock** being diluted to a value below the price per share at the time they receive **Preferred Stock**. This dilution would mainly occur due to the issuance of additional stock by the Company.

Investors who receive **Preferred Stock** subject to the Valuation Cap will also receive dividend rights.

*No Voting Rights.*

Investors will have no voting rights. Instead, the Company's CEO will be provided a proxy to vote on the Investor's behalf.

*Major Investor Threshold*

Definition: A major investor is one who invests a minimum of \$1,000,000.00 and are "accredited investors" as defined by Rule 501 of Regulation D (17 C.F.R. §230.501(a)).

Execution. Investors who invest less than \$1,000,000.00 will typically not execute transaction documents in order to receive Units at the time of an applicable equity offering. Instead, a "Designated Lead Investor" will execute the documents for them, provided that the documents are consistent with the Units received by new investors in the Company, modified, if applicable, based on the terms of the SAFE.

*Liquidity Events.*

If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **Preferred Stock**, Investors will receive

- shares of common stock equal to the amount invested by the Investor in the SAFEs divided by the quotient of (a) the Valuation Cap divided by (b) the number of outstanding shares of the Company's **common stock and Preferred Stock**, but excluding any shares of **common stock** reserved and available for future grant under any equity incentive or grant, SAFEs, and/or convertible promissory notes.

*Termination of the Company.*

If the Company ceases operations, liquidates, dissolves, winds up or has its assets assigned to another entity, an investor's obligations under the **Preferred Stock**

assigned to creditors prior to an issuance of securities involving **Preferred Stock**, the Company will pay first the other holders of existing **Preferred Stock**, based on the terms of the Company's certificate of incorporation, and then holders of the SAFEs. These payments will occur before any distributions to holders of common stock.

If there are not sufficient Company assets to pay holders of the SAFEs the amount of their investments, as determined by the Company's board of directors, payments will be made on a pro-rata basis. In this case, Investors may not recoup part or all of their investment from the Company.

*Repurchases.*

If the Company determines, in its sole discretion, that it is likely that within six months the securities of the Company will be held of record by a number of persons that would require the Company to register a class of its equity securities under the Securities Exchange Act of 1934, as amended, as required by Section 12(g) thereof, the Company shall have the option to repurchase this instrument from the investor for the greater of (i) the Purchase Amount and (ii) the fair market value of this instrument, as determined by an independent appraiser of securities chosen by the Company.

Give Legacy Inc was incorporated in the State of Delaware in July 2018.

In the next five years, Legacy will continue to double down on its competitive advantages. This includes but is not limited to expanding its staff which includes highly-recognized doctors, fertility experts, and business experts. This also includes growing its acquisition channels including but not limited to online marketing and partnerships with other fertility companies. This also includes expanding its product offering to continue providing exceptional service to its clients, including but not limited to providing additional, data-driven fertility and lifestyle assessments. Legacy's product offering is particularly important during a time of pandemic and economic hardship, providing an affordable, from-home service at a level of quality similar to and in some cases exceeding in-person fertility clinics.

### Historical Results of Operations

Our company was organized in July 2018 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2018, the Company had revenues of \$4,321.
- *Assets.* As of December 31, 2018, the Company had total assets of \$69,030, including \$64,500 in cash.

### Liquidity & Capital Resources

To-date, the company has been financed with \$3,500,000 in SAFEs.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 12 months.
