Business and Anticipated Business Plan

6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.

Background: Backers is the brainchild of Brian Tinney and was further shaped with the help of Matthew Smart, Nicholas Bonetto, and others. The Backers platform is designed to leverage digital currency and smart contracts to bridge the gap between eSports competitors and their fans. The Platform: The Backers Platform aims to allow eSports teams to create tournament structures with crowdfunded prize pools. The fans are Backing the teams and purchasing equity for that competition. All of the funds should be secured in a smart contract on a public blockchain. Think of it as a tournament with a cloud-based escrow account with specific software-defined payout instructions that mirror the tournament structure. The fans generate the prize pool and are now competing as “owners” for that prize money. With Backers, when the prize money is awarded to the winning teams, it is awarded directly to the Backers based on their equity share. The Market: The eSports markets have several layers to consider for our purposes. The Team: Currently, Brian Tinney is the CEO of Backers. Matthew Smart, the President of Smart Software Inc. has been a contributor to

the project and is the current Vice President of Backers. Matthew brings over 20 years of software development experience as well as his existing team and resources to the Backers development team. The Platform: In late 2018 we began building our initial proof of concept by creating a full-stack application that runs on Amazon Web Services. The application allowed for the creation of a smart-contract for a 9 person poker tournament. Backers were able to contribute to the smart-contract and the payout was made according to the tournament results. The contract was executed on the Ethereum blockchain and the payouts were completed successfully. We are now ready to build out the platform on a size and scale capable of servicing the audience we are targeting. Market Outlook Competition: There are no companies offering direct equity in professional sports teams. There are sites that allow poker players to sell equity in the same way that we are discussing. This concept of “Backers” is common in the poker community and allows professional players to reduce variance. In the past, these relationships were kept private but recently several sites have opened online that allow players to sell equity in themselves for a tournament. For an example of the marketplace and functionality, please visit www.youstake.com. Fantasy Sports sites are similar, in that they are beginning to take digital currency, but they have no integration with smart-contracts, and they do not offer direct equity positions, see www.fanduel.com. The fact that both sites operate openly is great news for Backers as we expect to have to break little legal ground, it does however illustrate the need for us to move quickly and execute with excellence. Industry Partners: Why do we expect companies like Riot and Epic Games to work with Backers and what will it cost them? The answer is simple. We won’t charge them anything. We plan to give them an opportunity to have direct input into the platform, from the ground up. We plan to find a major eSports Creator or Franchise that is looking for a free and revolutionary way to further engage with their existing fan base. eSports companies could then use their existing marketing resources to advertise their competitions to their respective audiences. Backers are a service company and our goal is to partner with eSports companies to build a robust and feature-rich platform. We intend to build the platform and generate APIs so that eSports companies, streamers, and eventually anyone can build out crowdfunded campaigns on Backers. How Do We Plan to Earn Money: All users should pay a 2.5% transaction fee when they fund their favorite teams. That fee aims to cover the network fee to transmit the funds to and from the smart contract. Network fees should average 0.5% leaving a 2% return to Backers Inc. Let’s look at a simple but possible scenario. Vision and Insights. Based on the research from BDO Global, Forbes, Business Insider, and others, we believe that any success in the development of our platform makes us a ripe target for anyone looking to fast track their exposure and saturation in eSports Market. Remember that Google offered to buy Groupon for \$6 billion dollars immediately after its launch. Today Groupon is looking for a buyer and has a valuation of \$2.4 billion dollars. It is extremely unlikely that we will see a valuation as high as Groupon, and you should not anticipate a large capital gain. However, we wanted you to know our vision. With a clear vision, excellent leadership, and careful execution, we believe we may be able to build a platform and launch more fanfare and excitement than any coupon site could ever imagine. While launching as a platform for eSports, Backers aim to be much more. We believe that our technology solutions will have use cases across multiple applications and industries. We expect our IP as well as our market saturation to allow us to attain profitability relatively quickly.

1. We have a limited operating history upon which you can evaluate our performance, and accordingly, our prospects must be considered in light of the risks that any new company encounters. We were incorporated under the laws of Wyoming on January 22, 2020, after operating for less than two years as a pre-revenue limited liability company. Accordingly, we have little history upon which an evaluation of our prospects and future performance can be made. Our proposed operations are subject to all business risks associated with new enterprises. The likelihood of our continuation of a viable business must be considered in light of the problems, expenses, difficulties, complications, and delays frequently encountered in connection with an early-stage a business operating in the competitive industry of mobile applications, and the continued development of advertising, promotions, and a corresponding client base. We anticipate that our operating expenses will increase for the near future. There can be no assurances that we will ever operate profitably. You should consider the Company's business, operations and prospects in light of the risks, expenses and challenges faced as an early-stage company.
2. The regulatory environment surround blockchain, distributed ledger technologies and cryptographic tokens is evolving and uncertain. Regulators in the United States and abroad have begun to bring enforcement actions or recommendations regarding companies purporting to issue digital "coins" or "tokens" if those assets have not been registered or if they do not fall under an exemption to registration. As an offering conducted pursuant to Regulation Crowdfunding offerings (JOBS Act Title III), which are offered to non-accredited and accredited investors alike, the Offering should be viewed as exempt from registration. However, due to the fluid regulatory environment and the desire of regulators and self-regulatory-organizations to protect the public, new legislation, rules, regulations, requirements or guidance ("Requirements") may be released now or in the future. Any new Requirements may have an adverse financial, operational, compliance, legal or other impacts on the Company or its investors, and exist completely out of the control of the Company, its leadership and its employees. In addition, regulation which results in the decline in the adoption or use of cryptocurrencies, such as cryptocurrency bans or the regulation of cryptocurrency exchanges, may result in the decline of cryptocurrency values, thereby making the Tokens decline in value or the operation of the digital ledger technology the Company plans to create unprofitable.
3. There can be no assurance that the Company will meet our projections. There can be no assurance that the Company will be able to find sufficient demand for our product, that people think it's a better option than a competing product, or that we will be able to provide the service at a level that allows the Company to make a profit and still attract business.
4. To date, we have not generated revenue, do not foresee generating any revenue in the near future and therefore rely on external financing. We are a startup company and our business model currently focuses on innovation rather than generating revenue. While we intend to generate revenue in the future, we cannot assure you when or if we will be able to do so.
5. An intentional or unintentional disruption, failure, misappropriation or corruption of our network and information systems could severely affect our business. Such an event might be caused by computer hacking, computer viruses, worms and other destructive or disruptive software, "cyber attacks" and other malicious activity, as well as natural disasters, power outages, terrorist attacks and similar events. Such events could have an adverse impact on us and our customers, including degradation of service, service disruption, excessive call volume to call centers and damage to our data. In addition, our future results could be adversely affected due to the theft, destruction, loss, misappropriation or release of confidential customer data or intellectual property. Operational or business delays may result from the disruption of network or information systems and the subsequent remediation activities. Moreover, these events may create negative publicity resulting in reputation or brand damage with customers.
6. Our business and results of operations may be adversely affected if we are unable to maintain our customer experience or provide high quality customer service. The success of our business largely depends on our ability to provide superior customer experience and high quality

customer service, which in turn depends on a variety of factors, such as our ability to continue to provide a reliable and user-friendly interface for our customers to use our mobile application, reliable and timely responses, and superior after sales services. Our economic prospects may decrease if our mobile application or website services are severely interrupted or otherwise fail to meet our customer requests. Should we or our third-party delivery companies fail to provide customer service in a convenient or reliable manner, or if our customers are not satisfied with our product quality, our reputation and customer loyalty could be negatively affected. As a result, if we are unable to continue to maintain our customer experience and provide high quality customer service, we may not be able to retain existing customers or attract new customers, which could have an adverse effect on our business and results of operations.

7. Maintaining, extending and expanding our reputation and brand image are essential to our business success. In order for the Company to compete and grow, we must extend and expand our brand image through marketing investments, including advertising and consumer promotions, and product innovation. In addition, our success in extending and expanding our brand image depends on our ability to adapt to a rapidly changing media environment. We expect to increasingly rely on social media and online dissemination of advertising campaigns. The growing use of social and digital media increases the speed and extent that information or misinformation and opinions can be shared. Negative posts or comments about us, our brands or our products on social or digital media, whether or not valid, could seriously damage our brands and reputation. If we do not establish, maintain, extend and expand our brand image, then our product sales, financial condition and results of operations could be adversely affected. Moreover, adverse publicity about regulatory or legal action against us could damage our reputation and brand image, undermine our customers' confidence and reduce long-term demand for our products, even if the regulatory or legal action is unfounded or not material to our operations.
8. Major health epidemics, such as the outbreak caused by a coronavirus (COVID-19), and other outbreaks or unforeseen or catastrophic events could disrupt and adversely affect our operations, financial condition and business. The United States and other countries have experienced, and may experience in the future, major health epidemics related to viruses, other pathogens, and other unforeseen or catastrophic events, including natural disasters, extreme weather events, power loss, acts of war, and terrorist attacks. For example, there was an outbreak of COVID-19, a novel virus, which has spread to the United States and other countries and declared a global pandemic. The global spread of COVID-19 has created significant volatility and uncertainty in financial markets. Although COVID-19 is currently not material to our results of operations, there is significant uncertainty relating to the potential impact of COVID-19 on our business. The extent to which COVID-19 impacts our current capital raise and our ability to obtain future financing, as well as our results of operations and financial condition, generally, will depend on future developments which are highly uncertain and cannot be predicted, including new information which may emerge concerning the severity of COVID-19 and the actions taken by governments and private businesses to contain COVID-19 or treat its impact, among others. If the disruptions posed by COVID-19 continue for an extensive period of time, our business, results of operations, and financial condition may be materially adversely affected.

10. *Neither the Offering nor the Securities have been registered under federal or state securities laws, leading to an absence of certain regulation applicable to the Company.*

The securities being offered have not been registered under the Securities Act of 1933 (the "Securities Act"), in reliance on exemptive provisions of the Securities Act. Similar reliance has been placed on apparently available exemptions from securities registration or qualification requirements under applicable state securities laws. No assurance can be given that any offering

currently qualifies or will continue to qualify under one or more of such exemptive provisions due to, among other things, the adequacy of disclosure and the manner of distribution, the existence of similar offerings in the past or in the future, or a change of any securities law or regulation that has retroactive effect. If, and to the extent that, claims or suits for rescission are brought and successfully concluded for failure to register any offering or other offerings or for acts or omissions constituting offenses under the Securities Act, the Securities Exchange Act of 1934, or applicable state securities laws, the Company could be materially adversely affected, jeopardizing the Company's ability to operate successfully. Furthermore, the human and capital resources of the Company could be adversely affected by the need to defend actions under these laws, even if the Company is ultimately successful in its defense.

11. *The Company has the right to extend the Offering Deadline, conduct multiple closings, or end the Offering early.*

The Company may extend the Offering Deadline beyond what is currently stated herein. This means that your investment may continue to be held in escrow while the Company attempts to raise the Minimum Amount even after the Offering Deadline stated herein is reached. While you have the right to cancel your investment up to 48 hours before an Offering Deadline, if you choose to not cancel your investment, your investment will not be accruing interest during this time and will simply be held until such time as the new Offering Deadline is reached without the Company receiving the Minimum Amount, at which time it will be returned to you without interest or deduction, or the Company receives the Minimum Amount, at which time it will be released to the Company to be used as set forth herein. 12. *The Company's management may have broad discretion in how the Company uses the net proceeds of the Offering.*

Despite that the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the allocation of proceeds from the Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

13. *The Securities issued by the Company will not be freely tradable until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities regulations may apply, and each Investor should consult with his or her attorney.*

You should be aware of the long-term nature of this investment. There is not now and likely will not be a public market for the Securities. Because the Securities offered in this Offering have not been registered under the Securities Act or under the securities laws of any state or non-United States jurisdiction, the Securities have transfer restrictions and cannot be resold in the United States except pursuant to Rule 501 of Regulation CF. 15. *The shares of Securities acquired upon the Offering may be significantly diluted as a consequence of subsequent financings.*

Company equity securities will be subject to dilution. Company intends to issue additional equity to future employees and third-party financing sources in amounts that are uncertain at this time, and as a consequence, holders of Securities will be subject to dilution in an unpredictable amount. Such dilution may reduce the purchaser's economic interests in the Company.

16. The amount of additional financing needed by Company will depend upon several contingencies not foreseen at the time of this Offering. Each such round of financing (whether from the Company or other investors) is typically intended to provide the Company with enough capital to reach the next major corporate milestone. We cannot assure you that the Securities could be resold by you at the Offering price or at any other price.

Moreover, the Company cannot predict whether the Company will successfully effectuate the Company's current business plan. The Offering

Backers Inc. ("Company") is offering securities under Regulation CF, through Netcapital Funding Portal Inc. ("Portal"). Portal is a FINRA/SEC registered funding portal and will receive cash compensation equal to 4.9% of the value of the securities sold through Regulation CF. Investments made under Regulation CF involve a high degree of risk and those investors who cannot afford to lose their entire investment should not invest.

The Company plans to raise between \$10,000 and \$1,070,000 through an offering under Regulation CF. Specifically, if we reach the target offering amount of \$10,000, we may conduct the first of multiple or rolling closings of the offering early if we provide notice about the new offering deadline at least five business days prior to such new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Oversubscriptions will be allocated on a first come, first served basis. Changes to the offering, material or otherwise, occurring after a closing, will only impact investments which have yet to be closed.

In the event The Company fails to reach the offering target of \$10,000, any investments made under the offering will be cancelled and the investment funds will be returned to the investor.

8. What is the purpose of this offering?

We need to staff up in order to complete the development of the platform in a timely manner. We are looking to add up to five developers to bring the platform on line. We believe backers is at an advantage when it comes to the use of funds because both Matthew Smart and Brian Tinney already own companies with existing infrastructure. We plan to leverage their existing resources during our first year of operations. Additionally, Smart Software Inc. has systems and software in place as well as existing project management staff that can be dedicated to the project. For Backers, this means we do not have to lay out the cost for new offices, rent, utilities etc. Existing software subscriptions and infrastructure will be leveraged to its full capacity. This will allow the overwhelming majority of funds to go directly to development costs to ensure timely completion of the project.

Backers Inc. is a new company that is still pre-income. After we raise capital, we anticipate our average monthly burn rate will be approximately \$45,000, with an average allocation of 5% towards sales and marketing, 85% to development, 5% to G&A, and 5% to operations/customer success. We currently have metrics around the eSports streamer user base. With this raise, we plan to allocate a higher percentage to development, as well as to customer acquisition and marketing. We believe these activities will result in the traction we will need to secure a contract with an eSports venture or team. We anticipate a successful launch that will initiate revenue generation and profitability. Upon a successful launch, we intend to raise an additional \$40,000,000 in capital from the sale of common stock. We currently have cash balances of approximately \$10,000. We plan to continue to keep a tight rein on expenses in order to keep a secure runway for the duration of the time it will take to raise this round. All development will take place in the offices of Smart Software Inc. This will allow us to utilize existing infrastructure and resources without incurring startup costs or monthly expenses. Our expenses from our date of inception on March 18, 2018, to our year-end on December 31, 2019, amounted to approximately \$24,000, which resulted in a \$24,000 loss. The \$24,000 in expenses primarily included professional fees, advertising, website, travel and software expenses.

We allow people who have already begun to monetize their skill through streaming to now have another way to sell equity in themselves for a competition that they can set up ad hoc. By engaging with the fans this way, we can start adding interesting things to competitions where you can now place bounties on players. When a player gets killed in the game and the money goes flying all over the place, that money could now be going to the fans and the backers that just took him out. So we want the platform to be open to everyone, of every competition, whether it's esports or physical sports. The next step for us is we want to go after the PGA.
