Entertainment and media are consumer-driven businesses that require a large amount of marketing. The company will be dependent on future raises of capital needed to both produce films and market them. If future fundraising is not successful growth will be slower and it could keep the company from achieving profitability.

Film and Television distribution is an established industry with a great deal of infrastructure in place. Much of our infrastructure will need to be built through partnerships with existing entertainment companies. Success will be

dependent on continuing to build those relationships.

Community involvement is critical to the success of our business model. As investors and followers join our community we must keep their interest and enthusiasm. If followers are not excited about our direction this will increase marketing costs and lower overall revenues.

The world wide effects of the Covid 19 Pandemic are still being realized and could drastically change economies and film markets. The uncertainty that this presents could cause unforeseen trends that would make it difficult to compete for attention of viewers and marketshare.

Media distribution is a very competitive industry. We will need to choose projects that separate us from the pack and grab the consumers attention. If our projects do not expand past our niche of the Church it will be difficult to grow the company.

Faith based organizations have been targeted by lawsuits in the past based on their convictions. Though we do not have any intentions of being controversial in this manner there are risks when dealing with issues of faith that someone could bring a lawsuit against a project, contractor, employee, or other associated entity that could bring legal action against us creating additional expenses that would drain revenues and focus on production of projects.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

David D. Dietrich is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.

Michael Klein is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.

Creator Films Inc is offering up to 421,556 shares of stocks, at a price per share of \$1.30.

Investors in the first \$99,999.40 of the offering will receive stocks at a price per share of \$1.15, and a pre-money valuation of \$1,359,825.55

The campaign maximum is \$534,979.40 and the campaign minimum is \$50,000.85.

#### Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

#### Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

#### Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. Preferred Stock has liquidation preferences over Common Stock, but Preferred Stock does not have voting rights. Therefore, Investors will not be receiving voting rights in this Offering.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. We produce faith-infused movies, TV shows, and media.

As an audience owned, faith based movie studio, we hope to be part of the new standard in faith based film production --meeting the demands for faith based entertainment by those in the church; and bridging the gap to those who desire high quality family friendly programming outside the church.

#### **Milestones**

Creator Films Inc was incorporated in the State of Delaware in November 2019.

Since then, we have:

- About Hope (our first feature film) opened in the box office top 20 and is currently available on Amazon Prime.
- Invest in a company, not a single project. Next film is in development along with 2 children shows.
- Distribution partners: Glass House Distribution, Vision Films, Nova Vento Entertainment, and more.
- Our productions are efficient and community supported which keeps our costs down. ( 1/4 the cost compared to average independent film)
- More than a stockholder, you have an insiders seat as part of the process from the pitch, to production and through distribution.
- Our projects are infused with faith. They bring a message of hope, truth, & redemption to the world.
- Faith Market is a growing segment and has great potential for crossover to a wider audience.

#### **Historical Results of Operations**

Our company was organized in November 2019 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2021, the Company had revenues of \$5,724 compared to the year ended December 31, 2020, when the Company had revenues of \$6,245

- *Assets.* As of December 31, 2021, the Company had total assets of \$157,619, including \$25,230 in cash. As of December 31, 2020, the Company had \$141,490 in total assets, including \$5,984 in cash.
- *Net Loss.* The Company has had net losses of \$52,790 and net losses of \$11,606 for the fiscal years ended December 31, 2021 and December 31, 2020, respectively.
- *Liabilities.* The Company's liabilities totaled \$160,571 for the fiscal year ended December 31, 2021 and \$153,573 for the fiscal year ended December 31, 2020.

#### **Related Party Transaction**

#### **Liquidity & Capital Resources**

To date the company has been financed with \$61,835 in equity, and \$5,600 in funding from related parties.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 24 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 9 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### **Runway & Short/Mid Term Expenses**

Creator Films Inc cash in hand is \$15,474.99, as of June 2022. Over the last three months, revenues have averaged \$9,000/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$11,000/month, for an average burn rate of \$2,000 per month. Our intent is to be profitable in 36 months.

We have invested in marketing materials and preparation for the current stock offering, hired additional staff, and paid for merchandise to be sold on our company website.

We run lean and are able to operate for between \$7-13K per month. We have two large contracts in place for current work with a partnered organization.

Revenues have begun coming in from About Hope and we are looking forward to our 1st quarter totals to be reported back to us in May. These revenues are uncertain but initial reporting looks favorable.

We will also be releasing our initial run of merchandise to be sold on the Creator Films website this year. We will lay the foundation for this year and look to generate revenues between 5-10K per quarter next year.

We have just begun distribution of our first feature film and are preparing to launch additional properties. As we build our library of content and distribution pipelines we expect to be profitable in the next 2-4 years. Our current plan targets raising of funds through Equity Crowd Funding to cover operations as well as project financing. Projects can be financed in partnership with distribution agents but our preference is to have them fully financed by Creator Films. This does give us some flexibility in our fundraising. We require funds for operations to continue to move forward, but can get creative with funding of projects. This means that we need to raise a minimal amount each year to cover operational expenses (\$50K in 2021, \$100K in 2022, 2023) but will also be looking for funds to finance projects (\$500K in 2021, \$750K 2022, 2023.)

We have loans that can be taken advantage of with favorable rates and terms. Loans would be used to fill the gap between current operations and close of escrow on the 2nd offering.

Any projections in the above narrative are forward-looking and not guaranteed.
