USE OF FUNDS

Use of Proceeds: 5% will be used toward Wefunder fees. 20% of the raise will be invested into building our sales team. 20% of the raise will be used towards our marketing and brand building. 55% to expand our product and technology offering.

Our mission is to continue to build and invest heavily into product, engineering and new business dev environments in order to further establish our brand as the premier content AI platform for enterprise clients. Sales expansion: Deep research is required to understand and drive strategy for existing and new client initiatives in a highly competitive landscape. By hiring 2-3 full-time sales executives including a sales leader, RAD will be able to further expand and develop key product offerings that leads to both recurring and new business revenue. Marketing and strategy: We intend to invest into key marketing personnel to further focus on product marketing and sales lead generation and client centric programs including email, SEO, demand generation, and key sales channels/partnerships. Key Operations: Adding senior operational support on both the client success and key deliverables including operations and finance resources needed to support growth. Technology and IP: Further invest into 2 machine learning engineers, 2 Artificial Intelligence architects, 2 data scientists and two client/product ops (full stack), 1 UI/UX developer.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

In the future, we will perform valuations of our common stock that take into account factors such as the following:

1. unrelated third party valuations of our common stock;
2. the price at which we sell other securities, such as convertible debt or preferred Stock, in light of the rights, preferences and privileges of our those securities relative to those of our common stock;
3. our results of operations, financial position and capital resources;
4. current business conditions and projections;
5. the lack of marketability of our common stock;
6. the hiring of key personnel and the experience of our management;
7. the introduction of new products;
8. the risk inherent in the development and expansion of our products;
9. our stage of development and material risks related to our business;
10. the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;
11. industry trends and competitive environment;
12. trends in consumer spending, including consumer confidence;
13. overall economic indicators, including gross domestic product, employment, inflation and interest rates; and
14. the general economic outlook.

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

22. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

An Investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the Investor. The Company will be managed by its officers and be governed in accordance with the strategic direction and decision-making of its Board Of Directors, and the Investor will have no independent right to name or remove an officer or member of the Board Of Directors of the Company.

Following the Investor's investment in the Company, the Company may sell interests to additional investors, which will dilute the percentage interest of the Investor in the Company. The Investor may have the opportunity to increase its investment in the Company in such a transaction, but such opportunity cannot be assured.

Historical Results of Operations

Our company was organized in October 2018 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$169,666 compared to the year ended December 31, 2019, when the Company had revenues of \$671,474.
- *Assets.* As of December 31, 2020, the Company had total assets of \$706,498, including \$345,596 in cash. As of December 31, 2019, the Company had \$270,982 in total assets, including \$4,092 in cash.
- *Net Loss.* The Company has had net losses of \$1,034,099 and net losses of \$712,929 for the fiscal years ended December 31, 2020 and December 31, 2019, respectively.
- *Liabilities.* The Company's liabilities totaled \$2,726,642 for the fiscal year ended December 31, 2020 and \$1,264,527 for the fiscal year ended December 31, 2019.

Liquidity & Capital Resources

To date, the company has been financed with \$310,000 in debt from private investors (all of which has converted into common stock), \$670,000 in SBA loans (\$630,000 currently outstanding), \$1,372,000 in equity, \$760,000 in convertibles (all of which has converted into common stock), and \$1,075,617 in SAFEs (all of which has converted into common stock).

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital. If we were to raise \$2M in this Offering, we project a 24-month runway; if we raise \$5M, we project 36 months of runway.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 18 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Rad Technologies Inc. cash in hand is \$700,000, as of October 2021. Over the last three months, revenues have averaged \$105,000/month, cost of goods sold has averaged \$45,000/month, and operational expenses have averaged \$170,000/month, for an average burn rate of \$110,000 per month. Our intent is to be profitable in 24 months.

Since the date of our financials, we merged with Atomic Reach in August of 2021. For the merger financing, we raised \$1.1m from accredited investors from both the Atomic Reach and RAD side. This is annotated in the notes of the attached audited financial statements.

We aim for Revenues in October to be \$120,000, \$96,000 in November, and \$108,000 in December. We expect our burn rate to remain constant between \$60,000 - \$70,000/mo during this period.

We are not profitable now. We estimate that \$3m in funding will get us to profitability. We plan on reinvesting all profits into growth, team building key hires. In six months, we hope to generate \$1.5M in revenue and incur \$1.8M in expenses.

These projections cannot be guaranteed.

We are generating revenue from a wide variety of clients and selling more client deals as we mature. In addition, we have \$700,000 cash on hand.
