8. Discuss the material factors that make an investment in the issuer speculative or risky:

While our company builds cloud-based software, its business model is to sell software to individuals and firms that own cryptocurrency or are service providers to such firms. Therefore demand for our software can be impacted by regulations governing cryptocurrencies.

The regulatory environment for cryptocurrency in the United States is still dynamic and evolving. The issuance of future regulations could impact businesses' demand for cryptocurrency in ways that we cannot currently anticipate.

Likewise, prolonged regulatory uncertainty could diminish demand for cryptocurrency and therefore impact demand for our software.

The US economy currently faces a number of economic risks, including but not limited to geopolitical conflict, high inflation, rising interest rates, stock market volatility, and ongoing uncertainty from the Covid-19 pandemic. This could

negatively impact the ability of our prospective clients to purchase our software or invest in new types of technologies.

We assume that use of cryptocurrency as an asset class and payment mechanism will continue to grow in future years. If this assumption proves incorrect, it will hamper our ability to sell our software.

Our firm's software product is early stage and has not yet achieved what is known in the industry as product-market fit. We are currently testing it with users in order to gain insights into the market, which we hope will guide us toward future changes to our product and implementation of our business model. If we are unable to achieve product-market fit for any reason, it will limit our ability to scale the business and hamper the company's future prospects.

We assume that we will be able to continue to enhance and improve our software in ways that are desirable to existing and prospective customers. If we are unable to do this for any reason, it will limit our ability to grow revenue and put the business at risk.

There are significant costs associated with the creation of a cloud-based software company, and most businesses in this industry do not generate a profit for many years, if ever. We will likely need to raise additional amounts of capital from outside investors after this current raise. If we are unable to do so for any reason, it will hamper the company's future prospects.

Other firms could enter our field and release competing products. If these firms are larger, more highly capitalized, or better at executing, they may pose a serious risk to the company's future prospects.

In order to respond to market changes, the Company's management may from time to time make changes to the business of the Company. There are certain risks associated with such changes. As a strategic response to changes in the competitive environment, the Company may from time to time make certain pricing, service or marketing decisions or business combinations that could have a material adverse effect on the Company's business, results of operations and financial condition.

The Company's future success depends on the continued services and performances of key management, consultants and advisors, and it currently does not carry key person life insurance. However, the Company may secure key person life insurance when such coverage is deemed financially prudent. Also, the Company's future success may further depend on its ability to attract and retain additional key personnel and third party contractual relationships. If the Company is unable to attract and retain key personnel and third party contractors, this could adversely affect the Company's business, financial condition, and operating results.

The Company relies on various intellectual property rights in order to operate its business. The Company's intellectual property rights, including trademarks, may not be sufficiently broad or otherwise may not provide a significant competitive advantage. The steps the Company has taken to maintain and protect its intellectual property may not prevent such rights from being challenged, invalidated, circumvented or designed-around. Should the Company fail to obtain or maintain intellectual property rights that convey competitive advantage, adequately protect intellectual property or detect or prevent circumvention or unauthorized use of such property, it could adversely impact Company's competitive position and results of operations.

The Company relies on nondisclosure and noncompetition agreements with vendors, consultants and other parties to protect trade secrets and other proprietary rights. There is no assurance that these agreements will adequately protect the trade secrets and other proprietary rights if breached, or that the Company will have adequate remedies for any breach. That others will not independently develop substantially

As the Company expands its business, protecting our intellectual property will become increasingly important. The protective steps taken may be inadequate to deter competitors from using the Company's proprietary information. In order to protect or enforce its intellectual property rights, the Company may be required to initiate litigation against third parties, such as infringement lawsuits. Also, third parties may assert claims against us with or without provocation, and an adverse finding could negatively impact the Company. These lawsuits could be expensive, take significant time and could divert management's attention from other business concerns. The law relating to the scope and validity of claims in the technology field in which the Company operates is still evolving and, consequently, intellectual property positions in this industry are generally uncertain. The Company cannot assure that it will prevail in any potential suits or that damages or other remedies would be commercially valuable.

Security breaches and other disruptions could compromise the Company's information and expose it to liability, which would cause its business and reputation to suffer. The Company collects and stores sensitive data, including intellectual property, proprietary business information of the Company's customers, vendors and business partners, and personally identifiable information of its customers and employees. The secure processing, maintenance and transmission of this information is critical to the Company's operations and business strategy. Like others in this industry, the Company could face persistent attacks on its information infrastructure where proprietary information and sensitive/confidential data relating to our operations is stored. Additionally, software and applications that the Company procures from third-parties may contain defects in design or manufacture, including "bugs" and other problems that could unexpectedly interfere with the operation of the information infrastructure. Despite security measures, the information technology and infrastructure may be vulnerable to attacks by hackers or breached due to employee error, malfeasance or other disruptions. Any such breach could compromise the Company's networks and the information stored there could be accessed, publicly disclosed, lost or stolen, potentially resulting in legal claims or proceedings. Such loss of information could disrupt the Company's operations and the products and services it provides to customers, damage its reputation, and cause a loss of confidence in its products and services, which could adversely

affect the Company's revenues and competitive position.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

THE OFFERING

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **Preferred Units** in the Company ("**Preferred Units**"), when and if the Company sponsors an equity offering that involves **Preferred Units**, on the standard terms offered to other Investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Units**,

Investors will receive a number of Preferred Units calculated using the method that results in the greater number of Preferred Units:

- i. the total value of the Investor's investment, divided by
 - a. the price of Preferred Units issued to new Investors multiplied by
 - b. the **discount rate (90%)**, or
- ii. if the valuation for the company is more than **\$16,000,000.00 (the "Valuation Cap")**, the amount invested by the Investor divided by the quotient of
 - a. the Valuation Cap divided by
 - b. the total amount of the Company's capitalization at that time.
- iii. for investors up to the **first \$500,000.00** of the securities, investors will receive a **valuation cap of \$12,500,000.00** and a discount rate of 90.0%.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Units basis):

- Includes all shares of Capital Units issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Investors who receive Units subject to the Valuation Cap will also receive dividend rights.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving Preferred Units, Investors will receive proceeds equal to the greater of

- i. the Purchase Amount (the "Cash-Out Amount") or
- ii. the amount payable on the number of shares of Common Units equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Units. The Investor's right to

receive its Cash-Out Amount is:

- i. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Units);
- ii. On par with payments for other Safes and/or Preferred Units, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Units, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Unit in proportion to the full payments that would otherwise be due; and
- iii. Senior to payments for Common Units.

Irrevocable Proxy. The Investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, will appoint XX Team LLC ("XX Team") as the Investor's true and lawful proxy and attorney (the "Proxy"), with the power to act alone and with full power of substitution, on behalf of the Investor to:

- i. direct the voting of all securities purchased through wefunder.com, and to direct the exercise of all voting and other rights of Investor with respect to the Company's securities, and
- ii. direct, in connection with such voting power, the execution of any instrument or document that XX Team determines is necessary and appropriate in the exercise of its authority. Such Proxy will be irrevocable. If an investor has entered into the Custodial and Voting Agreement with XX Investments LLC ("XX Investments"), then XX Investments will be the entity that XX Team directs to vote and take any other actions in connection with such voting (including the execution of documents) on behalf of such investor.

Repurchase. If the Company determines, in its sole discretion, that it is likely that within six months the securities of the Company will be held of record by a number of persons that would require the Company to register a class of its equity securities under the Securities Exchange Act of 1934, as amended ("Exchange Act"), as required by Section 12(g) or 15(d) thereof, the Company shall have the option to repurchase the securities from each Investor for the greater of

- i. the purchase price of the securities, and
- ii. the fair market value of the securities, as determined by an independent appraiser of securities chosen by the Company. The foregoing repurchase option will terminate upon a Change of Control or Dissolution Event (each as defined in the Company's Investment Agreement).

Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal, Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor:

- A. Wefunder Portal may amend the terms of an investment contract, provided that the amended terms are more favorable to the investor than the original terms; and

To-date, the company has been financed with \$5,000 in debt and \$2,128,103 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds." We

We plan to use the proceeds of our term in and from the offering of funds. We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

TransitNet LLC cash in hand is \$715,251.70, as of May 2022. Over the last three months, revenues have averaged \$1,000/month, cost of goods sold has averaged \$200/month, and operational expenses have averaged \$103,750/month, for an average burn rate of \$102,950 per month. Our intent is to be profitable in 24 months.

Regarding material changes since the date of our financials, total Operating Expenses in the most recent quarter were down 2% from Q4 2021. We anticipate Total Operating Expenses increasing 5% quarter-over-quarter beginning in Q2 2022 as the Company continues and ultimately completes development of our core product.

We do not expect to begin generating significantly more revenue over the next six months, as our core product will still be in development over that time. Total Operating Expenses are expected to total between \$103,750 and \$115,000 per month during Q3 and Q4 2022. TransitNet LLC is not expected to need any additional capital to pay those expenses but is exploring an additional capital raise to pay the Total Operating Expenses of \$115,000 that we will continue to incur over the first six months of GTM. Meaningful revenue is anticipated by 3Q 2023, with steady growth from zero Paid Users in the first half of 2023 to an estimated 5,000 Paid Users by the end of Q4 2023.

Six months after first achieving meaningful revenue, we expect Total Monthly Revenue to increase from \$60,000 per month from 5,000 Paid Users as of 12/31/23 to an estimated \$150,000 per month from 7,500 Paid Users as of 06/30/2024. That increase will be a result of both customer acquisition and an increase in the Paid Users' average monthly fee from \$15.00 in 2023 to \$20.00 in 2024. Six months after first achieving meaningful revenue, we expect OPEX to increase from \$115,000 per month as of 12/31/22 to an estimated \$120,000 per month as of 06/30/2023. While we believe that we likely have sufficient capital on hand to generate revenue if needed, we are actively exploring raising additional capital in 2022.

The Company is not currently profitable. Future profitability will depend on our ability to achieve product-market fit. As would be typical for most cloud software companies, we will likely need to raise a significant amount of venture funding to achieve this and scale the business to profitability. The bare minimum would we need to raise to total to potentially reach profitability is approximately \$1,380,000.

In addition to the completed FY 2021 fundraising, we anticipate being able to raise additional capital through Wefunder based on the experience of our founding team.

The services of XX are available to companies that offer securities through Wefunder Portal LLC and to investors who invest in such companies through Wefunder Portal, but XX is not affiliated with Wefunder Portal or its affiliates.

XX Investments is the Company's transfer agent and also acts as custodian, paying agent, and proxy agent on behalf of all investors that enter into the Custodial and Voting Agreement with XX Investments through the Wefunder Portal website ("Investors"). XX Investments holds legal title to the securities the Company issues through Wefunder Portal (which are uncertificated) on behalf of Investors. Investors, in turn, hold the beneficial interests in the Company's securities. XX Investments keeps track of each Investor's beneficial ownership interest and makes any distributions to the Investors (or other parties, as directed by the Investors).

In addition to the above services, at the direction of XX Team, XX Investments votes the securities and take any other actions in connection with such voting on behalf of the Investors. XX Investments acts at the direction of XX Team, because XX Team holds a power of attorney from each Investor that has entered into the Investor Agreement to make voting decisions on behalf of that Investor. XX Investments will not charge Investors for its services. XX Investments does charge the Company \$1,000/year for services; however, those fees may be paid by Wefunder Inc. on behalf of the Company.

As noted, XX Team holds a power of attorney from each Investor that has entered into the Investor Agreement to make voting decisions on behalf of that Investor. Pursuant to the power of attorney, XX Team will make voting decisions and then direct XX Investments to vote and take any other actions in connection with the voting on Investors' behalf. XX Team will act, with respect to the Company, through our Lead Investor, who is a representative of XX Team.

The Lead Investor is an experienced investor that we choose to act in the role of Lead Investor, both on behalf of the Company and on behalf of Investors. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a special purpose vehicle ("SPV") for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such a circumstance, the Lead Investor may act as a portfolio manager for that SPV (and as a supervised person of Wefunder Advisors) and may be compensated through that role.
