COVID-19 related risks: The travel industry is in the middle of dealing with a pandemic, and there are risks of a delay in the recovery of travel overall.

Both Rob O'Connor and Patrick O'Hara are involved in additional business ventures, potentially limiting their time available to allocate to Roomongo.

Our success is not completely dependent on a potential partnership with Airbnb, but it's a big part of our strategy. The company will work to mitigate this risk by iterating if needed.

The travel industry is not only incestuous but also a copycat industry. So, there's a high likelihood that our competitors will incorporate our products and that could potentially minimize our effectiveness.

Reliance on third-party software: Roomongo uses a number of third party software providers to conduct its business, including hotel aggregators, credit card processors, and others. If those businesses experience a significant interruption, it could negatively impact our ability to operate.

Travel industry disruption: Terrorism, pandemics, and natural disasters are among the potential risks that could negatively affect the travel industry as a whole. Many or all of them could negatively affect our profitability.

Legal: If a customer of ours is injured at a property booked through Roomongo, there is a potential liability. We've taken all of the precautions we can through business insurance (after this raise), terms and conditions, and other preventive measures, but the legal system is unpredictable.

Data privacy: Data privacy is an important task for any online business, but if there were a breach of private data, it could negatively affect our public perception or, depending on the jurisdiction, create a liability. That's why we strive to follow industry best practices, including access only as needed to our servers and encrypting sensitive data, or in the case of credit cards, relying on third-party vendors to secure it for us.

Procuring future talent: The availability of software developers is an ongoing concern. As we grow, we will need more staff, and the small number of developers available are in very high demand. If we're unable to hire the right talent, it could negatively affect our ability to grow.

The financial projections in the Roomongo profile are estimates only, and not a guarantee of future performance. Your investment decision should not be based on the projections contained in this profile or any attachments.

This offering is being conducted on an expedited basis due to circumstances relating to COVID-19 and pursuant to Reg. The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

Investors in the first \$100,000.00 of the offering will receive stocks at a price per share of \$0.40, and a pre-money valuation of \$4,000,000.00

The campaign maximum is \$250,000 and the campaign minimum is \$50,000.00.

Financial Information: Purchasers who have invested at least \$50,000 ("Major Investors") will receive standard information and inspection rights.

Participation Right: Major Investors will have the right to participate on a pro rata basis in subsequent issuances of equity securities.

Liquidation Preference: One times the Original Issue Price plus declared but unpaid dividends on each share of Series Seed Preferred Stock, balance of proceeds paid to holders of common stock of the Company ("Common Stock"). A merger, reorganization or similar transaction will be treated as a liquidation. For the avoidance of doubt, the Original Issue Price shall be \$0.50 regardless of whether the Purchasers received the Early Bird Discount or not.

Voting Rights: Votes together with the Common Stock on all matters on an as-converted basis. In addition, the Company may not change the rights, powers or privileges of the Series Seed Preferred Stock or create a new class or series of capital stock that is senior to the Series Seed Preferred Stock without the consent of the holders of a majority of the outstanding Series Seed Preferred Stock voting as a separate class, unless the Company offers holders of the Series Seed Preferred Stock the right to convert or exchange their Series Seed Preferred Stock into cap.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the

In 5 years we plan to be a major player in the travel space. The future may also include partnering with and/or selling to one of our competitors. But right now, our primary focus is the near-term execution of our business plan and establishing our differentiators and brand identity in the market. These projections are not guaranteed.

Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future, if any.

Milestones

Roomongo, Inc. was incorporated in the State of Colorado in July 2017.

Since then, we have:

- Early-stage entry - first time offering to outside investors.
- Zero long-term debt
- Aggressive plans to incorporate multiple suppliers, to increase deal availability and trip planning options.
- Plans to be tracking close to 5,000 reservations/month by the end of 2021 (not guaranteed).
- Built with a focus on customer care, with 2020's touchpoints.
- Internally built and fully customized CRM, allowing for a best in class customer experience.
- An online and social marketing strategy built on collaboration.

Historical Results of Operations

Our company was organized in July 2017 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2019, the Company had revenues of \$738.65 compared to the year ended December 31, 2018, when the Company had revenues of \$3,687.89.
- *Assets.* As of December 31, 2019, the Company had total assets of \$8,467.18, including \$0.63 in cash. As of December 31, 2018, the Company had \$0 in total assets, including \$0 in cash.
- *Net Loss.* The Company has had net losses of \$61,637.79 and net losses of \$38,265.65 for the fiscal years ended December 31, 2019 and December 31, 2018, respectively.
- *Liabilities.* The Company's liabilities totaled \$0 for the fiscal year ended December 31, 2019 and \$0 for the fiscal year ended December 31, 2018.

Liquidity & Capital Resources

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 5 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 3 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Roomongo, Inc. cash in hand is \$2,215.06, as of December 2020. Over the last three months, revenues have averaged \$306.09/month, cost of goods sold has averaged \$287.72/month, and operational expenses have averaged \$2,229.54/month, for an average burn rate of \$2,211.17 per month. Our intent is to be profitable in 12 months.

There were no material changes in our financials, since December 31, 2019, which is the most recent GAAP financials that we've attached. We did do a stock split since the date of our financials--item 17 of this Form C reflects our most recent capitalization structure.

In 2020, we've focused primarily on product development, so our revenues have not changed dramatically since the date of our financials.

We hope our trending monthly revenue and expenses to be trending at the following rate, by the end of the 3rd Quarter 2021 -- Gross Revenue: \$1,000,000, Net Revenue: \$120,000, Operational Expenses: \$150,000 (or more).

We believe raising \$250k in this Offering will put us on track to reach our milestones and eventually reach a break-even point, but we estimate we need around \$3-5M in total funding over the coming years to reach that point. These projections cannot be guaranteed.

The two founders, Rob O'Connor and Patrick O'Hara can cover short-term burn, but the goal is to bring in outside capital via this crowdfunding experience.
