Global crises such as COVID-19 can have a significant effect on our business operations and revenue projections.

Despite the impossibility of operating in the offices, the Company's revenue has not been adversely affected, due to a home-office plan implemented in March 2020.

Risks Related to the Company's Business and Industry

The operating companies have been in business for more than 10 years, but we have a limited joint history upon which you can evaluate our performance, and accordingly, our prospects must be considered in light of the risks that any young company encounters.

The amount of capital the Company is attempting to raise in this Offering may not be enough to sustain the Company's current business plan.

In order to achieve the Company's near and long-term goals, the Company may need to procure funds in addition to the amount raised in the Offering. There is no guarantee the Company will be able to raise such funds on acceptable terms or at all. If we are not able to raise sufficient capital in the future, we may not be able to execute our business plan.

Our business could be negatively impacted by cyber security threats, attacks and other disruptions.

We continue to face advanced and persistent attacks on our information infrastructure where we manage and store various proprietary information and sensitive/confidential data relating to our operations. These attacks may include sophisticated malware (viruses, worms, and other malicious software programs) and phishing emails that attack our products or otherwise exploit any security vulnerabilities. These intrusions sometimes may be zero-day malware that are difficult to identify because they are not included in the signature set of commercially available antivirus scanning programs. Experienced computer programmers and hackers may be able to penetrate our network security and misappropriate or compromise our confidential information or that of our

customers or other third-parties, create system disruptions, or cause shutdowns. Additionally, sophisticated software and applications that we produce or procure from third-parties may contain defects in design or manufacture, including "bugs" and other problems that could unexpectedly interfere with the operation of the information infrastructure. A disruption, infiltration or failure of our information infrastructure systems or any of our data centers as a result of software or hardware malfunctions, computer viruses, cyber-attacks, employee theft or misuse, power disruptions, natural disasters or accidents could cause breaches of data security, loss of critical data and performance delays, which in turn could adversely affect our business.

Security breaches of confidential customer information, in connection with our electronic processing of credit and debit card transactions, or confidential employee information may adversely affect our business.

Our business requires the collection, transmission and retention of personally identifiable information, in various information technology systems that we maintain and in those maintained by third parties with whom we contract to provide services. The integrity and protection of that data is critical to us. The information, security and privacy requirements imposed by governmental regulation are increasingly demanding. Our systems may not be able to satisfy these changing requirements and customer and employee expectations, or may require significant additional investments or time in order to do so. A breach in the security of our information technology systems or those of our service providers could lead to an interruption in the operation of our systems, resulting in operational inefficiencies and a loss of profits. Additionally, a significant theft, loss or misappropriation of, or access to, customers' or other proprietary data or other breach of our information technology systems could result in fines, legal claims or proceeding

The Securities will not be freely tradable under the Securities Act until one year from the initial purchase date. Although the Securities may be tradable under federal securities law, state securities regulations may apply, and each Investor should consult with their attorney.

The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

The campaign maximum is \$2,420,005.00 and the campaign minimum is \$99,995.00.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

100% of the Common stock outstanding is held by another entity, Pursuit SCA SICAV RAIF.

That entity is controlled by two shareholders, Mauricio Rioseco and Diego Zavala. As such, these two owners are listed as the principal security holders for the Issuer in Q6 of the Form C.

Common stock has 1 vote per share, while Preferred stock does not have voting rights.

Preferred stock has a 1x liquidation preference upon a liquidity event. The Preferred stock and Common stock participate pro rata in distribution of remaining assets.

Series B preferred stock and Series C preferred stock have both been authorized, but zero shares of Series B / Series C are currently issued.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. In addition, as discussed above, if a majority-in-interest of holders of securities with voting rights cause the Company to issue additional equity, an Investor's interest will typically also be diluted.

Based on the risk that an Investor's rights could be limited, diluted or otherwise qualified, the Investor could lose all or part of his or her investment in the securities in this offering, and may never see positive returns.

Cybolt is a Next-Generation Cybersecurity Services provider specialized in delivering multi-technology solutions for managing digital risks and transforming ways of working—ultimately becoming our customers' long-term IT security partner.

Over the next 5 years, we plan on reaching a valuation of \$1B USD. Our global TAM is USD \$163B+ in 2020 and is projected to reach USD \$418B by 2028 with North America poised to capture a large share in the global market for cybersecurity. We are positioning ourselves as market leaders, specializing in cybersecurity in North America and other parts of the world. These are forward looking projections and are not guaranteed.

Company background

A14SEC, Inc incorporated in the State of Delaware in May 2019.

The Company is wholly owned by PURSUIT SCA SICA RAIF. In turn, Search Services SAPI currently owns around 59% of RAIF.

In January 2020, through an Ordinary General Shareholders' Meeting, the sale of the shares of Cyber Team SAPI de CV, a Mexican holding company, was approved to A14SEC, Inc, making A14SEC Inc the new owner of Cyber Team SAPI de CV along with its subsidiaries.

Cyber Team SAPI de CV wholly owns the following entities: Cyber Shared Services, Informacion Segura, Novtech, and Cybolt Managed Services.

To-date, the company has been financed with \$8,154,063 in equity and \$4,956,233 in debt.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. The Company intends to raise additional capital in the future from investors. Runway & Short/Mid Term Expenses

A14SEC, Inc cash in hand is \$364,542, as of September 2021. Over the last three months, revenues have averaged \$2,247,000/month, cost of goods sold has averaged \$1,312,000/month, and operational expenses have averaged \$480,900/month, for an average net margin of \$454,100 per month. We are currently profitable.

Since the date our financials cover, the company continues to grow and remain cash flow positive. Revenues for the first 8 months of the year (2021) amount USD \$17 million and EBITDA of USD \$2.2 million. In 2021, the Company also underwent a stock split and thus authorized 16.6M shares of common stock.

Our next goal is to consolidate the organization's growth in Latin America with strategic acquisitions, and to penetrate the North American market, leveraging on our corporate structure designed to integrate other players in a friendly win-win model that has proven highly attractive for the most talented professionals. With the integration of the right partners in the US and Canada, we believe we will be able to scale the business with great profitability.

We expect to close 2021 with \$50M in revenues and \$7M in EBITDA. The Company makes most of its revenue in the last quarter of the year due to seasonality. Additionally, these projections also include acquisitions we intend to close before year end. These are forward looking projections are not guaranteed.

Free cash flow from operations can be leveraged as additional sources of capital. Given our expected levels of EBITDA, we believe we could also borrow an additional \$25-\$30M if needed (though not guaranteed).

3. the issuer has filed at least three annual reports and has total assets that do not exceed \$10 million;
4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
