Custom meat processing laws and regulations. Currently our model is well within the parameters of custom meat processing for individual consumption nationwide. If those regulations were to shift it could require a significant pivot in our model and possibly be detrimental to the company as a whole.

In the current landscape dealing with a global pandemic we cannot foresee how that may change the business landscape for our model. Currently it has created an increase in demand for processing and local farm goods but that could change for an unforeseeable reason.

The Grazr model is highly dependent upon small meat processors utilizing the software package that Grazr offers them in order to both incorporate Grazr customers and streamline their business processes.

Grazr's success is also dependent on our ability to raise the appropriate capital to successfully launch the platform.

There are a number of competitors in this space but currently all are shipping meat. If a competitor were to shift towards the Grazr model based around a localized market system there could be a threat to the success and 'first to market,' opportunity for Grazr.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$50,001**

Use of Proceeds: 25% towards sales and marketing, 43.5% towards platform development (platform launch, new feature implementation and maintenance), 6.5% towards WeFunder fees. 25% toward 12 months of overhead costs.

If we raise: **\$250,000**

Use of Proceeds: 26.0% towards sales and marketing, 60% towards platform development (platform launch, new feature implementation and maintenance), 6.5% towards WeFunder fees. 7.5% toward 18 months of overhead costs.

Irrevocable Proxy. The Investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney created by Investor in

(collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, will appoint XX Team LLC ("XX Team") as the Investor's true and lawful proxy and attorney (the "Proxy"), with the power to act alone and with full power of substitution, on behalf of the Investor to:

- direct the voting of all securities purchased through wefunder.com, and to direct the exercise of all voting and other rights of Investor with respect to the Company's securities, and
- direct, in connection with such voting power, the execution of any instrument or document that XX Team determines is necessary and appropriate in the exercise of its authority. Such Proxy will be irrevocable. - (1) annual unaudited financial statements for each fiscal year of the Company, including an unaudited balance sheet as of the end of such fiscal year, an unaudited statement of operations and an unaudited statement of cash flows of the Company for such year, all prepared in accordance with generally accepted accounting principles and practices; and
- (2) quarterly unaudited financial statements for each fiscal quarter of the Company (except the last quarter of the Company's fiscal year), including an unaudited balance sheet as of the end of such fiscal year, an unaudited statement of operations and an unaudited statement of cash flows of the Company for such quarter, all prepared in accordance with generally accepted accounting principles and practices, subject to changes resulting from normal year-end audit adjustments. If the Company has audited records of any of the foregoing, it shall provide those in lieu of the unaudited versions. The filing of an annual report on Form C/AR shall be deemed to satisfy the requirement to provide annual financial information described above.

(c) Inspection Rights. The Company shall permit each Major Investor to visit and inspect the Company's properties, to examine its books of account and records and to discuss the Company's affairs, finances and accounts with its officers, all at such reasonable times as may be requested by such Major Investor.

(d) Participation Right.

(i) General. Each Major Investor has the right of first refusal to purchase such Major Investor's Pro Rata Share (as defined below) of all (or any part) of any New Securities (as defined in Section 11(d)

A Major Investor's "Pro Rata Share" for purposes of this right of first refusal is the ratio of

- (b) a number of shares of Common Stock of the Company equal to the sum of (1) the total number of shares of Common Stock of the Company then outstanding plus (2) the total number of shares of Common Stock of the Company into which all then outstanding shares of Preferred Stock of the Company are then convertible plus (3) the number of shares of Common Stock of the Company reserved for issuance under any stock purchase and stock option plans of the Company and outstanding warrants.

(ii) New Securities. "New Securities" shall mean any Common Stock or Preferred Stock of the Company, whether now authorized or not, and rights, options or warrants to purchase such Common Stock or Preferred Stock, and securities of any type whatsoever that are, or may become, convertible or exchangeable into such Common Stock or Preferred Stock; provided, however, that the term "New Securities" does not include: (a) shares of Common Stock issued or issuable upon conversion of the outstanding shares of all the series of the Preferred Stock; (b) shares of Common Stock or Preferred Stock issuable upon exercise of any options, warrants or rights to purchase any securities of the Company outstanding as of the date of this Agreement and any securities issuable upon the conversion thereof; (c) shares of Common Stock or Preferred Stock issued in connection with any stock split or stock dividend or recapitalization; (d) shares of Common Stock (or options, warrants or rights therefor) granted or issued hereafter to employees, officers, directors, contractors, consultants or advisers to,

the Company or any subsidiary or the Company pursuant to incentive agreements, stock purchase or stock option plans, stock bonuses or awards, warrants, contracts or other arrangements that are approved by the Company's Board of Directors (the "Board"); (e) shares of the Company's Series Seed Preferred Stock issued pursuant to this offering; (f) any other shares of Common Stock or Preferred Stock (and/or options or warrants therefor) issued or issuable primarily for other than equity financing purposes and approved by the Board; and (g) shares of Common Stock issued or issuable by the Company to the public pursuant to a registration statement or offering statement (under Regulation A) filed under the Securities Act.

Each Major Investor shall have ten (10) days from the date such Notice is effective, as determined pursuant to Section 11(d) based upon the manner or method of notice, to agree in writing to purchase such Major Investor's Pro Rata Share of such New Securities for the price and upon the general terms specified in the Notice by giving written notice to the Company and stating therein the quantity of New Securities to be purchased (not to exceed such Major Investor's Pro Rata Share).

(iv) Failure to Exercise. If the Major Investors fail to exercise in full the right of first refusal within such ten (10) day period, then the Company shall have one hundred twenty (120) days thereafter to sell the New Securities with respect to which the Major Investors' rights of first refusal hereunder were not exercised, at a price and upon general terms not materially more favorable to the purchasers thereof than specified in the Company's Notice to the Major Investors. The holders of Series Seed preferred are entitled to a liquidation preference meaning they receive the greater of their original investment amount plus any dividends declared and unpaid thereon or the amount per share as would have been payable to them if they converted to common immediately prior to the liquidation event. They vote along with the Common stockholders on an as converted to common basis on all matters coming before the stockholders at a meeting or by written consent. The Series Seed converts into common at the option of the holder initially on a one for one basis but subject to standard anti dilution adjustments. The preferred stockholders are entitled to dividends as and when paid on the Common Stock on an as converted to common stock basis.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

Given the Company's limited operating history, the Company cannot reliably predict future success or estimate how much revenue it will receive in the future, if any.

Milestones

Grazr Inc was incorporated in the State of Delaware in September 2019.

Since then, we have:

- Marketplace platform built for live-on-the-hoof, direct-to-customer meat sales. Massive industry disruption potential.
- Covid-19 has driven consumers outside of the traditional supply chain towards secure local sourcing.
- 835 small processors nationwide and growing to support direct to consumer sale model.
- Hyperlocal food sourcing, particularly meats, lower the environmental impact of the meat we consume.
- As much as %50 of farmers costs tied up in cost to bring animal from farm to market.

Historical Results of Operations

Our company was organized in September 2019 and has limited operations upon

which prospective investors may base an evaluation of its performance.

- Revenues & Gross Margin.

For the period ended December 31, 2020, the Company had revenues of \$0 compared to the year ended December 31, 2019, when the Company had revenues of \$0.

- Assets. As of December 31, 2020, the Company had total assets of \$562, including \$562 in cash. As of December 31, 2019, the Company had \$13,184 in total assets, including \$13,184 in cash.

- Net Loss. The Company has had net losses of \$11,643 and net losses of \$6,816 for the fiscal years ended December 31, 2020 and December 31, 2019, respectively.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 12 months. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. The Company intends to raise additional capital in the future from investors. Runway & Short/Mid Term Expenses

Grazr Inc cash in hand is \$25, as of February 2021. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$1,000/month, for an average burn rate of \$1,000 per month. Our intent is to be profitable in 12 months.

After the period that our financials cover, the development of Grazr's platform was completed and we shifted our work toward preparing for the platform launch.

In 3-6 months, our projected monthly burn rate is \$1000/month. Assuming we complete a successful crowdfunding raise for a minimum of \$50,000, there will be a substantial rise in expenses due to marketing/promotion and sales costs. However, that will also be the crucial point at which we will begin generating revenue.

Tom Cunningham and Anthony Laney the co-founders of Grazr have funded the development thus far and will continue to do whatever they can financially to keep this venture moving forward. However, the scope and pace needed to launch the platform is outside of their means thus the need for crowdfunding capital.

In such a circumstance, the Lead Investor may act as a portfolio manager for that SPV (and as a supervised person of Wefunder Advisors) and may be compensated through that role. Although the Lead Investor may act in multiple roles and be compensated from multiple parties, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of the Company's securities. As a result, the Lead Investor's interests should always be aligned with those of the Investors.

Investors that wish to purchase the Company's securities through Wefunder Portal

must agree to (1) hire XX Investments to serve as custodian, paying agent, and proxy agent with respect to the Company's securities; (2) give a power of attorney to XX Team to make all voting decisions with respect to the Company's securities; and (3) direct XX Investments to share 10% of the Investor's distribution from the Company with XX Team. The Company may waive these requirements for certain investors with whom the Company has a pre-existing relationship.

The XX arrangement described above is intended to benefit the Company by allowing the Company to reflect one investor of its capitalization table (XX Investments) and by simplifying the voting process with respect to the Company's securities by having one entity (XX Team), through one person (the Lead Investor), make all voting decisions and having one entity (XX Investments) carry out XX Team's voting instruments and any take any related actions. The XX arrangement also is intended to benefit Investors by providing the services of an experienced Lead Investor (acting on behalf of XX Team) who is expected to make value-maximizing decisions regarding Investors' securities. XX Team (acting through the Lead Investor) may further benefit both the Company and Investors by providing consulting services to the Company that are intended to maximize both the value of the Company's business and also the value of its securities.
