Production Risk: Meeting slat and panel production goals during COVID is a consistent challenge with overseas management, labor availability, and shipping.

COVID/Travel: Not being able to travel easily to SE Asia could cause production slowdown as we continue to hire additional management in the Philippines.

Funding Risk: If we overextend buying new equipment without being able to raise additional funds, we run the risk of our expansion becoming capital constrained.

Sales Risk: We have strong customer demand expressed through LOIs, but customers facing additional COVID or demand bumps would slow expansion.

Regulatory/Geopolitical Risk: We operate in developing countries that can have higher operational risk than the US; this presents long-term risk for supply chain reliability, though we mitigate it by planting in the US and diversifying supply.

Demand Risk: If new construction drastically falls worldwide, there may be less demand for new bamboo products in the market. Lumber could also see a price decrease if demand falls low enough, making the opportunity cost for a new material greater. However, our climate-positive focus should still allow us to attract high-profile customers that prioritize green building.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Conversion and Repayment

(a) Conversion Upon Qualified Financing

Conversion upon a Qualified Financing. In the event that the Company issues and sells its equity securities to investors (the "Investors") while this Note remains outstanding in an equity financing with total proceeds to the Company of not less than \$10,000,000 (excluding the conversion of the Notes or other convertible securities issued for capital raising purposes (e.g., Simple Agreements for Future Equity)) (a "Qualified Financing"), then the outstanding principal amount of this Note and any unpaid accrued interest shall automatically convert in whole without any further action by the Holder into Equity Securities sold in the Qualified Financing at a conversion price equal to the lesser of (i) the price paid per share for Equity Securities by the Investors in the Qualified Financing multiplied by 0.88, and (ii) the quotient resulting from dividing \$27,000,000 by the number of outstanding shares of common stock of the Company immediately prior to the Qualified Financing (assuming conversion of all securities convertible into common stock and exercise of all outstanding options and warrants, but excluding the shares of equity securities of the Company issuable upon the conversion of the Notes or other convertible securities issued for capital raising purposes (e.g., Simple Agreements for Future Equity)). The issuance of Equity Securities pursuant to the conversion of this Note shall be upon and subject to the same terms and conditions applicable to Equity Securities sold in the Qualified Financing. Notwithstanding this paragraph, if the conversion price of the Notes as determined pursuant to this paragraph (the "Conversion Price") is less than the price per share at which Equity Securities are issued in the Qualified Financing, the Company may, solely at its option, elect to convert this Note into shares of a newly created series of preferred stock having the identical rights, privileges, preferences and restrictions as Equity Securities issued in the Qualified Financing, and otherwise on the same terms and conditions, other than with respect to (if applicable): (i) the per share liquidation preference and the conversion price for purposes of price-based anti-dilution protection, which will equal the Conversion Price; and (ii) the per share dividend, which will equal the dividend rate of the Equity Securities issued in the Qualified Financing.

(b) Conversion upon a Change of Control.

If the Company consummates a Change of Control (as defined in the Convertible Note) while this Note remains outstanding, the Company shall repay the Holder in cash in an amount equal to the outstanding principal amount of this Note plus any unpaid accrued interest on the original principal. For purposes of this Note, a "Change of Control" means (i) a consolidation or merger of the Company with or into any other corporation or other entity or person, or any other corporate reorganization, other than any such consolidation, merger or reorganization in

which the shares of capital stock of the Company immediately prior to such consolidation, merger or reorganization continue to represent a majority of the voting power of the surviving entity immediately after such consolidation, merger or reorganization; (ii) any transaction or series of related transactions to which the Company is a party in which in excess of 50% of the Company's voting power is transferred; or (iii) the sale or transfer of all or substantially all of the Company's assets, or the exclusive license of all or substantially all of the Company's material intellectual property; provided that a Change of Control shall not include any transaction or series of transactions principally for bona fide equity financing purposes in which cash is received by the Company or any successor, indebtedness of the Company is cancelled or converted or a combination thereof. The Company shall give the Holder notice of a Change of Control not less than 10 days prior to the anticipated date of consummation of the Change of Control. Any repayment pursuant to this paragraph in connection with a Change of Control shall be subject to any required tax withholdings, and may be made by the Company (or any party to such Change of Control or its agent) following the Change of Control in connection with payment procedures established in connection with such Change of Control.

(c) Procedure for Conversion. Procedure for Conversion.

In connection with any conversion of this Note into capital stock, the Holder shall surrender this Note to the Company and deliver to the Company any documentation reasonably required by the Company (including, in the case of a Qualified Financing, all financing documents executed by the Investors in connection with such Qualified Financing). The Company shall not be required to issue or deliver the capital stock into which this Note may convert until the Holder has surrendered this Note to the Company and delivered to the Company any such documentation. Upon the conversion of this Note into capital stock pursuant to the terms hereof, in lieu of any fractional shares to which the Holder would otherwise be entitled, the Company shall pay the Holder cash equal to such fraction multiplied by the price at which this Note converts.

(d) Interest Accrual. If a Change of Control or Qualified Financing is consummated, all interest on this Note shall be deemed to have stopped accruing as of a date selected by the Company that is up to 10 days prior to the signing of the definitive agreement for the Change of Control or Qualified Financing.

Senior Indebtedness The indebtedness evidenced by this Note is subordinated in right of payment to the prior payment in full of any Senior Indebtedness in existence on the date of this Note or hereafter incurred. "Senior Indebtedness" shall mean, unless expressly subordinated to or made on a parity with the amounts due under this Note, all amounts due in connection with (i) indebtedness of the Company to banks or other lending institutions regularly engaged in the business of lending money (excluding venture capital, investment banking or similar institutions and their affiliates, which sometimes engage in lending activities but which are primarily engaged in investments in equity securities), and (ii) any such indebtedness or any debentures, notes or other evidence of indebtedness issued in exchange for such Senior Indebtedness, or any indebtedness arising from the satisfaction of such Senior Indebtedness by a guarantor.

Irrevocable Proxy. The Investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, will appoint XX Team LLC ("XX Team") as the Investor's true and lawful proxy and attorney (the "Proxy"), with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) direct the voting of all securities purchased through wefunder.com, and to direct the exercise of all voting and other rights of Investor with respect to the Company's securities, and (ii) direct, in connection with such voting power, the execution of any instrument or document that XX Team determines is necessary and appropriate in the exercise of its authority. Such Proxy will be irrevocable. If an investor has entered into the Custodial and Voting Agreement with XX Investments LLC ("XX Investments"), then XX Investments will be the entity that XX Team directs to vote and take any other actions in connection with such voting (including the execution of documents) on behalf of such investor.

Repurchase. Any term of this Note may be amended or waived with the written consent of the Company and the Holder. In addition, any term of this Note may be amended or waived with the written consent of the Company and the Majority Holders. Overview

RIZOME is pioneering bamboo engineered lumber as a climate-positive alternative to wood, steel, and concrete. Bamboo is critical to addressing climate change and make the building industry sustainable.

Our goal is to sequester 10 gigatons of CO₂ by 2050, which is 1% of all anthropogenic carbon emissions. This is huge. In order to achieve this, we'll plant more than 1 million hectares of bamboo forest and build more than 1,000 manufacturing facilities. These projections cannot be guaranteed.

Milestones

Bamboo Ecologic Corp was incorporated in the State of Nevada in January 2013.

Since then, we have:

- RIZOME is the Global Leader in Bamboo Engineered Lumber
- RIZOME hopes to be profitable by June 2021 after building the largest bamboo factory in the world

Liquidity & Capital Resources

To-date, the company has been financed with \$1,333,223 in debt, \$1,200,269 in equity, and \$475,000 in convertibles.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 24 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Bamboo Ecologic Corp cash in hand is \$492,482, as of January 2021. Over the last three months, revenues have averaged \$17,556/month, cost of goods sold has averaged \$3,600/month, and operational expenses have averaged \$52,567/month, for an average burn rate of \$38,611 per month. Our intent is to be profitable in 5 months.

Since the date that our financials cover, we have rolled out new factory operations and deployed \$500k in new equipment purchases for operational expansion and positive cashflow. The company also raised additional cash through debt financing in the amount of \$673,750 via loans and \$475,000 via convertible debt. The terms of the debt vary with interest accruing at 6-12% and maturities ranging from 2021 – 2024.

We plan to fully deploy all new equipment from this fundraising round by June 2021 at our new factory in the Philippines. The equipment takes 2-4 months to be custom manufactured in Taiwan, 1 month shipping, and 1 month setup and calibration.

We aim to be cashflow positive after deploying the equipment and able to finance growth through commercial debt from operations. We need at least \$500k for a complete slat and lamination line to reach profitability. We anticipate a \$100k/month operational overhead, plus a 55% gross margin after COGS. These projections cannot be guaranteed.

We anticipate that we can leverage our existing investor base to provide additional convertible debt if necessary.
