8. Discuss the material factors that make an investment in the issuer speculative or risky:

Our first "Easy Order" product is a late entry into a very crowded order / delivery space. We might not be able to differentiate ourselves from the established players (GrubHub, DoorDash, etc.) enough to gain significant market traction.

We have future plans to establish meal delivery operations via aerial drones. This effort is a complicated, multi-year process. Success requires significant engineering, testing and regulatory approval from the FAA. We might spend years of work and tons of money chasing our approvals and ultimately fail.

Our target market (restaurants) are overwhelmed right now with COVID restrictions and a battered economy. Many are simply going out of business, and most of the rest are struggling financially. It is difficult to get their attention (especially in the US). New restaurant sign-ups might go out of business and their failure will negatively impact our growth targets.

Simultaneously launching in the USA and Mexico places extra strain on management and available capital which could cause us to do poorly or even fail in either or both markets.

Until we are able to establish our community delivery networks we are reliant on companies like Postmates, who are competitors, to provide last mile services for restaurants who do not want to do their own delivery. If we are unable to establish effective delivery networks, our appeal to restaurants will be significantly limited.

With new COVID "work from home" patterns it is difficult to manage people and individual productivity is lower across most of our teams.

The success of Dine Direct is directly tied to our ability to establish a multi-sided platform. (Restaurants, Delivery Agents and Food consumers) Multi-sided platforms are complex systems of individual, group and technological interdependence. They require reaching critical mass to succeed. We may need significantly more capital investment to jumpstart these relationships. If we do not reach critical mass, the company will eventually fail.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Ken Irvine is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.

USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

If we raise: **\$100,000**

Use of Proceeds: 60% will go to sales and new restaurant setup. 15% will go to development of platform enhancements. 17.5% will go to platform operations and general business expenses. 7.5% will go to WeFunder fees.

If we raise: **\$1,070,000**

Use of Proceeds: 73% will go to sales and new restaurant setup. 15% will go to platform operations and general business expenses. 4.5% will go to printer and table purchases for restaurant installations. 7.5% will go to WeFunder fees.

Book Entry and Use of XX Investments LLC as Transfer Agent and Custodian. Investments will be in book entry form. XX Investments LLC will act as custodian and hold legal title to the investments for investors that enter into a Custodial and Voting Agreement with XX Investments LLC and will keep track of those investors' beneficial interests in the investments. Ownership and Capital Structure

THE OFFERING

13. Describe the terms of the securities being offered.

To view a copy of the SAFE you will purchase, please see [Appendix B, Investor Contracts](#). The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **Preferred Units** in the Company ("**Preferred Units**"), when and if the Company sponsors an equity offering that involves **Preferred Units**, on the standard terms offered to other Investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving Preferred Units, Investors will receive a number of Preferred Units calculated using the method that results in the greater number of Preferred Units:

1. the total value of the Investor's investment, divided by
 1. the price of Preferred Units issued to new Investors multiplied by
 2. the **discount rate (90%)**, or
2. if the valuation for the company is more than **\$6,000,000.00** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
 1. the Valuation Cap divided by
 2. the total amount of the Company's capitalization at that time.
3. for investors up to the first **\$250,000.00** of the securities, investors will receive a valuation cap of **\$4,000,000.00** and a discount rate of **90.0%**.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Units basis):

- Includes all shares of Capital Units issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Investors who receive Units subject to the Valuation Cap will also receive dividend rights.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving Preferred Units, Investors will receive proceeds equal to the greater of

- 1: the Purchase Amount (the "Cash-Out Amount") or
- 2: the amount payable on the number of shares of Common Units equal to the

Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Units. The Investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Units); On par with payments for other Safes and/or Preferred Units, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Units, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Unit in proportion to the full payments that would otherwise be due; and
1. Senior to payments for Common Units.

Irrevocable Proxy. The Investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, will appoint XX Team LLC ("XX Team") as the Investor's true and lawful proxy and attorney (the "Proxy"), with the power to act alone and with full power of substitution, on behalf of the Investor to:

1. direct the voting of all securities purchased through wefunder.com, and to direct the exercise of all voting and other rights of Investor with respect to the Company's securities, and
2. direct, in connection with such voting power, the execution of any instrument or document that XX Team determines is necessary and appropriate in the exercise of its authority. Such Proxy will be irrevocable. If an investor has entered into the Custodial and Voting Agreement with XX Investments LLC ("XX Investments"), then XX Investments will be the entity that XX Team directs to vote and take any other actions in connection with such voting (including the execution of documents) on behalf of such investor.

Repurchase. If the Company determines, in its sole discretion, that it is likely that within six months the securities of the Company will be held of record by a number of persons that would require the Company to register a class of its equity securities under the Securities Exchange Act of 1934, as amended ("Exchange Act"), as required by Section 12(g) or 15(d) thereof, the Company shall have the option to repurchase the securities from each Investor for the greater of

1. the purchase price of the securities, and
2. the fair market value of the securities, as determined by an independent appraiser of securities chosen by the Company. The foregoing repurchase option will terminate upon a Change of Control or Dissolution Event (each as defined in the Company's Investment Agreement).

 - A. the Purchase Amount may not be amended, waived or modified in this manner,
 - B. the consent of the Investor and each holder of such Safes must be solicited (even if not obtained), and
 - C. such amendment, waiver or modification treats all such holders in the same manner. "Majority-in-interest" refers to the holders of the applicable group of Safes whose Safes have a total Purchase Amount greater than 50% of the total Purchase Amount of all of such applicable group of Safes.

Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal, Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor:

- A. Wefunder Portal may amend the terms of an investment contract, provided that the amended terms are more favorable to the investor than the original terms; and

SAFES from this round, if converted, will convert to Preferred Units.

(a) Preferred Units. The Company, at the management's option, may at any time, redeem any number of outstanding preferred units at a per unit rate at which each such preferred unit was sold, plus any accrued preferred dividend. The Company's preferred units have preferred dividend rights equal to a percentage return defined in the subscription agreement or 8% per year on a cumulative non-compounded basis if no such percentage return is defined. Holders of preferred units have no voting rights. Holders of preferred units have liquidation preferences over our common units and restricted units. The result is that in the event of any liquidation, dissolution or winding up of the Company's affairs, whether voluntary or involuntary, the holders of record of preferred units shall be entitled to recover their investment prior and in preference to any distribution of any of the Company's assets or surplus funds to the holders of our common units or restricted units.

(b) Restricted Units. Each Restricted Unit shall be entitled to profit and loss distributions and allocations. Holders of restricted units have no voting rights. Holders of restricted units have the same liquidation preferences as our common units. The result is that in the event of any liquidation, dissolution or winding up of the Company's affairs, whether voluntary or involuntary, the holders of record of preferred units shall be entitled to recover their investment prior and in preference to any distribution of any of the Company's assets or surplus funds to the holders of our common units or restricted units.

(c) Common Units. Each Common Unit shall carry the right to cast one vote on any matter submitted to the Members of the Company and be entitled to profit and loss distributions and allocations. Holders of common units have the same liquidation preferences as our restricted units. The result is that in the event of any liquidation, dissolution or winding up of the Company's affairs, whether voluntary or involuntary, the holders of record of preferred units shall be entitled to recover their investment prior and in preference to any distribution of any of the Company's assets or surplus funds to the holders of our common units or restricted units.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

The holders of a majority-in-interest of voting rights in the Company could limit

DineDirect helps restaurants prosper by offering online ordering, pick-up and delivery. We support member restaurants with advanced technology, marketing an engaged partner community who provide everything from bicycles to contract delivery services.

We aim to be supporting restaurants in the US and Mexico before the end of 2021. By 2025 we hope to be in over 20+ countries spread across the Americas, Europe and Asia. We already have driver assisted human delivery technology. By 2025 we plan to offer fully autonomous ground and aerial drone food delivery. These projections cannot be guaranteed.

Milestones

Dine Direct LLC was organized in the State of Nevada in August 2020.

Since then, we have:

- \$160 Billion global market is ripe for platform / technology disruption.
- Dine.Direct is growing fast. Over 60% M/M growth for the last 6 months.
- Executive team with over 85 years combined experience in technology, hospitality and organization.

- Global team of over 50 people with a low cost footprint.
- We exist to give control of online ordering back to restaurants and the communities they serve.

Historical Results of Operations

Our company was organized in August 2020 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$608.
- *Assets.* As of December 31, 2020, the Company had total assets of \$124,568, including \$74,223 in cash.
- *Net Loss.* The Company has had net losses of \$143,869 for 2020.
- *Liabilities.* The Company's liabilities totaled \$65,837 for 2020.

Liquidity & Capital Resources

To-date, the company has been financed with \$202,400 in equity and \$21,552 in debt.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 3 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 1 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Dine Direct LLC cash in hand is \$50,455.57, as of January 2021. Over the last three months, revenues have averaged \$1,750/month, cost of goods sold has averaged \$1,620/month, and operational expenses have averaged \$38,500/month, for an average burn rate of \$38,370 per month. Our intent is to be profitable in 9 months.

Since the date our financials cover, we have started increasing direct sales and begun incurring setup operational expenses around \$10K starting mid-January 2021. We plan to steadily increase this expense to \$160K per month by the end Q2.

Total revenue from January to June 2021 is expected to be about \$150K and total expenses are planned to be \$763K. Based on our current models, we will need at least \$513K to hit the \$150K in revenue by the end of June 2021. The additional \$250K in planned expenses is slated for sales and new restaurant setup investment that will begin generating income in FYQ3. These projections cannot be guaranteed.

The current owners have the ability to invest additional capital to cover our burn rate and in the instance that we don't achieve our maximum goal. Third party individuals have expressed interest in investing. If we hit our 15+% M/M revenue growth targets during the first months of 2021 we have interest from traditional VC firms as well. These projections cannot be guaranteed.

In addition to the fees described above, the Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a special purpose vehicle ("SPV") for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such a circumstance, the Lead Investor may act as a portfolio manager for that SPV (and as a supervised person of Wefunder Advisors) and may be compensated through that role. Although the Lead Investor may act in multiple roles and be compensated from multiple parties, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of the Company's securities. As a result, the Lead Investor's interests should always be aligned with those of the Investors.

Investors that wish to purchase the Company's securities through Wefunder Portal must agree to (1) hire XX Investments to serve as custodian, paying agent, and proxy agent with respect to the Company's securities; (2) give a power of attorney to XX Team to make all voting decisions with respect to the Company's securities; and (3) direct XX Investments to share 10% of the Investor's distribution from the Company with XX Team. The Company may waive these requirements for certain investors with whom the Company has a pre-existing relationship.

The XX arrangement described above is intended to benefit the Company by allowing the Company to reflect one investor of its capitalization table (XX Investments) and by simplifying the voting process with respect to the Company's securities by having one entity (XX Team), through one person (the Lead Investor), make all voting decisions and having one entity (XX Investments) carry out XX Team's voting instruments and any take any related actions. The XX arrangement also is intended to benefit Investors by providing the services of an experienced Lead Investor (acting on behalf of XX Team) who is expected to make value-maximizing decisions regarding Investors' securities. XX Team (acting through the Lead Investor) may further benefit both the Company and Investors by providing consulting services to the Company that are intended to maximize both the value of the Company's business and also the value of its securities.

4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
