These include risks relating to economic downturns, political and economic events, and technological developments. The SEC recently approved amendments to Regulation Crowdfunding in which the fundraising limit for crowdfunding issuers will be increased from \$1.07 million during a 12-month period to \$5 million during a 12-month period. These amendments will take effect 60 days after the publication in the Federal Register. The Company reserves the right to increase the Maximum Fundraise Target once such amendments take effect. If the Company increases the Maximum Fundraising Target, investments made prior to such limit increase may be diluted accordingly.

Sizigi was founded in September 2019. Our limited operating history makes evaluating the business and prospects difficult and may increase the risk of your investment. We are at the beginning stages of our product lifecycle in which market acceptance and customer adoption have yet to be validated. As a result, our financial projections are based on assumptions such as the cost of customer acquisition, paid conversion, average revenue per paid users, churn and profit margin. If any of these or our other assumptions vary significantly from actual performance, our financial results could be negatively impacted and put the viability of our enterprise at risk. We cannot guarantee our business strategy will be successful or that we will successfully address unforeseen risks or difficulties as they arise.

Enhancing our brand is critical to expanding our base of members in our network. We believe that the importance of our brand recognition will increase due to the relatively low barriers to entry in the Internet market. If we fail to enhance our brand, or if we incur excessive expenses in this effort, our business, operating results and financial condition will be materially and adversely affected.

To remain competitive, we must continue to enhance and improve the functionality and features of our websites and technology infrastructure. As a result, we will need to continue to improve and expand our hosting and network infrastructure and related software capabilities. These improvements may require greater levels of spending than we have experienced in the past. Without such improvements, our operations might suffer from unanticipated system disruptions, slow application performance or unreliable service levels, any of which could negatively affect our reputation and ability to attract and retain customers and contributors. Furthermore, to continue to attract and retain new customers, we are likely to incur expenses in connection with continuously updating and improving our user interface and experience. We may face significant delays in introducing new services, products, and enhancements. If competitors introduce new products and services using new technologies or if new industry standards and practices emerge, our existing websites and our proprietary technology and systems may become obsolete or less competitive, and our business may be harmed. In addition, the expansion and improvement of our systems and infrastructure may require us to commit substantial financial, operational, and technical resources, with no assurance that our business will improve.

The Company relies on Amazon Web Services for hosting. Any interruption in the availability of these services could have material negative impact on our ability to deliver service to users, as well as the profitability of these operations. Interruptions could occur due to both Internet outages as well as policy changes or terms violations according to these third parties. The prospect of increased regulation may create access challenges to our users and service offerings.

Management will have broad discretion in determining the specific uses of the net proceeds received from the sale of the convertible notes, as well as the net proceeds received from any other financing transaction undertaken by the Company. (a) **Qualified Financing.** In the event of one or more cash closings for a minimum in the aggregate of \$2,000,000 (excluding amounts under the Company Notes and any other convertible promissory notes) in an equity financing (a "Qualified Financing") issuing capital stock of the Company on or prior to the Maturity Date (the "Financing Stock"), this Note shall automatically convert into the number of

shares of Financing Stock determined by dividing (i) the sum of the principal amount of this Note plus accrued interest thereon by (ii) the QF Conversion Price, and then rounding that number down to the nearest whole number (i.e., no fractional shares of Financing Stock will be issued, and the Company will pay the amount corresponding to fractional shares in cash at the time the Company issues the Financing Stock to Holder). The "QF Conversion Price" shall be the lesser of (x) 85% of the price per share at which the Financing Stock is sold in the Qualified Financing or (y) the price per share determined by dividing \$9,000,000 by the aggregate number of shares outstanding of Common Stock immediately preceding a Qualified Financing (assuming full conversion or exercise of all convertible and exercisable securities then outstanding other than the Company Notes or any other convertible promissory notes). Subject to Holder's execution of any related agreement(s), (1) the shares of Financing Stock received by Holder pursuant to a conversion of this Note as provided in this Section 2(a) (the "Conversion Shares") shall have rights, preferences and privileges identical to those shares received by investors in the Qualified Financing and (2) such Conversion Shares shall benefit from representations, warranties, covenants and registration rights, if any, of and from the Company which are identical to those received by such investors. Holder hereby agrees to execute and deliver to the Company all such related agreement(s). For clarity, all such related agreements are expected to include a stock purchase agreement, an investors' rights agreement, a voting agreement and a right of first refusal and co-sale agreement and any other agreement that may be required by the investors in the Qualified Financing. Any conversion of this Note pursuant to this Section 2(a) shall be deemed to have been made concurrently with the closing of the first issuance and sale of shares of Financing Stock and on and after such date the person entitled to receive the Conversion Shares issuable upon such conversion shall be treated for all purposes as the record holder of such Conversion Shares and a purchaser of such Conversion Shares under the stock purchase agreement governing the Qualified Financing (and any other agreements related to the Qualified Financing) and shall be bound by the terms of such stock purchase agreement (and such other agreements).

(b) Conversion Procedure. Upon any conversion of this Note, Holder shall surrender this Note, duly endorsed, at the principal office of the Company. At its expense, the Company shall, as soon as practicable thereafter, issue and deliver to Holder at such principal office a certificate or certificates for the number of shares of equity securities to which Holder shall be entitled upon such conversion (bearing such legends as are required by any applicable agreements and applicable state and federal securities laws), together with any other securities and property to which Holder is entitled upon such conversion under the terms of this Note. For clarity, upon the occurrence of a Qualified Financing, this Note shall be deemed to be converted to Conversion Shares for the benefit of Holder as set forth in Section 2 of the attached agreement, notwithstanding any failure to follow the conversion procedure and any such failure, in whole or in part, shall not be deemed an Event of Default (as defined in the attached agreement).

Irrevocable Proxy.

The Investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, will appoint XX Team LLC ("XX Team") as the Investor's true and lawful proxy and attorney (the "Proxy"), with the power to act alone and with full power of substitution, on behalf of the Investor to:

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 8 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. Runway & Short/Mid Term Expenses

Over the last three months, revenues have averaged \$12,634/month, cost of goods sold has averaged \$688/month, and operational expenses have averaged \$28,764/month, for an average burn rate of \$16,818 per month. Our intent is to be profitable in 12 months.

Our financials cover 2019 and 2020. There are no significant changes in our financials so far in 2021.

As noted, XX Team holds a power of attorney from each Investor that has entered into the Investor Agreement to make voting decisions on behalf of that Investor.
