8. Discuss the material factors that make an investment in the issuer speculative or risky:

The bulk of our collection and processing operations is located in Mexico and Puerto Rico. Both countries are susceptible to severe and unpredictable weather conditions that have increased in frequency as the impact of climate change has become more severe. When we founded in early 2020 we identified this risk and diversified outside of Puerto Rico to Mexico. We will continue to execute this strategy by further expanding through the Caribbean and Mexico.

The sargassum bloom has grown significantly over the last 10 years due to the warming ocean and farming practices in the Amazon. Neither of these trends are reversing, but the bloom could decrease in size for unknown reasons. In order to mitigate the risk of severe supply disruption over an elongated period, we are exploring low-risk methods to grow sargassum seaweed, aka sargassum ranching. These technologies have been developed and can be expected within years.

Scaling production from hundreds of kilograms to thousands of tonnes presents multiple risks. To mitigate these risks we have partnered with an engineering firm with 30+ years of experience in extracting high-value components from seaweed.

One of our primary competitive advantages is our processing intellectual property "IP" and theft of that our IP is a real threat. We protect our IP as we work through the supply chain, filing global patents, and ensuring no one counterparty knows how we extract the components. The future strategy, already in motion, is to use our processing IP as a platform for product IP. Product IP is easier to monitor as it is on the open market. All C-Combinator IP is wholly-owned by C-Combinator, or jointly developed by C-Combinator and Celignis Ltd through C-Combinator Intellectual Property JV LLC, which is 80% owned by C-Combinator and 20% owned by Celignis Ltd.

We are selling multiple seaweed-based products into many different end markets and geographies. With that comes a dynamic regulatory environment. To mitigate this risk, when we prioritize a product we assess the regulatory environment and establish a conservative time to full approval. Time to market is a high weight factor in the product priority.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

## The Offering

### USE OF FUNDS

9. What is the purpose of this offering?

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$100,000**

Use of Proceeds: 50% of the capital raised will go toward the purchase of filtration system to increase our biostimulant production in Mexico from 100 liters per day to 4,000 liter per day. We're hoping this potential increase will production will up our potential daily revenue from \$1,500 to \$60,000 (not guaranteed). The capacity addition will also open up larger sales opportunities that are key in reaching our \$1M+ 6-month biostimulant sales goals. The system has already been built, expected delivery is end of July. The remaining capital, exuding the 6.5% WeFunder fee or 43.5%, will go towards operational expenses.

If we raise: **\$1,070,000**

Use of Proceeds: 50%: In addition to the filtration system, we will use \$150,000 to acquire a second truck, and other equipment, for our collection business. Each truck has the potential to generate \$40,000 per month in revenue (not guaranteed). We are currently at max capacity in our collection business, and have a backlog of 5 resorts ready for our services. We will also invest 2 senior sales positions, one for global biostimulant sales and another for global cosmetic emulsifier sales. These professionals are key in reaching our 2022 and 2023 revenue goals. We will also invest heavily in the

development of our Vegan Leather made from sargassum seaweed. Alternatives to animal and plastic-based leathers are in high demand and our prototype has potential to disrupt the market. Other capital will go towards operational expenses. These capital needs equal an est. 50%, the remaining capital after the 6.5% WeFunder fee will go towards operating expenses ahead of our Series A close in August/September 2021.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). **Interest Rate:** 7%. Interest shall commence with the date of the convertible note and shall continue on the outstanding principal amount until paid in full or converted. Interest shall be computed on the basis of a year of 365 days for the actual number of days elapsed. All unpaid interest and principal shall be due and payable upon request of the Majority Holders on or after the Maturity Date.

### Conversion and Repayment

#### (a) Conversion Upon Qualified Financing

Conversion upon a Qualified Financing. In the event that the Company issues and sells its equity securities to investors (the "Investors") while this Note remains outstanding in an equity financing with total proceeds to the Company of not less than \$1000000 (excluding the conversion of the Notes or other convertible securities issued for capital raising purposes (e.g., Simple Agreements for Future Equity)) (a "Qualified Financing"), then the outstanding principal amount of this Note and any unpaid accrued interest shall automatically convert in whole without any further action by the Holder into Equity Securities sold in the Qualified Financing at a conversion price equal to the lesser of (i) the price paid per share for Equity Securities by the Investors in the Qualified Financing multiplied by 0.85, and (ii) the quotient resulting from dividing \$29000000 by the number of outstanding shares of common stock of the Company immediately prior to the Qualified Financing (assuming conversion of all securities convertible into common stock and exercise of all outstanding options and warrants, but excluding the shares of equity securities of the Company issuable upon the conversion of the Notes or other convertible securities issued for capital raising purposes (e.g., Simple Agreements for Future Equity)). The issuance of Equity Securities pursuant to the conversion of this Note shall be upon and subject to the same terms and conditions applicable to Equity Securities sold in the Qualified Financing. Notwithstanding this paragraph, if the conversion price of the Notes as determined pursuant to this paragraph (the "Conversion Price") is less than the price per share at which Equity Securities are issued in the Qualified Financing, the Company may, solely at its option, elect to convert this Note into shares of a newly created series of preferred stock having the identical rights, privileges, preferences and restrictions as Equity Securities issued in the Qualified Financing, and otherwise on the same terms and conditions, other than with respect to (if applicable): (i) the per share liquidation preference and the conversion price for purposes of price-based anti-dilution protection, which will equal the Conversion Price; and (ii) the per share dividend, which will be the same percentage of the Conversion Price as applied to determine the per share dividends of the Investors in the Qualified Financing relative to the purchase price paid by the Investors.

#### (b) Conversion upon a Change of Control.

If the Company consummates a Change of Control (as defined in the Convertible Note) while this Note remains outstanding, the Company shall repay the Holder in cash in an amount equal to the outstanding principal amount of this Note plus any unpaid accrued interest on the original principal. For purposes of this Note, a "Change of Control" means (i) a consolidation or merger of the Company with or into any other corporation or other entity or person, or any other corporate reorganization, other than any such consolidation, merger or reorganization in which the shares of capital stock of the Company immediately prior to such consolidation, merger or reorganization continue to represent a majority of the voting power of the surviving entity immediately after such consolidation, merger or reorganization; (ii) any transaction or series of related transactions to which the Company is a party in which in excess of 50% of the Company's voting power is transferred; or (iii) the sale or transfer of all or substantially all of the Company's assets, or the exclusive license of all or substantially all of the Company's material intellectual property; provided that a Change of Control shall not include any transaction or series of transactions principally for bona fide equity financing purposes in which cash is received by the Company or any successor, indebtedness of the Company is cancelled or converted or a combination thereof. The Company shall give the Holder notice of a Change of Control not less than 10 days prior to the anticipated date of consummation of the Change of Control. Any repayment pursuant to this paragraph in connection with a Change of Control shall be subject to any required tax withholdings, and may be made by the Company (or any party to such Change of Control or its agent) following the Change of Control in connection with payment procedures established in connection with such Change of Control.

#### (c) Procedure for Conversion.

Procedure for Conversion. In connection with any conversion of this Note into

capital stock, the Holder shall surrender this Note to the Company and deliver to the Company any documentation reasonably required by the Company (including, in the case of a Qualified Financing, all financing documents executed by the Investors in connection with such Qualified Financing). The Company shall not be required to issue or deliver the capital stock into which this Note may convert until the Holder has surrendered this Note to the Company and delivered to the Company any such documentation. Upon the conversion of this Note into capital stock pursuant to the terms hereof, in lieu of any fractional shares to which the Holder would otherwise be entitled, the Company shall pay the Holder cash equal to such fraction multiplied by the price at which this Note converts.

**(d) Interest Accrual.** If a Change of Control or Qualified Financing is consummated, all interest on this Note shall be deemed to have stopped accruing as of a date selected by the Company that is up to 10 days prior to the signing of the definitive agreement for the Change of Control or Qualified Financing.

#### **Senior Indebtedness**

The indebtedness evidenced by this Note is subordinated in right of payment to the prior payment in full of any Senior Indebtedness in existence on the date of this Note or hereafter incurred. "Senior Indebtedness" shall mean, unless expressly subordinated to or made on a parity with the amounts due under this Note, all amounts due in connection with (i) indebtedness of the Company to banks or other lending institutions regularly engaged in the business of lending money (excluding venture capital, investment banking or similar institutions and their affiliates, which sometimes engage in lending activities but which are primarily engaged in investments in equity securities), and (ii) any such indebtedness or any debentures, notes or other evidence of indebtedness issued in exchange for such Senior Indebtedness, or any indebtedness arising from the satisfaction of such Senior Indebtedness by a guarantor.

#### **Securities Issued by the SPV**

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

#### **Voting Rights**

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

#### **Proxy to the Lead Investor**

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferee or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

#### **Restriction on Transferability**

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

## Management's Discussion and Analysis of Financial Condition and Results of Operations

### Overview

We're one of the few global companies exploring the benefits of the most common tropical brown seaweed, Sargassum. Our products actually help reduce and offset emissions from fossil fuels and traditional plastics while minimizing waste.

Through processing Sargassum into carbon neutral and biodegradable products, we hope to see a regeneration of soils and oceans, strengthening their natural ability as Carbon Sinks - all the while restoring their capacity to generate life - as critical habitats, fishing grounds, or farmland. In 5 years, we want to sequester thousands of tons of carbon into a new approach to biodegradable solutions in opposition to the oil companies of today.

### Milestones

C-Combinator, a Public Benefit Corporation was incorporated in the State of Delaware in January 2020.

Since then, we have:

- Launched our first 3 biostimulant products in May 2021. Our SargaExtra product has shown increased yields of 15-40% in food crops like peppers and tomato.
- Resilient business model with up to 60% product contribution margins due to close to zero acquisition costs for seaweed and proprietary processing methods.
- Intellectual property filed on extraction methods used to create products worth \$200 - \$2000/kg.
- Can drawdown & avoid gigatons of CO2 stopping the acidification of oceans destroying coral reefs & fish stocks.
- Generated \$75,000 in contracted revenue from resorts in the Puerto Morelos area, monthly revenue is in excess of \$40,000 for the month of June.

### Historical Results of Operations

Our company was organized in January 2020 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$0.
- *Assets.* As of December 31, 2020, the Company had total assets of \$545,401, including \$244,383 in cash.
- *Net Loss.* The Company has had net losses of \$1,866,036 for 2020.
- *Liabilities.* The Company's liabilities totaled \$2,517,697 for 2020.

### Liquidity & Capital Resources

To-date, the company has been financed with \$2,263,000 in convertibles and \$1,442,500 in Reg D financing in the form of operating profit shares.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 4 to 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 1 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

### Runway & Short/Mid Term Expenses

C-Combinator, a Public Benefit Corporation cash in hand is \$250,000, as of June 2021, with an additional \$250,000 to \$350,000 of convertible note investment committed in the near-term. This capital is in addition to Reg CF capital we expect to raise in this offering. We expect cash on hand, plus incoming investment, to cover 3-months of our base burn. We have launched our Series A process, with the goal to raise \$5M in capital closing in August or September. We

already have interest from our existing investor base and other institutions that have followed us since launch.

Over the last three months, revenues have averaged \$12,642/month, cost of goods sold has averaged \$5,265/month, and operational expenses have averaged \$200,000/month, for an average burn rate of \$205,000 per month. Our intent is to be operating profit positive within 18-months and net profit positive within 2 to 3 years.

Throughout calendar year 2020 we established and grew our Puerto Rico R&D facility from a team of 2 people to 7 people in a 4,500 square ft lab. Also in Puerto Rico we built out an initial processing line capable of processing and drying 1 tonne per day of sargassum seaweed to prove out our processing model intended for larger scale in other regions.

Since the date of our financials, we expanded our operation to Puerto Morelos, Mexico. Added a team of 10 local people and signed a lease for 20,000 square ft of processing. We added collection capacity through the acquisition of a roll-off truck to collect from resorts and processing capacity of 72 tonnes of sargassum per day.

Over the next 3-6 months we expect revenue to range from \$350,000 to \$2,000,000 driven by sargassum collection and sale of biostimulants into the agriculture sector. Expenses are expected to range from \$600,000 to \$1,800,000, depending on opportunities to capture near-term revenue. These projections cannot be guaranteed.

The Lead Investor. As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.
