This company is a high-tech venture requiring specialized management, ongoing product development, and production expertise. There is no guarantee that our current marketing edge can be maintained without sufficient revenues to support clinical trials and more research.

Additional guidelines imposed by the FDA on CBD product advertising in the future could curtail some marketing avenues and activities.

The acquisition of raw materials and quality HEMP bio-mass for processing could affect profitability in the future.

State-imposed regulations on the advertising and sale of Hemp-derived CBD products could adversely affect projected roll-outs in some states.

Selling Hemp CBD products for uses other than cosmetics comes with significantly higher legal risks that have not been fully identified at this time.

The initial revenues reflected on the company's financial statements are not representative of the current business model. The company has shifted from a consulting model to a wholesale/dispensary concept. Revenues are expected to grow slowly because of a lack of funding and will continue slowly during the first 12 months while physicians and health care professionals are educated and recruited.

As holders of a majority-in-interest of voting rights in the Company, the shareholders may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. Interest Rate: 6%. Interest shall commence with the date of the convertible note and shall continue on the outstanding principal amount until paid in full or converted. Interest shall be computed on the basis of a year of 365 days for the actual number of days elapsed. All unpaid interest and principal shall be due and payable upon request of the Majority Holders on or after the Maturity Date.

Early-Bird: Investors investing in the first \$250,000.00, will receive a valuation cap of \$15,000,000.00

Conversion and Repayment

(a) Conversion Upon Qualified Financing Conversion upon a Qualified Financing. In the event that the Company issues and sells its equity securities to investors (the "Investors") while this Note remains outstanding in an equity financing with total proceeds to the Company of not less than \$1000000 (excluding the conversion of the Notes or other convertible securities issued for capital raising purposes (e.g., Simple Agreements for Future Equity)) (a "Qualified Financing"), then the outstanding principal amount of this Note and any unpaid accrued interest shall automatically convert in whole without any further action by the Holder into Equity Securities sold in the Qualified Financing at a conversion price equal to the lesser of (i) the price paid per share for Equity Securities by the Investors in the Qualified Financing multiplied by 0.8, and (ii) the quotient resulting from dividing \$20000000 by the number of outstanding shares of common stock of the Company immediately prior to the Qualified Financing (assuming conversion of all securities convertible into common stock and exercise of all outstanding options and warrants, but excluding the shares of equity securities of the Company issuable upon the conversion of the Notes or other convertible securities issued for capital raising purposes (e.g., Simple Agreements for Future Equity)). The issuance of Equity Securities pursuant to the conversion of this Note shall be upon and subject to the same terms and conditions applicable to Equity Securities sold in the Qualified Financing. Notwithstanding this paragraph, if the conversion price of the Notes as determined pursuant to this paragraph (the "Conversion Price") is less than the price per share at which Equity Securities are issued in the Qualified Financing, the Company may, solely at its option, elect to convert this Note into shares of a newly created series of preferred stock having the identical rights, privileges, preferences and restrictions as Equity Securities issued in the Qualified Financing, and otherwise on the same terms and conditions, other than with respect to (if applicable): (i) the per share liquidation preference and the conversion price for purposes of price-based anti-dilution protection, which will equal the Conversion Price; and (ii) the per share

dividend, which will be the same percentage of the Conversion Price as applied to determine the per share dividends of the Investors in the Qualified Financing relative to the purchase price paid by the Investors.

(b) Conversion upon a Change of Control. If the Company consummates a Change of Control (as defined in the Convertible Note) while this Note remains outstanding, the Company shall repay the Holder in cash in an amount equal to the outstanding principal amount of this Note plus any unpaid accrued interest on the original principal. For purposes of this Note, a "Change of Control" means (i) a consolidation or merger of the Company with or into any other corporation or other entity or person, or any other corporate reorganization, other than any such consolidation, merger or reorganization in which the shares of capital stock of the Company immediately prior to such consolidation, merger or reorganization continue to represent a majority of the voting power of the surviving entity immediately after such consolidation, merger or reorganization; (ii) any transaction or series of related transactions to which the Company is a party in which in excess of 50% of the Company's voting power is transferred; or (iii) the sale or transfer of all or substantially all of the Company's assets, or the exclusive license of all or substantially all of the Company's material intellectual property; provided that a Change of Control shall not include any transaction or series of transactions principally for bona fide equity financing purposes in which cash is received by the Company or any successor, indebtedness of the Company is cancelled or converted or a combination thereof. The Company shall give the Holder notice of a Change of Control not less than 10 days prior to the anticipated date of consummation of the Change of Control. Any repayment pursuant to this paragraph in connection with a Change of Control shall be subject to any required tax withholdings, and may be made by the Company (or any party to such Change of Control or its agent) following the Change of Control in connection with payment procedures established in connection with such Change of Control.

(c) Procedure for Conversion. Procedure for Conversion. In connection with any conversion of this Note into capital stock, the Holder shall surrender this Note to the Company and deliver to the Company any documentation reasonably required by the Company (including, in the case of a Qualified Financing, all financing documents executed by the Investors in connection with such Qualified Financing). The Company shall not be required to issue or deliver the capital stock into which this Note may convert until the Holder has surrendered this Note to the Company and delivered to the Company any such documentation. Upon the conversion of this Note into capital stock pursuant to the terms hereof, in lieu of any fractional shares to which the Holder would otherwise be entitled, the Company shall pay the Holder cash equal to such fraction multiplied by the price at which this Note converts.

(d) Interest Accrual. If a Change of Control or Qualified Financing is consummated, all interest on this Note shall be deemed to have stopped accruing as of a date selected by the Company that is up to 10 days prior to the signing of the definitive agreement for the Change of Control or Qualified Financing.

Senior Indebtedness

The indebtedness evidenced by this Note is subordinated in right of payment to the prior payment in full of any Senior Indebtedness in existence on the date of this Note or hereafter incurred. "Senior Indebtedness" shall mean, unless expressly subordinated to or made on a parity with the amounts due under this Note, all amounts due in connection with (i) indebtedness of the Company to banks or other lending institutions regularly engaged in the business of lending money (excluding venture capital, investment banking or similar institutions and their affiliates, which sometimes engage in lending activities but which are primarily engaged in investments in equity securities), and (ii) any such indebtedness or any debentures, notes or other evidence of indebtedness issued in exchange for such Senior Indebtedness, or any indebtedness arising from the satisfaction of such Senior Indebtedness by a guarantor.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferee or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

Upon the effectuation of such waiver or amendment with the consent of the Majority Holders in conformance with this paragraph, such amendment or waiver shall be effective as to, and binding against the holders of, all of the Notes, and the Company shall promptly give written notice thereof to the Holder if the Holder has not previously consented to such amendment or waiver in writing; provided that the failure to give such notice shall not affect the validity of such amendment or waiver.

Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal, Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor:

- A. Wefunder Portal may amend the terms of an investment contract, provided that the amended terms are more favorable to the investor than the original terms; and
- B. Wefunder Portal may reduce the amount of an investor's investment if the reason for the reduction is that the Company's offering is oversubscribed.

Overview

BioSmart Research produces CBD isolate formulas for topical and internal use.

In 5 years, BioSmart Research hopes to have no less than 50 retail dispensaries and 500 professional partners consisting of retailers, pain clinics, pharmacies, and physical therapy businesses producing \$25 million in sales per year. These projections cannot be guaranteed.

Milestones

BIOSMART RESEARCH, INC. was incorporated in the State of Washington in March 2019.

Since then, we have:

- Launch in 2019 produced \$1.7M in sales
- Biosmart produces pain management and anti-anxiety formulas for clinical and retail distribution
- BioSmart has a 3-year technology lead using high-pressure liquid chromatography for isolate extraction
- BioSmart markets through it's own retail dispensaries, healthcare providers, pharmacies, affiliates, and internet sales
- U.S. Market for non-steroidal OTC pain relievers is \$21.9 B/yr. US CBD market is \$4.7 B/yr.
- Clinical dosing levels with CBD isolates produce similar results to OTC pain relievers without the side effects.
- BioSmart collaborates with university and clinical researchers and is a member of Choose Wisely, a patient forum

Historical Results of Operations

Our company was organized in March 2019 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$52,952 compared to the year ended December 31, 2019, when the Company had revenues of \$1,873,578. Our gross margin was 20.05% in 2019.
- *Assets.* As of December 31, 2020, the Company had total assets of \$2,627,387, including \$49,777 in cash. As of December 31, 2019, the Company had \$2,472,260 in total assets, including \$68,970 in cash.
- *Net Loss.* The Company had a net loss of \$149,247 and net income of \$74,730 for the fiscal years ended December 31, 2020 and December 31, 2019, respectively.
- *Liabilities.* The Company's liabilities totaled \$240,277 for the fiscal year ended December 31, 2020 and \$114,891 for the fiscal year ended December 31, 2019.

Liquidity & Capital Resources

To-date, the company has been financed with \$2,316,627 in equity and \$239,787 in debt.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 12 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business

Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

BIOSMART RESEARCH, INC. cash in hand is \$9,116, as of June 2021. Over the last three months, revenues have averaged \$11,000/month, cost of goods sold has averaged \$1,500/month, and operational expenses have averaged \$14,000/month, for an average burn rate of \$4,500 per month. Our intent is to be profitable in 2 months.

Since the date our financials cover, initial limited production in our new manufacturing facility began in February 2021. Product sampling and marketing expenses rose sharply in March and April. The B2C marketing campaign has not launched but will commence based upon the success of the Wefunder campaign.

Assuming we achieve our minimum fundraising goal on Wefunder, we anticipate that we can generate \$25,000 per month in revenues during the next 3 months rising to \$77,000 in revenues per month within 6 months. Projected expenses in the next 3-6 months range from \$45,000-\$350,000, depending on how much we raise. Higher expenses would be contingent on retiring the corporate note on the remaining piece of equipment and opening up the first retail CBD dispensary. We estimate reaching breakeven in the next 60 days. These are estimates based upon existing B2B retail distribution opportunities and the launch of a major marketing campaign. These projections cannot be guaranteed.

We have our own personal lines of credit and a large asset base if it became necessary to infuse the company with additional funds. We do not feel that this will be necessary based upon our current production, our product lines and the opportunities that lie before us.

Change in Revenue from 2019 to 2020

In 2018, we began importing lab equipment through a new company which we formed called Washington State Enterprises, Inc. This Corporation was expressly organized to handle the sales of lab equipment. We formed BioSmart Research, Inc. to handle the consulting revenues generated from WSE's client base and to supervise the equipment installations and SOP development on the equipment.

During this early period of 2018, BioSmart Research began a collaboration with a biochemist from the University of Washington and began attending all their internal faculty forums. After meeting with numerous researchers over several months it became apparent that the bulk of all university and independent research was being conducted on isolated individual cannabinoids which could not be produced on conventional distillation equipment. We immediately stepped up our game and began a collaboration with one of the world's largest High-Pressure Liquid Chromatography (HPLC) manufacturers. An organic (ethanol) process for separating out individual cannabinoids was developed over 15 months with the help of our two biochemists. Our product line, produced from cannabinoid isolates took another 12 months to develop.

When COVID hit in March of 2020, almost all equipment sales and consulting revenues were put on hold by most of our major customers. Consulting revenues soon came to a halt. Seeing this as an opportunity to focus on the direction that we saw as our future, we imported our own lab equipment and installed it in buildings owned by us. While this was being accomplished, our biochemists were working on finalizing the isolate formulas that now comprise BioSmart's product lines.

BioSmart's product lines are comprised of unique cannabinoid isolates. They are designed to be distributed primarily through healthcare provider networks either directly through doctor referrals or other health care providers as well as retail outlets.

Our projected future revenue stream is coming primarily from wholesale accounts with healthcare providers and retail outlets. BioSmart's dispensary concept is quite different from conventional storefronts. The BioSmart dispensary serves as a hub for wholesale distribution, in-store sales, referrals, consulting services with health care professionals, and a plethora of free information and medical literature including videos like the one prepared for our corporate investors. The dispensary is a staged vehicle meant to provide a genuine service that both educates and heals because of its services and products. We are putting together a team of health care professionals to educate and assist other health care professionals with cannabinoid treatment for their patients. We have several professional papers published, some by our staff biochemists working with the University of Washington which we provide to assist in the educational process for health care professionals.

Our dispensary model is somewhat unique at this time, however, as more research and clinical guidelines are established, isolated cannabinoid formulas will become

the norm, especially as major drug companies such as GW Pharmaceuticals begin to use FDA sanctioned marketing strategies and clinical trials to overcome the strategies and hype employed in the hemp and cannabis industry. Professional endorsements trump all the hype over the “entourage effect” employed by the rest of the grower and retail industry. Isolated cannabinoid formulas that treat specific conditions are where the medical market is headed and BioSmart is at the forefront of that market.

Revenues began slowly because of a lack of funding and will continue slowly during the first 12 months while physicians and health care professionals are educated and recruited. The quality of wholesale accounts is dependent on the type of sales reps that are recruited to pitch and educate retailers. BioSmart’s business-to-business marketing strategy utilizes physicians and in-house sales reps.

BioSmart’s initial infusion of assets and capital resources comes from its founders through their Taiwan Company and through personal loans to BioSmart. Cash loans from the founders provided for nearly all operating activities up until now although its subsidiary was profitable in 2019. Additional operating capital of \$40,000 was advanced to Biosmart its founders in April. It is anticipated that this will be the last cash infusion required of its founders. If the WeFunder campaign is even marginally successful, Biosmart intends to be cash-flow positive by the end of Summer. The proceeds of this offering will enable the business to continue to pursue its marketing plan and will be necessary for sustained growth. BioSmart currently has \$60,000 in raw materials, labels, and packaging to produce its listed products. BioSmart’s processing capabilities enable it to produce 15 Kilos of distillate and 2 Kilos of isolate per day. Isolate production could be doubled within 120 days in order to produce \$2 million in wholesale products per month. These projections are not guaranteed.

As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such a circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.
