Purpose of This Form

A company that wants to raise money using Regulation Crowdfunding must give certain information to prospective investors, so investors will have a basis for making an informed decision. Our Story

In 2018, she introduced the hand-bottled tonic syrups exclusively at farmers' markets—before she had even developed the brand and marketing for her products.

- "It was a great testing ground and showed me that people loved the product," Mouming said.
- Now in addition to showcasing her products at the Evanston, Des Moines, Omaha and Kansas City farmers markets, Joanna's tonic syrups are popping up in many establishments. Iowa City icons including Pullman Bar & Diner, Bread Garden Market, John's Grocery, Prairie Kitchen Store, Cedar Ridge Winery & Distillery, Bootleggin' Barzini's and New Pioneer Coop feature Joanna's. Gateway Market, Des Moines Mercantile and Cheese Bar in Des Moines and The Map Room and The Hotel at Kirkwood Center in Cedar Rapids also carry her tonic syrups. Independent Liquors, L&M Fine Foods and D&D Fine Foods in Chicago also stock Joanna's.
- The positive response inspired Joanna to open a commercial kitchen in Iowa City, "It's an exciting time," Mouming said. "We are just getting started, but it has been so wonderful to see the outpouring of support for the brand."

The Team

Joanna Mouming, Owner

Joanna is no stranger to the food industry. She worked at both Kalona SuperNatural and Frontier Herbs—two leaders in the food industry. During that time, she recalls having her palette tested. "I never knew there was a thing called a perfect palette," Mouming said. "But apparently mine is about as close as it comes. It's the reason I'm using the tagline, 'She has a way with ingredients.'

Our Mission

A self-professed foodie and entrepreneur, Joanna Mouming has spent more than a decade in the organic food industry. Today, this New York native, who has lived in Iowa for three decades, is launching her own brand: Joanna's Premium Tonic Syrups. The tonic syrups come in two flavors—Joanna's Original and Orange Fennel.

- “One day it occurred to me I was tired of drinking overly sweet gin and tonics,” said Mousing, who lives on a lifestyle farm featured in Dwell Magazine with 50 acres of restored prairie near Wellman, Iowa. “I realized there was no nuance to the tonics. Honestly, they just didn’t taste good.”
- That prompted Joanna to create her own tonic syrups from scratch using raw citrus juices, spices, real cinchona bark, and other natural ingredients. After perfecting the flavor, she started making the craft tonic syrups in a pot she calls ‘Big Betty’ and still uses today

Other Information on the Investment Process

- Investors may cancel an investment commitment until 48 hours prior to the Offering Deadline.
- MainVest will notify investors when and if the Target Offering Amount has been raised.
- If the Company reaches the Target Offering Amount before the Offering Deadline, it may close the offering early if it provides notice about the new Offering Deadline at least five business days before such new Offering Deadline, absent a material change that would require an extension of the offering and reconfirmation of the investment commitment.
- If an investor does not cancel an investment commitment before the 48-hour period before the Offering Deadline, the funds will be released to the Company upon closing of the offering and the investor will receive securities in exchange for his or her investment.

(K) Material Changes

In the event the issuer undergoes a material change, the Investor will be notified of such change. The investor will have five (5) business days from the receipt of such notice to reconfirm their investment. IF AN INVESTOR DOES NOT RECONFIRM HIS OR HER INVESTMENT COMMITMENT WITHIN FIVE (5) DAYS OF THE NOTICE OF MATERIAL CHANGE BEING SENT, THE INVESTOR'S INVESTMENT COMMITMENT WILL BE CANCELLED, THE COMMITTED FUNDS WILL BE RETURNED, AND THE INVESTOR WILL NOT BE ISSUED ANY OF THE SECURITIES REFERENCED IN THIS OFFERING.

Explanation

A “material change” means a change that an average, careful investor would want to know about before making an investment decision. If a material change occurs after you make an investment commitment but before the Offering closes, then the Company will notify you and ask whether you want to invest anyway. If you do not affirmatively choose to invest, then your commitment will be cancelled, your funds will be returned to you, and you will not receive any securities.

(L) Price of the Securities

The Company is offering “securities” in the form of revenue sharing notes, which we refer to as “Notes.” The Notes are being offered at their face amount. For example, you will pay \$1,000 for a Note with a face amount of \$1,000.

(M) Terms of the Securities

Overview

The Company is offering “securities” in the form of revenue sharing notes, which we refer to as the “Notes.” The Terms of the Notes are set forth in the Revenue Share Agreement accompanying this Form C in Appendix A. Copies of the Note and Revenue Sharing Agreement are attached to this Form C.

² The rate of revenue sharing is calculated on a linear scale with a minimum rate of 0.9% and a maximum rate of 1.8% and is rounded to the nearest 1/10th percent. The final rate is based on the amount raised and is calculated after the offering has successfully closed. As the amount raised in the offering increases, the rate of revenue sharing increases. For example, a hypothetical offering could result in the following revenue sharing percentages, depending on the amount raised:

³ To reward early participation, the investors who contribute the first \$20,000.0 raised in the offering will receive a 1.8x cap. Investors who contribute after \$20,000.0 has been raised in the offering will receive a 1.6x cap.

Your Right to Payments under the Note

Your right to payments under the Note is set forth in the Note, together with a separate document

called the Revenue Sharing Agreement. Copies of the Note and Revenue Sharing Agreement are attached to this Form C. Additionally, general terms are outlined below and in the Company's offering page.

Obligation to Contribute Capital

Once you pay for your Note, you will have no obligation to contribute more money to the Company, and you will not be personally obligated for any debts of the Company. However, under some circumstances you could be required by law to return some or all of a distribution you receive from the Company.

No Right to Transfer

You should plan to hold the Notes until maturity. The Notes will be illiquid (meaning you might not be able to sell them) for at least four reasons:

- The Revenue Sharing Agreement prohibits the sale or other transfer of Notes without the Company's consent.
- If you want to sell your Note the Company will have the first right of refusal to buy it, which could make it harder to find a buyer.
- Even if a sale were permitted, there is no ready market for Notes, as there would be for a publicly-traded stock.
- By law, for a period of one year you won't be allowed to transfer the Investor Shares except (i) to the Company itself, (ii) to an "accredited" investor, (iii) to a family or trust, or (iii) in a public offering of the Company's shares.

Security

The Notes are not secured by any assets of the Company or any assets of persons associated with the Company.

Modification of Terms of Notes

The terms of the Notes and the Revenue Sharing Agreement may be modified or amended with the consent of Investors holding 50% of the Notes, measured by the total amount outstanding under each Note.

Dilution of Rights

The Company has the right to create additional classes of securities, both equity securities and debt securities (e.g., other classes of promissory notes). Some of these additional classes of securities could have rights that are superior to those of the Notes. For example, the Company could issue promissory notes that are secured by specific property of the Company.

How the Exercise of Voting Rights Could Affect You

You will receive payments with respect to your Note only if the Company makes enough money to pay you, or, if the Company does not make enough money to pay you, if there is enough value in the collateral the Company pledged as security for the Notes.

The people with voting rights control the Company and make all the decisions about running its business. If they make good business decisions, it is more likely you will be paid. If they make poor business decisions, it is less likely you will be paid. For example, if they hire too many people and/or try to expand too quickly, the business could be harmed. The people with voting rights could also decide to file for bankruptcy protection, making it more difficult for you to be paid.

How the Notes are Being Valued

The Notes are being valued at their face value. We don't anticipate that we'll ever need to place a value on the Notes in the future.

(N) The Funding Portal

The Company is offering its securities through MainVest, Inc., which is a "Funding Portal" licensed by the Securities and Exchange Commission and FINRA. MainVest Inc.'s Central Index Key (CIK) number is 0001746059, their SEC File number is 007-00162, and their Central Registration Depository (CRD) number is 298384.

(O) Compensation of the Funding Portal

MainVest will be paid 6.0% of the final offering amount, upon the successful completion of the offering. MainVest does not receive compensation if the offering does not succeed. MainVest, Inc. owns no interest in the Company, directly or indirectly, and will not acquire an interest as part of the Offering, nor is there any arrangement for MainVest to acquire an interest.

- Had Cost of Goods Sold (COGS) of \$6060, which represented gross profit of \$40,403 in 2019.
- Had Cost of Goods Sold (COGS) of \$8291, which represented gross profit of \$56445 in 2020.
