The film industry is highly speculative and carries inherent risk. There is no way to predict how audiences will respond to the product.

Recently Organized Company. The Company was recently organized. There can be no assurance that the Company's business plans will prove successful, and there is no assurance that the Company will be able to operate profitably.

Declaration and Payment of Distributions; Future Distributions are not guaranteed. Payment of future distributions and the amounts thereof will be dependent upon the Company's earnings, financial requirements, and other factors. No assurances can be given that the Company will operate profitably or declare and pay any future distributions. Any future return on investment to investors will depend upon successful operation of the Company.

COVID 19: The world is still recovering from the COVID 19 pandemic and could still affect the production in negative ways. Including, scheduling, cast & crew availability, and locations.

The cast & crew are actively working in the entertainment industry and may be working on other projects during production.

Limited operating scope. The business of our company is based upon the development and monetization of a single film. Our company does not intend to engage in operations other than those relating to the production of such film. Accordingly, all of the business prospects of our company rely on the successful monetization of a single film. If such film is not successfully produced or is not popular with consumers and audiences, you may lose all of your investment.

An investment in our company is speculative. Investors hereby may not realize a return on their investment and could lose their investment. Investors should carefully review all materials provided in connection with the offering and these risk factors and consult with their attorneys, tax advisors, and/or business advisors prior to investing.

Ability and Willingness to Accept Risk. The financial success of the Company will depend upon factors beyond the control of the Company and its management, including without limitation, general economic conditions and a potential lack of a market for the Company's products and services, as well as upon the ability of the management team to successfully formulate and execute its business plan. We need a minimum of \$20K to complete pre-production through production of the film. If we cannot raise that amount in the Wefunder campaign, there is a risk that we cannot produce the film and therefore not generate future revenues.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect

on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

## Ownership and Capital Structure

### THE OFFERING

13. Describe the terms of the securities being offered.

The Company is offering a revenue participation agreement to Investors. See exact security attached as Appendix B, Investor Contracts.

**SHARE OF REVENUE.** Subject to the terms and conditions in the revenue share agreement, Net Proceeds (as defined below) shall be allocated in the following manner and order of priority:

First, if necessary, Production Company shall have the right to repay any first priority indebtedness and advances incurred by Company provided that such debt is used by Production Company towards the production of the Picture.

Second, Funder shall receive its proportionate share of one hundred percent (100%) of the Net Proceed on a pro rata, pari passu basis with other Funders, and any Additional Funders, if any, until Funder, all other Funders, and Additional Funders have recouped **one hundred and twenty percent (120%) of their investment**. For purposes of this Agreement, "Additional Funders" is defined as persons or entities that provide any additional funds required to produce and market the Picture, including, without limitation, equity funding, loans, advances, bonds, and guarantees.

Third, Funder shall receive its proportionate share of **fifty percent (50%)** of the Net Proceeds of the Picture on a pro rata, pari passu basis with other Funders and Additional Funders, if any.

**NET PROCEEDS.** As used herein, "Net Proceeds" shall mean any and all amounts actually received by Production Company from the exploitation of the Picture and/or elements thereof, and/or rights therein, in any and all manner and media,

now known or hereafter devised, worldwide, in perpetuity, after deduction of the following:

(a) third party sales agent fees;

(b) actual, third party, out of pocket amounts incurred by or on behalf of Production Company in connection with the sale, marketing, licensing, delivery, distribution and/or exploitation of the Picture;

(c) ongoing third party accounting and legal costs and expenses actually incurred by or on behalf of Production Company in connection with the processing of payments to profit participants (including, without limitation, collection agent fees and expenses), and audit costs;

(d) any deferred compensation and bonuses (including, without limitation, gross or net receipts participations, box office bonuses, award bonuses, and the like) payable to parties rendering services in connection with the Picture (to the extent not assumed by distributors of the Picture);

(e) any taxes actually paid by Production Company to a taxing authority; and

(f) any reasonable reserve amounts, as determined by Production Company in its good faith business judgment, required to cover anticipated future costs or liabilities.

#### **Voting Rights**

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

#### **Proxy to the Lead Investor**

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

#### **Restriction on Transferability**

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

The revenue share funding agreement contains the entire understanding of the Parties relating to the subject matter herein, and supersedes all other agreements between the Parties whether written or oral relating thereto, and may not be modified or amended except by written instrument executed by both of the parties hereto.

The securities being offered may not be transferred by any purchaser of such securities during the one year period beginning when the securities were issued, unless such securities are transferred:

1. to the issuer;

4. to a member of the family of the purchaser or the equivalent, to a trust controlled by the purchaser, to a trust created for the benefit of a member of the family of the purchaser or the equivalent, or in connection with the death or divorce of the

purchaser or other similar circumstance.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

Because the Investor holds no voting rights in the company, the holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering). These decisions could affect gross revenues and diminish payments made to Investors.

Based on the risk that the company may never realize revenues or face a Default Event, the Investor may never see any returns.

Additional risks related to the rights of other security holders are discussed below, in Question 20.

19. Are there any differences not reflected above between the securities being offered and each other class of security of the issuer?

There are no shares issued in this offering. This is a Funding Agreement. For more information please review the Offering Details Document.

As a holder of a Funding Agreement you will have no voting rights, and limited ability, if at all, to influence out policies or any other corporate matter, including the election of directors, changes to the Company's governance documents, additional issuances of securities, company repurchases of securities, a sale of the Company or of assets of the Company, or transactions with related parties.

20. How could the exercise of rights held by the principal shareholders identified in Question 6 above affect the purchasers of the securities being offered?

As holders of a majority-in-interest of voting rights in the Company, **the unitholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the unitholders** may change the terms of the operating agreement for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The unitholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

**The unitholders** have the right to redeem their securities at any time. **Unitholders** could decide to force the Company to redeem their **securities** at a time that is not

favorable to the Investor and is damaging to the Company. Investors' exit may affect the value of the Company and/or its viability.

In cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. In addition, as discussed above, if a majority-in-interest of holders of securities with voting rights cause the Company to issue additional units, an Investor's interest will typically also be diluted.

The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

Our company was organized in May 2021 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Assets.* As of June 21, 2021, the Company had total assets of \$0, including \$0 in cash.

Our intent is to be profitable in 18 months.

There are no material changes or trends in our finances or operations since the date of our financials cover.

Over the next 3-6 months we will spend the entirety of the funds raised (\$20K-\$50K) from the Wefunder on Production of the film. We will not complete post-production within 6 months, so we will not begin generating revenue from the film in that time period. We need a minimum of \$20K in order to complete pre-production through production of the film. An additional \$25K-\$30K would cover the labor cost of finishing the film as well as funds for advertising and film festival.

We expect production to run from Sept - Oct 2021. Post Production is intended to run through late Spring/early Summer 2022. Then there will be showings in film festivals, which can span between 6-12 months following post production, depending on results. Our main revenue goal is to get our investors back their investment, whether that's through a sale of the film or a form of online self-distribution. These are forward looking projections and are not guaranteed.

The co-owners of the company have already covered startup cost and are prepared to invest more of their own capital earned from other projects into the film Forever Home.
