We have not yet generated any revenue. The Company's ability to continue until such time as the Company is able to generate revenue is dependent upon its ability to obtain sufficient capital financing from investors in order to pay any and all operating expenses.

Although we've been working on this project since November 2020, Cycle Phones, Inc. was not incorporated until June 2021. It is a relatively new company, with no history upon which an evaluation of its past performance and future prospects can be made.

It is possible we are too early, and the wireless data technology is not quite ready to support a good user experience on Cycle.

It is possible server failures could result in losing user data, or failing to provide service for a certain period of time that could cause excessive amounts of customers to leave our service. Similar to the server failure Blackberry experienced in 2012.

Our initial release on mobile app stores (Apple and Google Play) will require approval from third party companies. If we cannot get approval for any reason, it could delay or change launch plans significantly.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

## The Offering

### USE OF FUNDS

9. What is the purpose of this offering?

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$50,000**

Use of Proceeds: At this stage of funding, we will focus solely on developing a mobile app that will demonstrate our minimum viable product (MVP) and provide service to our first users. The funding allocation is roughly laid out below:

15% for salaries for a new developer.

55% for salaries for the current 4 full time team members.

14% for incidentals such as legal costs, rent, electricity, internet, etc.

8.5% to cover server costs, likely used servers or rented AWS servers.

7.5% to pay Wefunder's fees.

If we raise: **\$200,000**

Use of Proceeds: This stage is similar to the minimum stage, except we will have more

Proceeds: This stage is similar to the minimum stage, except we will have more capital for advertising and developing our server infrastructure. See the breakdown below:

27% for salaries for 2-3 new developers.

25.5% for a marketing campaign, to help reach more users once the product launches.

15% for salaries for the current 4 full time team members.

13% to cover server costs, likely used servers or rented AWS servers.

12% for incidentals such as legal costs, rent, electricity, internet, etc.

7.5% to pay Wefunder's fees.

If we raise: **\$300,000**

Use of Proceeds: This tier of funding will include everything previously, plus an effort to create a custom lightweight OS for Android phones. This will give users a more integrated and feature-complete experience with our MVP.

45% for salaries for 4-6 new developers.

20% for a marketing campaign, to help reach more users once the product launches.

10% for salaries for the current 4 full time team members.

9.5% to cover server costs, likely used servers or rented AWS servers.

8% for incidentals such as legal costs, rent, electricity, internet, etc.

7.5% to pay Wefunder's fees.

If we raise: **\$650,000**

Use of Proceeds: At this level of funding, we will design and begin manufacturing our own hardware, as well as the other targets listed before. There will likely need to be a second raise to fund manufacturing of the device at scale once the prototype is suitable. The cost breakdown can be found below:

43.5% for designing, prototyping, and developing the first few units of our custom lightweight device. This may involve hiring 1-2 hardware specialists.

25% for salaries for 5-6 new developers.

10% for a marketing campaign, to help reach more users once the product launches.

7.5% to pay Wefunder's fees.

5% for salaries for the current 4 full time team members.

5% to cover server costs, likely used servers or rented AWS servers.

4% for incidentals such as legal costs, rent, electricity, internet, etc.

If we raise: **\$800,000**

Use of Proceeds: This tier includes all the goals in the lower tiers, but we will also focus on providing users an all-inclusive experience where the phone will come an unlimited data plan. The objective is to provide a painless and economical computing experience. The breakdown can be found below:

35% for designing, prototyping, and developing the first few units of our custom lightweight device. This may involve hiring 1-2 hardware specialists.

20% for salaries for 5-6 new developers.

16.5% for securing a bulk data plan with a telecommunication carrier, and providing this service to our first users.

8% for a marketing campaign, to help reach more users once the product launches.

7.5% to pay Wefunder's fees.

5% to cover server costs, likely used servers or rented AWS servers.

4.5% for salaries for the current 4 full time team members.

3.5% for incidentals such as legal costs, rent, electricity, internet, etc.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

## Ownership and Capital Structure

### THE OFFERING

13. Describe the terms of the securities being offered.

To view a copy of the SAFE you will purchase, please see [Appendix B, Investor Contracts](#). The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **preferred stock** in the Company ("**Preferred Stock**"),

when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

*Conversion to Preferred Equity.* Based on our SAFEs, when we engage in an offering of equity interests involving **preferred stock**, **Investors will receive a number of shares of preferred stock** calculated using the method that results in the greater number of **preferred stock**:

1. the total value of the Investor's investment, divided by
  1. the price of **preferred stock** issued to new Investors multiplied by
  2. the **discount rate** (90%), or
2. if the valuation for the company is more than **\$3,650,000** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
  1. the Valuation Cap divided by
  2. the total amount of the Company's capitalization at that time.
3. for investors up to the first **\$100,000** of the securities, investors will receive a valuation cap of **\$3,100,000** and a discount rate of 90%.

*Additional Terms of the Valuation Cap.* For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

*Liquidity Events.* If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **preferred stock**, Investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

*Liquidity Priority.* In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
2. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
3. Senior to payments for Common Stock.

#### **Securities Issued by the SPV**

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

#### **Voting Rights**

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

#### **Proxy to the Lead Investor**

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If

the Proxy is not revoked within the 5-day time period, it shall remain in effect.

**Restriction on Transferability**

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

Any provision of this Safe may be amended, waived or modified by written consent of the Company and either:

- ii. the majority-in-interest of all then-outstanding Safes with the same "Post-Money Valuation Cap" and "Discount Rate" as this Safe (and Safes lacking one or both of such terms will be considered to be the same with respect to such term(s)), provided that with respect to clause (ii):
  - A. the Purchase Amount may not be amended, waived or modified in this manner,
  - B. the consent of the Investor and each holder of such Safes must be solicited (even if not obtained), and
  - C. such amendment, waiver or modification treats all such holders in the same manner. "Majority-in-interest" refers to the holders of the applicable group of Safes whose Safes have a total Purchase Amount greater than 50% of the total Purchase Amount of all of such applicable group of Safes.

Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal, Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor:

- A. Wefunder Portal may amend the terms of an investment contract, provided that the amended terms are more favorable to the investor than the original terms; and
- B. Wefunder Portal may reduce the amount of an investor's investment if the reason for the reduction is that the Company's offering is oversubscribed.

Our intent is to be profitable in 24 months.

If the Proxy is not revoked during this 5-day period, it will remain in effect.

**Tax Filings.** In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the Investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN.
