We operate in an open, fast paced, and competitive market and our future success will be largely dependent on our ability to continue to execute consistently and quickly as possible with good structure and organization.

To succeed and keep our clients and customers happy with our platform we must be consistently addressing and improving any users issues and implementing quality suggestions.

We are an early stage company and have limited revenue and operating history. Any valuation at this stage is difficult to assess.

The Company might not sell enough securities in this offering to meet its operating needs and fulfill its plans, in which case the Company might need to reduce sales & marketing, or other expenses.

If the Company is successful, the Company will certainly have to obtain further additional capital beyond the foregoing to expand reach. As such, it is absolutely certain that the Company will need additional financing. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. Investors in the first \$75,000.00 of the offering will receive units at a price per share of \$0.40, and a pre-money valuation of \$4,016,000.00

The campaign maximum is \$250,000.00 and the campaign minimum is \$50,000.00.

#### Securities issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

#### Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

#### Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

#### Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

The Preferred Units have ten million (10,000,000) authorized units, however, only 537,500 units are authorized for this offering. Preferred units, as authorized, allow the Board of Managers to designate a new series without the consent of the members. The Series A Preferred Units have been designated and are the equity units available at this offering. In the future, the Board may create new series that are senior to or on parity with Series A Preferred Units.

The P-units are profits interests that would be issued for services.

Preferred Units have 1x liquidation priority over Common and P-units.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

The Company may issue other units of the Company without the consent of the holders of the Series A Units. These other units may be senior to or on parity with the Series A Preferred Units. This means that these senior units might have a liquidation preference or other right to distributions before distributions can be made to the holders of the Series A Preferred Units. These other units might also have redemption rights, which would allow the holder to be cashed out before the holders of Series A Preferred Units, or they might have voting rights that allow the holders of the other units to veto major corporate transactions.

20. How could the exercise of rights held by the principal shareholders identified in Question 6 above affect the purchasers of the securities being offered?

As holders of a majority-in-interest of voting rights in the Company, the unitholders may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, the unitholders may change the terms of the Operating Agreement for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. The unitholders may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns. The unitholders have the right to redeem their securities at any time. Unitholders could decide to force the Company to redeem their securities at a time that is not favorable to the Investor and is damaging to the Company. Investors' exit may affect the value of the Company and/or its viability. The Largest one-stop Virtual Video Meeting Platform on the planet connecting clients and fans to Celebrities and Professionals virtually.

Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future, if any.

#### Milestones

MeetEm, LLC was incorporated in the State of South Carolina in December 2017. Previously to December 2020, we were organized from MeetEm, Inc.

Since then, we have:

- Our encrypted video technology is developed, tested, and 100% market ready
- No apps or software to download; we're an advanced virtual & encrypted browser-based technology
- No monthly fees to users; Talent receives above-market 70% daily payouts
- Optimized for all mobile devices, laptops, desktops, and iPads
- Seasoned & talented executive and tech team
- \$880B industry; aspire to be the Netflix & iTunes for browsing & booking video meetings

#### Historical Results of Operations

Our company was organized in December 2017 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2020, the Company had revenues of \$0 compared to the year ended December 31, 2019, when the Company had revenues of \$0. Our gross margin was % in fiscal year 2020, compared to % in 2019.
- *Assets.* As of December 31, 2020, the Company had total assets of \$2,700, including \$73.97 in cash. As of December 31, 2019, the Company had \$3,600 in total assets, including \$0 in cash.
- *Net Loss.* The Company has had net losses of \$19,025.50 and net losses of \$38,131.74 for the fiscal years ended December 31, 2020 and December 31, 2019, respectively.
- *Liabilities.* The Company's liabilities totaled \$0 for the fiscal year ended December 31, 2020 and \$0 for the fiscal year ended December 31, 2019.

#### Liquidity & Capital Resources

To date, the company has been financed with \$115,556 in capital contributions by the founder.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### Runway & Short/Mid Term Expenses

MeetEm, LLC cash in hand is \$8,031, as of September 2021. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$9,873/month, for an average burn rate of \$9,873 per month. Our intent is to be profitable in 6 months by working with talent agencies to onboard at least 500 people from their roster booking 10 virtual meeting monthly at an average of \$100 each.

Since the date our financials cover, we converted from a C Corp to an LLC. Also, we are currently onboarding talent to the platform, continuing platform developments, hosting, software maintenance and preparing marketing and promotion videos.

In the next 6 months, we expect our expenses to total \$20,136 and our revenues to total \$250K. Our revenue projections are based on the assumption that we can onboard 250 new individual "talents" to the platform and each of them hosts 10 MeetEm's per month at an average of \$100 each. Forward looking projections cannot be guaranteed.

Outside of funds raised in this offering, the founder will continue to provide operating capital if needed to cover short term burn while fundraising.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such a circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.
