Brandon Jantz is the only full time employee at Temecula FC. As such, it is likely that the company will not make the same progress as if that were not the case.

The professional, pre-professional, and youth athletics market in Southern California is incredibly competitive, and the club will compete for attendance, viewership and advertising revenue with a wide range of other entertainment and recreational activities available to potential consumers. There can be no assurance that the club will be able to compete effectively, including with companies that may have greater resources than it. There is a risk that the club will struggle some years and financially and not return a profit for their investors that year.

The ongoing COVID-19 pandemic poses significant risks to competitive athletics, including the risk of actions that may be taken by government authorities to contain the outbreak, including the imposition of limitations on fan attendance and potential shutdowns and the lost revenues associated therewith.

The risk of the NISA Nation league its self failing in coming years which would force Temecula FC to look into other league options for our minor league team.

The unknown added expenses due to possible inflation over the next few years that could cut into our budget/profits.

Another group that comes in and plans to develop a team in the Temecula area that could take away some fans or players.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

We'll also 22.5% funds for new marketing to grow our youth club. Investment from community will also ensure we are on strong financial footing, not just now, but into the future.

If we raise: **\$124,000**

Use of Proceeds: 7.5% Wefunder intermediary fee, we'll use 42.5% of the funds for normal business operation (including the costs and expenses of this offering) as we gear up for the 2023 season. We'll also use 25% funds for new marketing to grow our youth club. Investment from community will also ensure we are on strong financial footing, not just now, but into the future. We will also put 25% aside and explore the options of purchasing land in and around Temecula Wine Country for a small stadium/event center which will include wine/beer/music and other events.

The Investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, will appoint XX Team LLC ("XX Team") as the Investor's true and lawful proxy and attorney (the "Proxy"), with the power to act alone and with full power of substitution, on behalf of the Investor to:

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. 20. How could the exercise of rights held by the principal shareholders identified in Question 6 above affect the purchasers of the securities being offered?

As holders of a majority-in-interest of voting rights in the Company, **the unitholders** may make decisions with which the Investor disagrees. or that

negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the unitholders** may change the terms of the Operating Agreement for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The unitholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

In the future, we will perform valuations of our common unit that take into account factors such as the following:

1. unrelated third party valuations of our common unit;
2. the price at which we sell other securities, such as convertible debt or preferred Unit, in light of the rights, preferences and privileges of our those securities relative to those of our common unit;
3. our results of operations, financial position and capital resources;
4. current business conditions and projections;
5. the lack of marketability of our common unit;
6. the hiring of key personnel and the experience of our management;
7. the introduction of new products;
8. the risk inherent in the development and expansion of our products;
9. our stage of development and material risks related to our business;
10. the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;
11. industry trends and competitive environment;
12. trends in consumer spending, including consumer confidence;
13. overall economic indicators, including gross domestic product, employment, inflation and interest rates; and

We will analyze factors such as those described above using a combination of financial and market based methodologies to determine our business enterprise

financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

22. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

An Investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the Investor. The Company will be managed by its officers and be governed in accordance with the strategic direction and decision-making of its Management, and the Investor will have no independent right to name or remove an officer or member of the Management of the Company.

Following the Investor's investment in the Company, the Company may sell interests to additional investors, which will dilute the percentage interest of the Investor in the Company. The Investor may have the opportunity to increase its investment in the Company in such a transaction, but such opportunity cannot be assured.

The amount of additional financing needed by the Company, if any, will depend upon the maturity and objectives of the Company. The declining of an opportunity or the inability of the Investor to make a follow-on investment, or the lack of an opportunity to make such a follow-on investment, may result in substantial dilution of the Investor's interest in the Company.

Additional issuances of securities. - *Revenues & Gross Margin.* For the period ended December 31, 2022, the Company had revenues of \$124,030 compared to the year ended December 31, 2021, when the Company had revenues of \$83,000.86. Our gross margin was 93.01% in fiscal year 2022, compared to 95.83% in 2021.
- *Assets.* As of December 31, 2022, the Company had total assets of \$41,393.35, including \$5,748.14 in cash. As of December 31, 2021, the Company had \$22,610.59 in total assets, including \$1,608.36 in cash.
- *Net Income.* The Company has had net income of \$18,997.35 and net income of \$1,608.36 for the fiscal years ended December 31, 2022 and December 31, 2021, respectively.
- *Liabilities.* The Company's liabilities totaled \$0 for the fiscal year ended December 31, 2022 and \$0 for the fiscal year ended December 31, 2021.

Liquidity & Capital Resources

To-date, the Company has been financed with \$72,800 in founder-contributed capital.

After the conclusion of this Offering, should we hit our minimum funding target, we are projecting to be profitable and maintain an indefinite runway.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 12 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. Runway & Short/Mid Term Expenses

Temecula Football Club LLC cash in hand is \$10,243, as of August 2023. Over the last three months, revenues have averaged \$11,000/month, cost of goods sold has averaged \$750/month, and operational expenses have averaged \$8,000/month, for an average net margin of \$2,250 per month.

We have not had any material changes or trends in our finances or operation since the date that our financials cover.

Expenses over the next 6 months will be around \$35,000 to operate our NISA Nation team and youth club. We expect our revenue to be around \$82,000.

Temecula Football Club is currently profitable and expects to expand and grow over the next 3-6 months at the youth level and our ticket and merchandise sales.

Outside of funds raised on Wefunder, the company has no additional sources of funding with which to cover short term burn (if there is any).
