Even though we created and pioneered functional gummy space, competitions in functional gummy space are popping up and catching up. If we don't move fast and grow fast, we could be out-paced by later comers.

Our functional gummy business is going into an exponential growth stage, which significantly increases the cash flow needs. If we don't raise enough funding in time, the growth and survial of the company could be significantly crippled.

The growth of our functional gummy business is putting pressure on production as well as supply chains. Currently pandemic continues to negative impact supply chains, which could negatively impact our ability to meet the demands.

Even though the gummy medicine pipeline is going exceptionally well, FDA regulatory process is inherently risky and unpredictable.

We have received the world's first Investigational Drug Application (IND) approval from FDA. Even though the approved clinical trial is a straightforward bioavailability study, human biological system is inherently unpredictable and the clinical trial result may trigger additional requirements from FDA.

Many of our platform technologies are protected by a large portfolio of patent filings. These patent filings are currently pending in different countries including US, China and European countries. The patent prosecution process can be unpredictable and the allowances of these patent filings are not guranteed.

Nutraceutical and pharmaceutical products are both highly regulated by government agencies including FDA. The path of go-to -market is long, unpredictable and risky. The approval, success launch and continued commercialization of these products are not guaranteed.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

No dividends shall be paid on the Common Stock prior to the full payment of the dividends set forth above. For any additional dividends, the holders of Preferred Stock shall participate pro-rata with the Common Stock on an asconverted basis.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Dividend Provisions: Noncumulative dividends of 4% per annum, payable as, if and when declared by the Board. No dividends shall be paid on the Common Stock prior to the full payment of the dividends set forth above. For any additional dividends, the holders of Preferred Stock shall participate pro-rata with the Common Stock on an asconverted basis.

Liquidation Preference: In the event of any liquidation or winding up of the Company, or any Deemed Liquidation Event (defined below), prior to and in preference to any other payments to holders of the Common Stock (defined below), the holders of Series A Preferred Stock shall be entitled to receive an amount equal to the applicable original purchase price per share of Series B Preferred (as adjusted for stock splits, stock dividends, recapitalizations, etc.) plus the amount of all declared but unpaid dividends on each share of Preferred Stock, which shall be distributed ratably among the holders of Series B Preferred on a, pari passu basis, and in proportion to the full preferential amount each holder of Series B Preferred is entitled to pursuant to this liquidation preference (the "Series B Liquidation Preference").

The balance of any proceeds shall be distributed pro rata to holders of Common Stock.

A merger or consolidation (other than one in which stockholders of the Company own a majority by voting power of the outstanding shares of the surviving or acquiring corporation) and a sale, lease, transfer, exclusive license or other disposition of all or substantially all of the assets of the Company will be treated as a liquidation event (a "Deemed Liquidation Event"), thereby triggering payment of the liquidation preferences described above unless the holders of a majority of the Preferred Stock elect otherwise.

Antidilution Provisions:

- (1) Adjustments. The conversion price of each series of Preferred Stock shall be subject to adjustment, on a broad-based weighted average basis, to prevent dilution in the event that the Company issues additional shares at a purchase price per share less than the then current applicable Conversion Price.
- Exceptions. There will be no adjustment to the Conversion Price of the Preferred Stock for issuances of (i) shares of Series B Preferred issued at the Initial Closing, or any subsequent closings thereafter, (ii) shares of Common Stock issued upon conversion of Preferred Stock, (iii) shares of Common Stock or options issued to employees, consultants or directors in accordance with plans approved by the Board, (iv) shares issued upon exercise of options or warrants existing on the Closing Date, (v) shares of Common Stock issued as a dividend or distribution on Preferred Stock, (vi) shares of Common issued in a Qualified Public Offering, (vii) shares of Common Stock issued or issuable pursuant to an acquisition of another corporation by the Company provided such acquisition is approved by the Board, (viii) shares issued or issuable pursuant to equipment lease and bank financing arrangements approved by the Board, (ix) shares issued in transactions of primarily a strategic not financial nature, as determined by the Board, (x) shares of Common Stock issued to suppliers of goods or services pursuant to transactions approved by the Board; or (xi) shares of Common Stock that are otherwise excluded by vote or written consent of holders of at least a majority of Preferred Stock (the foregoing issuances described in subsections (i) through (xi) shall be referred to as the "Exempted Issuances").

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements

governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. Our gummy medicines could significantly improve medication efficiency and patients' compliance.

In five years, with our first gummy medicine expected to hit the market in the next 12-18 months, we hope to make gummy medicine a standard treatment in 5 years. We want to be the next biggest thing coming out of Seattle. Projections cannot be guaranteed.

Runway & Short/Mid Term Expenses

Seattle Gummy Company cash in hand is \$2,243,690, as of January 2022. Over the last three months, revenues have averaged \$137,336.88/month, cost of goods sold has averaged \$47,001.73/month, and operational expenses have averaged \$113,417.80/month, for an average burn rate of \$23,082.65 per month. Our intent is to be profitable in 12 months.

Since June 30th 2021, we have made significant progress selling into commercial channels including national roll-out of the products with two largest natural food distributors in US. We have added several hundred additional points of sales. We are in the process of adding 10 additional brokers covering most of the US states.

On functional gummies, we have launched market testing on two additional wellness products -- ACV Shots (Apple Cider Vinegar Gummies) and Slumber Shots (sleep-aids gummies), both are sugar free. The initial market testing feedbacks on both products have been extremely positive especially on the efficacy of Slumber Shots on promoting the sleep.

To ensure we can meet the growing demands, we have signed a Letter of Intent leasing a new site with a total square footage of more than 14,000 with the intention of adding and expanding manufacturing and warehousing capacities.

On the R&D front, we have signed a three-year Master Service Agreement on R&D collaboration with a Fortune 500 consumer product company.

On pharmaceutical front, we are in discussion of a potential joint venture partnership with a large pharmaceutical company.

In the next 3-6 months, we expect our expense to be averaging at \$130,000 per month; and our revenue to be average at \$150,000 per month. We expect to be profitable in 2023.


