There is risk our club falls short of capital raise goals, as well as revenues fall short of expectations which could jeopardize the club being able to play professional soccer past the 2022 season. The club can fall back to participate in an amateur league as part of a longer term strategy if revenues fall short of projections as well as capital raise efforts.

While the club has up to four full time employees, the owners and others who are managing the team are not full-time which means there is risk that founders may leave the company or become unable to operate the company

Due to operating under strict expense budgets, the club is operating with

limited initial marketing budgets placing a reliance on third party platforms for distribution, marketing, or development  
Social media

There is always a risk that projected revenue forecasts may not be achieved, therefore revenue models may be changed based on assumptions, and cannot predict unexpected circumstances.

Investors may not see a return ever or until an acquisition, or profitability  
Dividends are paid at company's discretion, but not anticipated

The lingering Covid 19 pandemic could still have a negative impact on attendance as this crisis is ever evolving and changing. NY State has historically been one of the most restrictive states related to live events during spikes in Covid cases.

Flower City Union will be operating in the downtown soccer stadium owned by the city of Rochester. The club is a tenant and not the operator of the stadium, which means the club will have limited control over stadium availability, stadium maintenance as well as stadium cleanliness and event readiness. There are also some people who feel the stadium is located in a dangerous part of town, which prevents some fans from attending events at the stadium location

One of the clubs business strategies is to be able to fall back into an amateur league if the revenues fall short of projections to cover annual professional operating NISA expenses to meet professional league standards. Flower City Union could fall back into an amateur league for one or many seasons, which would affect the valuation of the club as a whole, again if revenue projections are not met.

The club annual operating budget projects an annual loss, losses however should reduce year over year. Therefore, the club will be dependent on attracting investors to help cover the anticipated annual losses, while revenue generation will remain an ongoing priority as well. Asset value escalation is anticipated as well, the 2026 World Cup is returning to North America where pro soccer club asset values is expected to be at an all time high.

Minor league soccer clubs also depend on human resources, especially being able to hire key full time employees to generate revenue. The current expense model doesn't afford the club to hire the appropriate number of FT staff to drive necessary revenue. Investing in revenue generation positions will be a priority as more revenue and capital is brought into the organization

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Mark Washo is a part-time officer, acting as Managing Director. As such, it is likely that the company will not make the same progress as it would if that were not the case.

Flower City Union Holdings Inc. is offering up to 100,000 shares of stocks, at a price per share of \$2.50.

The campaign maximum is \$250,000.00 and the campaign minimum is \$50,000.00.

#### **Securities Issued by the SPV**

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

#### **Voting Rights**

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

#### **Proxy to the Lead Investor**

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by

Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor (“Replacement Lead Investor”) takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

**Restriction on Transferability**

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

*Preferred shares has liquidation preference over common stock shares.*

**Liquidation Preference.** In the event of any voluntary or involuntary liquidation, dissolution or winding up of the affairs of the club, the holders of shares of Preferred Stock then issued shall be entitled to be paid out of the assets of the company available for distribution to its shareholders an amount in cash equal to the Liquidation Value for each share outstanding based on asset sales price, less annual business operating costs, taking annual losses into consideration. Preferred stock shall have liquidation preference over company issued founder common shares and Class B common stock. The preferred stock share price should a liquidation event occur will be determined by final board of directors vote, based on final club sale price, taking club acquisition costs, operating costs and annual losses into consideration to determine final share price for preferred stock holders. If the assets of the Association are not sufficient to pay in full the liquidation payments payable to the holders of outstanding shares of the Preferred Stock, investors may not recover the full amount of initial investment.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no

guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. Our company was organized in September 2021 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2021, the Company had revenues of \$21,195.49. Our gross margin was 97.51%.
- *Assets.* As of December 31, 2021, the Company had total assets of \$142,734.24, including \$29,107.24 in cash.
- *Net Loss.* The Company has had net losses of \$68,352.46 for 2021.

- *Liabilities*. The Company's liabilities totaled \$1,086.70 for 2021.

#### **Liquidity & Capital Resources**

To-date, the company has been financed with \$380,000 in equity.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### **Runway & Short/Mid Term Expenses**

Flower City Union Holdings Inc. cash in hand is \$9,500, as of May 2022. Over the last three months, revenues have averaged \$15,000/month, cost of goods sold has averaged \$2,000/month, and operational expenses have averaged \$30,000/month, for an average burn rate of \$17,000 per month. Our intent is to be profitable in 60 months.

No material changes have occurred in our financials and operations since the date our financials cover.

Our revenues should increase in the next 3 to 6 months, with improved weather and general awareness of the club increasing. When ticket sales revenue increases, other revenue increases as well such as merchandise and individual Suite sales. We anticipate they will increase to \$30-\$40 K per month. Expenses are expected to remain the same, at \$30,000/month.

The club is not currently profitable, nor do the projections contemplate profitability for at least 3 to 5 years. The Club will need to raise a total of approximately \$2.3MM to reach a point of profitability.

Outside of funds raised on Wefunder, our main capital comes from our current primary club owner. Our second source of capital is through organic club revenues which includes ticket sales, sponsorship sales, merchandise sales and broadcasting advertising. We are also seeking investment from early stage investors, several have participated outside the Wefunder platform already.
