8. Discuss the material factors that make an investment in the issuer speculative or risky:

We are not in a contract with any of our stores or accounts, so there is a risk that they drop us and we lose their revenue, causing us not to hit our projections.

We are low on cash and have been burning between \$30,000 and \$45,000 per month. We will continue to burn cash until we increase sales to cover expenses.

We may not be able to raise the full \$1M we are seeking between our public and private raises, which may slow progress on our sales projections.

Risk of an inability to hire enough staff: if we are not able to raise the full \$1M we are seeking between our public and private raises given the economic downturn, this may slow progress on our sales projections.

Risk of climate change: our Regenerative Organic Certified farms should be hardy against climate change, but if drought is bad enough, or wildfire occurs, or niche supply chain could be disrupted and we'd have to transition to regular organic sources.

The Company is a California Corporation that is federally taxed as an S-Corp. As such, the Company will be legally required to change their federal tax status to a C-Corp in the future upon a qualified financing round (as described in the convertible note) in order for the securities in this offering to convert to stock in the Company. Should the Company not convert to C-Corp tax status in the future upon a qualified financing round, convertible notes purchased in this Reg CF will not convert to equity. That said, as described in the terms of the notes, investors will still be entitled to receiving their investment back plus interest.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Jared Lovenduski is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.

the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

Interest Rate: 5.5%. Interest shall commence with the date of the convertible note and shall continue on the outstanding principal amount until paid in full or converted. Interest shall be computed on the basis of a year of 365 days for the actual number of days elapsed. All unpaid interest and principal shall be due and payable upon request of the Majority Holders on or after the Maturity Date.

Conversion and Repayment

Conversion. In the event Payor issues and sells Equity Securities to investors (the “Investors”) before December 31, 2028 (the “Maturity Date”), in an equity financing in which Payor raises at least five hundred thousand dollars (\$500,000) in gross proceeds (excluding the amount of any promissory notes being converted) with the principal purpose of raising capital (a “Qualified Financing”), upon agreement of both parties, the outstanding principal balance of this Note, together with any accrued but unpaid interest thereon, will convert into Equity Securities at the Conversion Price. Other than the purchase price, this Note shall convert into Equity Securities on the same terms and conditions given to the Investors in the Qualified Financing. Notwithstanding the foregoing, if the conversion price of the Notes is less than the cash price per share sold in the Qualified Financing, the Payor may, solely at its option, elect to convert the Notes into shares of a newly created series of capital stock having the identical rights, privileges, preferences, and restrictions as the preferred stock issued in the Qualified Financing, and otherwise on the same terms and conditions, other than with respect to (if applicable): (i) the per share liquidation preference and the conversion price for purposes of price-based anti-dilution protection, which will equal the conversion price; and (ii) the per share dividend, which will be the same percentage of the conversion price as applied to determine the per share dividends of new investors in the Qualified Financing relative to the purchase price paid by such investors. No fractional shares shall be issued upon conversion of this Note. In lieu of any fractional shares to which Holder would otherwise be entitled, the number of shares issuable shall be rounded down to the next whole number and Payor shall, in lieu of issuance of any fractional share, pay to Holder a sum in cash equal to the value of such fractional share based on the Conversion Price.

Change of Control. In the event of a Change of Control, Holder shall elect one of the following:

- (1) payment of all outstanding principal and interest upon the closing of such transaction;
- (2) conversion of this Note into the shares of stock and other securities, cash, or property receivable upon or deemed to be held by holders of Common Stock following such transaction.

Maturity. If no Qualified Financing has occurred before the Maturity Date, then within 30 days after the Maturity Date, the Payor shall repay all principal and any accrued but unpaid interest under the Note.

Prepayment. The principal amount under the Note may not be prepaid without the consent of Holder. Payor shall have the absolute right to prepay accrued interest at any time during the term of the Note.

Most Favored Investor

In the event the Payor calls or issues any convertible

in the event the Payor sells or issues any convertible instruments (other than the issuance of stock options to service providers of the Payor) at any time prior to the conversion of the Note, the Payor shall provide the Holder with written notice of such sale or issuance. In the event the Holder determines, in its sole and absolute discretion, that such instrument contains terms more favorable to the Holder than the terms of the Note, the Holder may elect to exchange the Note for such instrument.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. While the Issuer may be required to pay an annual administrative fee for the maintenance of the SPV, investors should note the Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument

and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

Upon the effectuation of such waiver or amendment with the consent of the Majority Holders in conformance with this paragraph, such amendment or waiver shall be effective as to, and binding against the holders of, all of the Notes, and the Company shall promptly give written notice thereof to the Holder if the Holder has not previously consented to such amendment or waiver in writing; provided that the failure to give such notice shall not affect the validity of such amendment or waiver.

Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal, Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor:

- A. Wefunder Portal may amend the terms of an investment contract, provided that the amended terms are more favorable to the investor than the original terms; and

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering). These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents. To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the articles of incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the

Company's securities in a way that negatively affects the value of the securities the Investor owns. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

The shareholders have the right to redeem their securities at any time. **Shareholders** could decide to force the Company to redeem their **securities** at a time that is not favorable to the Investor and is damaging to the Company. In addition, as discussed above, if a majority-in-interest of holders of securities with voting rights cause the Company to issue additional stock, an Investor's interest will typically also be diluted.

Liquidity & Capital Resources

To-date, the company has been financed with \$834,666 in debt, \$428,352 in convertibles, and \$635,000 in CARE Notes.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 18 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 18 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

The Philosopher's Stoneground, Inc DBA Philosopher Foods cash in hand is \$69,050.84, as of February 2025. Over the last three months, revenues have averaged \$122,359/month, cost of goods sold has averaged \$36,909/month, and operational expenses have averaged \$106,401/month, for an average burn rate of \$20,951 per month. Our intent is to be profitable in 9 months.

Since the date of our financials, our sales went up - we just had our best month of sales ever in January 2025 at \$150,022.72. We also brought in more investment - \$59,000.

We expect to scale to \$1.5M in revenue by 6 months from now, while incurring approximately \$1.3M in operating expenses and COGS. We're aiming to cross \$3M in revenue and break even this year.

We are not yet profitable. We anticipate that raising another \$250,000 - \$500,000 will get us to breakeven by the end of this year. We have a growth hypothesis with more details.

For additional sources of capital outside of this offering, we have debt from the SBA, which we intend to increase with another \$68,000 SBA Bolt Loan in the next month or two. We also have a \$150,000 private low interest line of credit in the works with Cienega Capital.

The Lead Investor. As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.
