8. Discuss the material factors that make an investment in the issuer speculative or risky:

Slower than expected EV adoption could be a risk for Lectrium, delaying our success and impacting the time it takes for Lectrium to return capital to shareholders. This can come from consumers in the USA not purchasing EVs or from OEMs not being able to produce them quickly enough to meet demand.

We operate in the highly competitive EV charging market and our future success will be largely dependent on our ability to provide quality products and services at competitive prices. We face competition from OEMs as well as other charger platforms. Consumers have many choices around which hardware they would like to put in their homes. We also compete with public charging stations, and with level 1 charging. Other competitive forces include established European brands coming to the USA and trying to gain market share here.

Lectrium needs a team of highly skilled and dedicated founders and employees to compete and deliver the highest service. Should Lectrium struggle to recruit the best talent to the team, this would be detrimental to Lectrium. The success of the Company will depend on its ability to compete for and retain additional qualified key personnel to enhance the growth. The Company's business would be adversely affected if it were unable to recruit qualified personnel when necessary or if it were to lose the services of certain key personnel and it were unable to locate suitable replacements in a timely manner. Finding and hiring such replacements, if any, could be costly and might require the Company to grant significant equity awards or incentive compensation, which could have a material adverse effect on the Company's financial results and on your investment. The loss, through untimely death, unwillingness to continue or otherwise, of any such persons could have a materially adverse effect on the Company and its business.

Lectrium will likely raise future rounds of funding to grow and compete in the developing EV charging market. There is the risk of dilution to all shareholders, with the factor depending upon which valuations Lectrium can fetch in the future.

Policy could affect Lectrium's focus on Level 2 charger installations in residences. If the government subsidizes public chargers very heavily and consumer behavior prefers these public chargers over residential chargers, Lectrium's current business model would be impacted in the long term. Additionally, if the government does not continue introducing policy to facilitate EV adoption, or scales back its current policies, Lectrium will be adversely affected as the adoption of EVs will likely not increase as quickly.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Securities Issued by the SPV

3. Senior to payments for Common Stock.

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

VitalizeVC Management, LLC is the Lead Investor and retains all of its rights and duties associated with its position as Lead Investor as defined in the Lead Investor Agreement executed by, among, and between VitalizeVC Management, LLC, Wefunder Inc., and Lectrium, Inc. on or about March 24, 2022. Mr. Alex Rosenberg retains the right to approve the voting decisions of VitalizeVC Management, LLC made in the execution of its duties as Lead Investor under the aforementioned Lead Investor Agreement.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. In addition, as discussed above, if a

majority-in-interest of holders of securities with voting rights cause the Company to issue additional equity, an Investor's interest will typically also be diluted.

Based on the risk that an Investor's rights could be limited, diluted or otherwise qualified, the Investor could lose all or part of his or her investment in the securities in this offering, and may never see positive returns.

The shareholders have the right to redeem their securities at any time. Shareholders could decide to force the Company to redeem their securities at a time that is not favorable to the Investor and is damaging to the Company. Investors' exit may affect the value of the Company and/or its viability.

In the future, we will perform valuations of our **stock (including both common stock and Preferred Stock)** that take into account, as applicable, factors such as the following:

- unrelated third party valuations;
- the price at which we sell other securities in light of the relative rights, preferences and privileges of those securities;
- our results of operations, financial position and capital resources;
- current business conditions and projections;

- the marketability or lack thereof of the securities;
- the hiring of key personnel and the experience of our management;
- the introduction of new products;
- the risk inherent in the development and expansion of our products;
- our stage of development and material risks related to our business;
- the likelihood of achieving a liquidity event, such as an initial public offering or a sale of our company given the prevailing market conditions and the nature and history of our business;
- industry trends and competitive environment;
- trends in consumer spending, including consumer confidence;
- overall economic indicators, including gross domestic product, employment, inflation and interest rates; and
- the general economic outlook.

We will analyze factors such as those described above using a combination of financial and market-based methodologies to determine our business enterprise value. For example, we may use methodologies that assume that businesses operating in the same industry will share similar characteristics and that the Company's value will correlate to those characteristics, and/or methodologies that compare transactions in similar securities issued by us that were conducted in the market.

An Investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the Investor. A sale of the issuer or of assets of the issuer. Overview

Lectrium is a full-service platform for EV home charging with a mission to make every home EV-ready. We make the home charging installation process easy through our network of EVITP certified electricians. We believe that true carbon neutrality can be achieved only if the transition to EVs is frictionless.

Our ambition is to standardize and reduce the cost of the installation process and remove financial barriers for EV adoption.

Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future, if any.

Milestones

Lectrium, Inc. was incorporated in the State of Delaware in November 2021.

Since then, we have:

- o Our pre-seed investor Antler has the #1 investor rank on Crunchbase (2021)
- MOUR MVP is revenue-generating
- We have a network of over 500+ electricians covering 8 states

Historical Results of Operations

Our company was organized in November 2021 and has limited operations upon which prospective investors may base an evaluation of its performance.

- Revenues & Gross Margin. For the period ended December 31, 2021, the Company had revenues of \$0.
- Assets. As of December 31, 2021, the Company had total assets of \$79,090, including \$54,090 in cash.
- Net Loss. The Company has had net losses of \$43,960.50 for 2021.
- Liabilities. The Company's liabilities totaled \$122,960.50 for 2021.

Liquidity & Capital Resources

To-date, the company has been financed with \$535,000 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 9 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Lectrium, Inc. cash in hand is \$\$446,935.51, as of April 2022. Over the last three months, revenues have averaged \$914.50/month, cost of goods sold has averaged \$678.66/month, and operational expenses have averaged \$11,635.46/month, for an average burn rate of \$11,399.62 per month. Our intent is to be profitable in 12 months.

Since December 31, 2021, Lectrium has raised additional capital from investors and plans to continue to do so. We have also established a wholly-owned subsidiary, Lectrium Technologies UAB to employ our team in Lithuania. We incurred legal fees for setting up this entity.

We also have hired additional members of the team, and will continue to hire more team members. We will grow our marketing expenses and acquire more

customers through a variety of channels, leading to more revenues and costs as well. Further, we have become an affiliate partner of an EV charging hardware company, allowing us to make more revenue per installation.

We expect our revenues to reach the 5 figure mark (\$10,000) on a monthly basis sometime in the next 3-6 months.

We expect our costs to outpace our revenues (at about \$25k per month) as we build a team and establish ourselves in a number of go to market channels. If our team grows to 5 full time employees, our expenses can be many times larger than our revenue over the next 3-6 months until we get a significant amount of installations flowing on the platform.

We are not yet profitable. Our profitability is an equation that factors our number of installations, the amount we make per installation, and how many people it takes to support or fulfill an installation (cost per installation). We forecast profitability in the month in which our software and team can handle a volume of installations that generates revenue larger than the costs associated with the team and software. For example, when we reach a month where we facilitate ~700 installations, make a profit of ~\$500 per installation (generating ~\$350,000 in profit before SG&A costs) and have a team with monthly salary + benefits + our other costs combine for an amount less than ~\$350,000, we will reach profitability.

Forward-looking projections cannot be guaranteed.

We have raised funding from Antler Global in the past. We have raised funding from angel investors, and are currently raising a round led by Link VC. We plan to cover our short-term budget through this invested capital.

Any projections in the above narrative are forward-looking and not guaranteed.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company.
