Eric beat me to the punch in reaching out to you! (Which I am appreciative to have such a proactive husband on my behalf, but had also wanted to reach out to you personally as we've launched our WeFunder campaign!)

You are honestly the type of person who embodies what they say about aligning yourselves with people who will recommend you in a room when you're not there, and I have always felt incredibly appreciative of the fact that we crossed paths.

I know we had talked about the misery and frustration in investor funding as the bar continues to move no matter how much the metrics improve. I had actually looked into an SBA loan after you and I last connected, but it wasn't a fit for us in terms of collateral. But a few months ago, Wharton Impact Ventures Associates - a student impact investment focused group - asked if we'd ever consider doing a community crowd (i.e. crowd equity). I hadn't, but after conversations with Wharton and WeFunder, it made sense for us.

While it would be easy to say that we were attracted to this approach out of frustration for traditional fundraising, the truth is, I don't think this route will be any easier, but I also think for us, the ability to raise capital in a way that can democratize or lower barriers to access when it comes to investing aligns with our mission and goals.

Hello, Casey -

It's been a while so I hope this is the correct email.

I'm just going to assume that (shockingly) you haven't been reading our company newsletter, listening to my Instagram live or reading our Founders Corner blog so that you don't know that last week, my company, 7 Generation Games, opened a Community Round.

If you didn't know, now you know - a community round, also called crowd equity, allows 'average people' to invest in a startup. Usually, investors need to be accredited - that is, make over \$200,000 a year - and the minimum investment is high. In our previous seed round, the minimum was \$10,000. In a community round, anyone with \$100 to put in can invest.

You can click the link here to invest: <https://wefunder.com/7generationgames> and get LOTS of information.

As an added bonus, early investors get more favorable, early terms.

Even if you are an accredited investor because of all that grass dance prize money you and Z have been raking in, I'd still ask you to invest in our community round, for four reasons:

1. You have the potential to make a return on investment.

2. 7 Generation Games makes educational games and the tools to make them. Not only do you get to join our community of investors, but you'll also be helping develop products to help people learn, and because we can make games faster and cheaper than the competition, we can target specific communities like the Lakota or Appalachia or even a specific sports community like judo or BJJ. Lots of people have stories to tell and games help them tell those stories.
3. I'd be very appreciative of your support - so much so that we are doing an early round giving friends and family a better deal. This is legal so long as we allow anyone who comes in early to get the same terms (believe me, I checked. I didn't want to end up Martha Stewart's roommate in white collar prison).
4. Analyses have shown that crowd equity rounds that bring in significant funds in the early weeks are more likely to be successful as people want to jump on the bandwagon.

If you have any questions, I would be more than happy to talk to you, probably at greater length than you want, about what we are doing.

I'd also ask you to pass this on to others you know who might invest. I was very pleasantly surprised to find that some of our first investments came from people who said things like, "I don't have any money to invest but I sent this to my aunt/ sister/ friend" who does - and they invested.

I know you have a wide network of people who have a high opinion of you so if you could share it with them, I'd appreciate it.

Greetings from Madrid! I've been here presenting at the South Summit conference, and specifically working on generating interest on the 7 Gen Blocks platform that I've been talking so much about in our investor reports lately. It really feels like we are approaching a tipping point as far as the platform and the business model shift, which is exciting.
