The company has a limited operating history.

The company's business and operations are sensitive to general business conditions meaning that turnover, operational issues, etc., can negatively affect demand/sales.

A host of factors beyond the Company's control could cause fluctuations in these conditions.

Adverse conditions may include recession, downturn, local competition or changes in consumer taste. This can negatively affect demand/sales.

Sidekick Mobile Technologies is subject to privacy laws which can be amended or changed in the coming years. The company may have to adapt to forces outside of its control. This can cause Go-To-Market strategies to be put on pause until adapted to meet compliance laws.

The company is a technology company meaning the stability and maintenance of the platform is necessary for sustained growth. The stability of the technology will be based on the company's ability to finance working hours from app developers. This means that if the company hits major cashflow issues in the future, the speed to release new updates and improve may be slower.

Business projections may not be reached. The projections made by the company are based on current circumstances and experience. When circumstances change, projections may sometimes need to be adjusted. The more traction the company has the opportunity to build, the more accurate the projections should be.

Operating costs may be unpredictable. Our operating costs will scale primarily as our user base and revenue grows. This means that if we are ahead of projections, we will need to make key hires sooner than planned. This could also happen if a new risk area is discovered where it is necessary to hire talent to meet that need.

A key factor to our growth has been our proprietary Empathy Algorithm which drives the peer to peer engagement that has been a key aspect of our growth. This algorithm is not patented, so a risk we run is that a third party could replicate this and take away one of our key advantages. We have limited this risk so far by reinvesting revenues into user acquisition and aggressive growth.

Sidekick Mobile Technologies currently has only one developer (Chris Thompson). Until we generate more funding, the risk is that the ability to improve the technology will be limited to his time and availability. Chris Thompson has multiple roles within this company and at times, he has to put developing improved technology on hold.

The work Sidekick Mobile Technologies is doing to increase positive outcomes, and lower relapse rates will negatively effect many of the business models in the Substance Abuse Treatment Industry that are incentivized by repeat customers. This may cause hostility within the industry as we scale.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **preferred stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

*Conversion to Preferred Equity.* Based on our SAFEs, when we engage in an offering

of equity interests involving **preferred stock**,

**Investors will receive a number of shares of preferred stock** calculated using the method that results in the greater number of **preferred stock**:

1. the total value of the Investor's investment, divided by
  1. the price of **preferred stock** issued to new Investors multiplied by
  2. the **discount rate** (80%), or
2. if the valuation for the company is more than **\$8,000,000.00** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
  1. the Valuation Cap divided by
  2. the total amount of the Company's capitalization at that time.
3. for investors up to the first **\$500,000.00** of the securities, investors will receive a valuation cap of **\$7,500,000.00** and a discount rate of 80.0%.

*Additional Terms of the Valuation Cap.* For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

*Liquidity Events.* If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **preferred stock**, Investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

*Liquidity Priority.* In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
2. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
3. Senior to payments for Common Stock.

#### **Securities Issued by the SPV**

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

#### **Voting Rights**

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

#### **Proxy to the Lead Investor**

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to (i) vote all securities related to the

substitution, on behalf of the investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

#### Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

Sober Sidekick will be a part of 10 million comeback stories in 5 years, and will be the first decentralized support platform in the mental health space. This is a forward looking projection that cannot be guaranteed.

### Milestones

Sidekick Mobile Technologies Inc was incorporated in the State of Delaware in October 2021. Slack Mobile Technologies, LLC was formed in the Commonwealth of Pennsylvania in 2019.

Slack Mobile Technologies, LLC ceased all operations at the end of 2021 and contributed all of its assets and liabilities to Sidekick Mobile Technologies, Inc. in exchange for shares in Sidekick Mobile Technologies, Inc.

The consolidated financial statements have been prepared to present the financial position and results of the operations of the following related entities (collectively, the "Company"). The financials statements only include information from January 1, 2020 through December 31, 2021.

Our company was organized in October 2021 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2021, the Company had revenues of \$262,533.

- *Assets.* As of December 31, 2021, the Company had total assets of \$39,991, including \$30,689 in cash.

- *Net Income.* The Company has had net income of \$3,801 for 2021.

- *Liabilities.* The Company's liabilities totaled \$37,500 for 2021.

### Liquidity & Capital Resources

To-date, the company has been financed with \$3,000 in debt and \$100,000 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 3 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 9 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in

offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### **Runway & Short/Mid Term Expenses**

Sidekick Mobile Technologies Inc cash in hand is \$10,716, as of June 2022. Over the last three months, revenues have averaged \$23,333/month, cost of goods sold has averaged \$15,000/month, and operational expenses have averaged \$39,166/month, for an average burn rate of \$30,833 per month. Our intent is to be profitable in 9 months.

Since the date our financials cover, we've used funding from Expert Dojo to build more engagement features and launch new revenue pilots.

In order to ensure that this Wefunder raise gets us at least 3 months of runway, our baseline monthly burn will be limited to \$20,000. Historically, we have put over 75% of our revenue directly back into marketing and growth, our burn will increase accordingly if our sales warrant us to do so.

For the next three months, we expect our necessary operational expenses to be \$45,000 (\$15,000 monthly). The more traction we generate on our campaign, the more we can invest in member acquisition and increase marketing spend accordingly.

We only have \$15,000 in necessary operational costs, but we have put an extra \$20,000-30,000 into paid media and marketing as our revenue has extended our runway in order to scale faster and generate more value.

We expect revenue to be stable from \$15,000-25,000 Monthly for the next three months or so. This summer, we will have the opportunity to launch revenue models in new verticals, and we expect to begin scaling them in September with a goal of hitting \$1,000,000 ARR in December.

Currently, we are losing between \$5,000-\$15,000 per month, which is well worth the cost of growth. We expect to hit a point of profitability in the September 2022, and scale accordingly.

50% of our burn has gone into growth, meaning we need less than \$20,000 to meet our monthly obligations when it comes to expenses. Our marketing spend can always be lowered if we reach a point where we are in danger of running out of cash.

The purpose of this raise is to help us scale our user growth faster, and give us time to focus on improving our technology. If we reach a point where profitability is urgent, we can lower our marketing spend accordingly. We're estimating \$150,000 raised through Wefunder will help us get our sales scaling fast enough to scale in tandem with our user growth in order for us to reach profitability without sacrificing growth.

We would likely launch a new fund raising round once we hit profitability again in order to focus on growth.

We've been able to grow up to this point (110,000 members, \$300,000 ARR) with only \$100,000 in funding. We will handle short term burn the same way we always have for the past 3 years by focusing on revenue. Our revenue combined with our limited burn has allowed us to remain flexible while avoiding cashflow issues.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offering and may potentially be compensated for some of its

Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

**Tax Filings.** In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the Investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.

## ONGOING REPORTING

32. The issuer will file a report electronically with the Securities & Exchange Commission annually and post the report on its website, no later than:

120 days after the end of each fiscal year covered by the report.

1. the issuer is required to file reports under Exchange Act Sections 13(a) or 15(d);
2. the issuer has filed at least one annual report and has fewer than 300 holders of record;
3. the issuer has filed at least three annual reports and has total assets that do not exceed \$10 million;
4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
