8. Discuss the material factors that make an investment in the issuer speculative or risky:

The ultimate profitability of any motion picture depends upon its audience appeal in relation to the cost of its development, production and distribution. The audience appeal of a given motion picture depends, among other things, on unpredictable critical reviews and changing public tastes and such appeal cannot be anticipated with certainty. It is possible that the film will fail to gain traction with its target audience which may result in the Company's inability to return investor capital.

Film distribution models are constantly evolving. The Company plans to release this film using the pathways available to us which are most likely to succeed based on the knowledge and experience in the industry. The Company endeavors to assign rights to (or otherwise engage) a distributor to leverage its existing networks. However, the efforts of such distributor are not guaranteed to succeed. Furthermore, the Company may be unable to engage such a distributor and the alternative approaches to distributing the film may also fail to generate sufficient revenue to allow the Company to return investor capital.

Technology plays a crucial role in filmmaking. The Company will use best practices to safeguard and back-up all footage, but unforeseen technological failures or hacking could result in losses and/or impede the progress of production.

If there is an influx of films that are similar in tone, voice, style, or story, the marketplace could become oversaturated, hindering the film's ability to generate revenue. The film is targeted at movie-goers as well as digital platforms, cable, satellite and standard television viewers. This is an extremely competitive market. Many motion pictures are released during a given year. Many utilize the strength of studios and large companies with far greater resources in talent, production, marketing and distribution than the Company possesses. The Company shall also be competing against other smaller production companies which may or may not have larger budgets.

The Company is a newly organized entity and therefore has no history of operations or earnings. The Company is being created for the sole purpose of developing and producing one motion picture to be sold or assigned to a distributor or self-distributed and exploited in various ancillary markets. Once all revenue has been received and all distributions made, the Company will cease to exist.

The motion picture industry is highly speculative and risky. Many motion pictures commence development and production but are unable to complete the same due to lack of funding or overages. Many motion pictures that are developed for presentation to a distributor for sale or assignment are not "picked up" (sold or assigned) nor actually distributed even if "picked up." Many motion pictures that are targeted for theatrical release may only obtain direct-to-digital platforms or direct-to-cable release. Many motion pictures fail to obtain any release at all. The investors should be prepared to lose their investment as part of the risk of this venture.

Particularly as developed and produced by independent filmmakers, each motion picture is a separate business venture with its own management, employees and equipment and its own budgetary requirements. There are substantial risks associated with film development and production, including death or disability of key personnel, strikes/labor disputes, other factors causing delays, destruction or malfunction of sets or equipment, the inability of personnel to comply with budgetary or scheduling requirements and physical destruction or damage to the films themselves. Significant difficulties such as these may materially increase the

cost of development or production or may cause the entire project to be abandoned, resulting in a total loss of investment to the investors.

The development, production or distribution of a motion picture may be abandoned at any stage if further expenditures do not appear commercially feasible, with the resulting loss of some or all of the funds previously expended on the development, production or distribution of the film, including funds expended in connection with the development and packaging of the screenplay and pre-production or production of the film.

The costs of developing and producing motion pictures are often underestimated and may be increased by reason of factors beyond the control of the producers. Such factors may include weather conditions, illness of technical and/or artistic personnel, artistic requirements, strikes/labor disputes, governmental regulations, equipment breakdowns and other production disruptions (including evolutions of COVID-19 and governmental response thereto) can disrupt and impede the progress of production. While the Company intends to engage development and production personnel who have demonstrated an ability to complete their assigned responsibilities within the assigned budget, the risk of a motion picture running over budget is always significant and may have a substantial adverse impact on the profitability of the film.

The development, production and distribution of a motion picture involves the passage of a significant amount of time. Development may extend for months. Pre-production on a motion picture may extend for two or three months or more. Principal photography may extend for several weeks or more. Post production may extend from three to four months or more. Distribution and exhibition of motion pictures generally and of the Company's film, specifically, may continue for years before Company gross revenues or distributable cash may be generated, if at all.

The entertainment business in general, and the motion picture business in particular, are undergoing significant changes, primarily due to technological developments. These developments have resulted in the availability of alternative forms of leisure time entertainment, including expanded pay and basic cable television, syndicated television, videocassettes, video discs, video games, the Internet, the worldwide web, other forms of electronic transmission to smart phones and other similar devices. During the last several years, revenues from licensing a motion picture to network television have decreased (and fewer motion pictures are now being licensed for any price to network television), while revenues from streaming have increased relative to network. It is impossible to accurately predict the effect that these and other new technological developments may have on the motion picture distribution industry.

Film production safety guidelines are still being developed and refined in response to COVID-19. Even following the strictest guidelines to ensure the cast and crew's safety, it is still possible for the virus to affect the production scheduling and budget.

The Company's future success depends on the efforts of a small management team. The loss of services of Adam Scheiner, Joshua Bunting or any other critical employees or contributors to the production team may have an adverse effect on the Company. There can be no assurance that the Company will be successful in attracting and retaining other personnel the Company requires to produce the film.

USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$50,000**

Use of Proceeds: 65% to production (camera, locations, crew, etc.); 20% to cast; 5% to post-production (editing, sound, score); 2.5% to insurance; 7.5% to Wefunder fees.

If we raise: **\$1,070,000**

Use of Proceeds: Raising the full \$1.07M will greatly increase the production value--the Company will be able to sign contracts with labor unions and access those enhanced talent pools.

65% to production (camera, locations, crew, etc.); 20% to cast; 5% to post-production (editing, sound, score); 2.5% to insurance; 7.5% to Wefunder fees.

"Book Entry and Investment via SPV": In exchange for investment, investors shall receive interests in a special purpose vehicle established by Wefunder Admin, LLC (the "SPV"). The SPV will invest all amounts received from investors in securities issued by the Company. SPV interests issued to investors will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, each investor's interests will be recorded in such investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an investor's investment in the "Company" or the "Issuer" (or similar phrases) should be interpreted to include investments in the SPV.

12. How can an investor cancel an investment commitment?

Revenues

All gross revenues from the distribution and exhibition of the Picture from all sources and all media worldwide collected by Company or the Collection Agent, as applicable, (the "Gross Revenues") shall be applied and paid out by Company or the Collection Agent for the following items in the following order on a continuing basis:

- i. First, one hundred percent (100%) of the Gross Revenues shall go towards the following customary "off-the-top" payments (which, for clarification, are not necessarily payable in the order of sections 8.a.i.(1) through 8.a.i.(5) hereinbelow):
 - (1) Payments actually made by Company in connection with collection agent fees and expenses (if any);
 - (2) Payments actually made by Company, or a reserve, to the extent required by the applicable unions or guilds, for sums reasonably anticipated to be due by Company to applicable unions or guilds having jurisdiction over the Picture for residuals, royalties or similar payments related to the exhibition or release of the Picture; payments actually made by Company, or a reserve for sums reasonably anticipated to be payable by Company, in connection with any actual, direct, customary, third party, out-of-pocket costs and expenses of auditing, administering and collecting monies paid and/or owing to Company from distributors and/or other licensees of the Picture (including without limitation collections account management fees and licensing intermediaries); the payment of taxes (but not income taxes); and other administrative expenses of Company in connection with the Picture only. For clarification purposes, it is acknowledged and agreed that administrative expenses herein shall not include any overhead or payments to Company personnel (other than reimbursement of any actual, verifiable out-of-pocket expenses incurred by such parties in connection with the foregoing);
 - (3) To the repayment of any and all loans incurred by Company, if any (including all interest, fees and expenses in connection therewith);
 - (4) The fees and expenses actually paid by Company to any distributors, sales agents, and to outside attorney(s) for their reasonable fees in connection with the Picture; and
 - (5) Any reasonable costs associated with the delivery of the Picture to distributors and/or sales agents, and festival related expenses.
- ii. Next, if applicable, to the tax credit lender for repayment of unpaid indebtedness ("Tax Credit Loan") incurred solely in connection with collateralization of tax credits, until such time as the Tax Credit Loan is repaid in full;
- iii. Next, to Investor and all Other Investors in reimbursement and recoupment of such party's investment, pro rata to each party's Percentage Interest until each such party has received an amount equal to one hundred twenty-five percent of its respective investment in Company (which, for Investor, shall be the Investment).

iv. Next, to any and all deferrals, bonuses and similar payments, if any; and

v. Revenues remaining thereafter shall be deemed "Net Proceeds" from the distribution and exploitation of the Picture and shall be paid fifty percent (50%) to the Principals (Scheiner and Bunting) and fifty percent (50%) to Investor and all Other Investors (combined), to the extent applicable pursuant to the financing agreement entered into by each such Other Investor, paid pro rata to their respective Percentage Interests. The Company's Net Proceeds shall be payable to Company (or as directed by Company) and allocated to and shall include all contingent amounts other than fixed deferred sums, payable to writers, director, producers, actors and other individuals rendering services in connection with the Picture, except as otherwise agreed to in writing by Investor.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, for administrative purposes, the Company shall issue its interests to the SPV, which, in turn, will issue its

interests to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

With respect to any voting rights of the SPV securities, the investor and his, her, or its transferee or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

The Company plans to use the proceeds as set forth in this Form C under "Use of Funds". The Company does not have any other sources of capital in the immediate future.

The Company will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number).
