An investment in the SAFE offered by Megafono Corporation (the "Company") is extremely speculative, involves a high degree of risk, and should be considered only by investors who are able to bear the economic risks of their investment for an indefinite period of time and who can afford to sustain a total loss of their

investment in the SAFE. The risks described below are not the only ones facing the Company. Additional risks that the Company does not yet know of, or that the Company currently thinks are immaterial, may also impair the Company's business operations. If any of the events described in the following risk factors actually occur, it could have a material adverse effect on the Company's business, prospects, financial condition, results of operations and cash flow. Potential investors are urged to consult with their legal, financial, and other professional advisors prior to investing in the Company.

Development Stage Business

Megafono Corporation is a Delaware corporation formed on September 1, 2020. The Company has not commenced selling products or services and has focused solely on research and design. Accordingly, the Company has only a limited history upon which an evaluation of its prospects and future performance can be made. The Company's proposed operations are subject to all business risks associated with new enterprises. The likelihood of the Company's success must be considered in light of the problems, expenses, difficulties, complications, and delays frequently encountered in connection with the expansion of a business, operation in a competitive industry, and the continued development of advertising, promotions, and a corresponding customer base. There is a possibility that the Company could sustain losses in the future. There can be no assurances that the Company will operate profitably.

Inadequacy of Funds

Assuming the offering is fully subscribed, \$1,000,000 of gross proceeds may be realized. The management team believes that additional capital will be necessary to properly capitalize and sustain the Company to allow for the implementation of the Company's business plan. If only a fraction of this offering is sold, the Company is unable to raise additional funds outlined in the business plan, or if certain assumptions contained in business plan prove to be incorrect, the Company may have inadequate funds to fully develop its business and may need debt financing or other capital investment to fully implement the Company's business plans. The development timeline varies greatly based on the amount of funds the Company is able to raise, and the longer it takes to go to market the greater the risk of another company copying the Company's strategy.

Dependence on Management

In the early stages of development, the Company's business will be significantly dependent on the Company's management team. The loss of any one of these individuals could have a material adverse effect on the Company. The Company does not have employment agreements with the Company's officers or directors. Until the Company is fully funded, members of the management team will likely maintain outside employment. The Company's ability to achieve its business goals and objectives depends upon the management team's ability to successfully commercialize the Company and capitalize on the intellectual property that constitute the only significant assets of the Company. SAFE holders will have no opportunity to evaluate or otherwise approve or disprove of (i) the contracts or licenses entered into by the Company, (ii) the continued research and development of the Company, (iii) potential or prospective applications and uses of the Company, or any permutations or derivatives thereof, or (iv) certain economic or financial data concerning the operations of the Company. Investors must rely entirely on the skills, judgment, and competency of the management team in effectively utilizing and successfully leveraging and applying the proceeds of this offering. We cannot be sure that the management team will be successful in financially exploiting or commercializing the Company on financially attractive terms, or that the Company's business objectives and operational goals will be achieved. The management team may change its business strategy and plan without the consent or knowledge of the SAFE holders. The management team may make errors of judgment in pursuing the Company's business objectives and may encounter difficulties in successfully commercializing the Company. The Company's success depends upon the continued contributions of the management team, each of whom would be difficult to replace because of their experience in or with the political industry, artificial intelligence, and business operations. If certain members of the management team were to cease their service to the Company, the Company could suffer.

Customer Base and Market Acceptance

While the Company believes it can develop a customer base based on its market research, the inability of the Company to develop such a customer base could have a material adverse effect on the Company. Although the Company believes that it has product-market fit, no assurance can be given that the Company's products and services will attain a degree of market acceptance on a sustained basis or that it will generate revenues sufficient for sustained profitable operations. The platform generally requires a minimum number of users per Congressional District to work at its peak potential. While the Company will strive to have as close to full coverage as possible, the Company cannot guarantee how many users will join in each Congressional District.

Risks of Borrowing

If the Company incurs indebtedness, a portion of its cash flow will have to be dedicated to the payment of principal and interest on such indebtedness. Typical loan agreements also might contain restrictive covenants, which may impair the Company's operating flexibility. Such loan agreements would also provide for default under certain circumstances, such as failure to meet certain financial covenants. A default under a loan agreement could result in the loan becoming immediately due and payable and, if unpaid, a judgment in favor of such lender which would be senior to the rights of SAFE holders of the Company. A judgment creditor would have the right to foreclose on any of the Company's assets resulting in a material adverse effect on the Company's business, operating results, or financial condition.

Unanticipated Obstacles

The Company's plans may change significantly. Many of the Company's potential business endeavors are capital intensive and may be subject to statutory or regulatory requirements. Management believes that the Company's strategies are achievable in light of current economic and legal conditions with the skills, background, and knowledge of the Company's principals and advisors. Management reserves the right to make significant modifications to the Company's stated strategies depending on future events.

Management Discretion as to Use of Proceeds

The Company reserves the right to use the funds obtained from this offering for purposes not presently contemplated which it deems to be in the best interests of the Company and its stockholders in order to address changed circumstances or opportunities. As a result of the foregoing, the success of the Company will be substantially dependent upon the discretion and judgment of management team with respect to application and allocation of the net proceeds of this offering. Investors in the SAFE offered hereby will be entrusting their funds to the Company's management team, upon whose judgment and discretion the investors must depend.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

SAFE Risks

The Company may never receive a future equity financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an initial public offering. If neither the conversion of the Securities nor a liquidity event occurs, the investors could be left holding the SAFE in perpetuity. The SAFEs have numerous transfer restrictions and will be highly illiquid, with no secondary market on which to sell them. The SAFEs are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Compliance with Securities Laws

The SAFEs are being offered for sale in reliance upon certain exemptions from the registration requirements of the Securities Act of 1933, as amended (the "Securities Act") and applicable state securities laws. If the sale of SAFEs were to fail to qualify for these exemptions, purchasers may seek rescission of their purchases of the SAFEs. If a number of purchasers were to obtain rescission, the Company would face significant financial demands, which could adversely affect the Company as a whole, as well as any non-rescinding purchasers.

No Underwriter

The SAFEs are offered directly by the Company on a "best efforts basis" without commission to the management team on the terms and conditions set forth herein and the SAFE. The Company will use its best efforts to sell the SAFEs to investors. However, there can be no assurance that all or any of the SAFEs offered, will be sold.

Lack of Liquidity of SAFEs

The SAFEs are to be acquired for investment purposes only and not with a view to their resale or other distribution. The SAFEs have not been registered under the Securities Act, or any applicable state securities laws, and are being offered in reliance on exemptions from the registration requirements of the Securities Act and such laws. The SAFEs are subject to restrictions on transferability and resale and may not be transferred or resold except as permitted under the Securities Act and applicable state securities laws pursuant to registration or exemption therefrom. The SAFEs are also subject to restrictions on transfer as described therein. Investors may not be able to obtain cash for their SAFEs in a timely manner and should anticipate holding their SAFEs indefinitely. Investors will not be able to sell or assign the SAFEs or use the SAFEs as collateral for a loan and will not be entitled to have their SAFEs redeemed by the Company. There is no public market upon which the SAFEs can be traded.

The management team hopes that the primary exit strategy for all SAFE holders will be an initial public offering or a private sale of the entire company or all or substantially all of its assets at some point in the future. However, while such an exit strategy might be desirable, there are absolutely no guarantees that it will happen, and investors may be required to hold their SAFEs for an indefinite period of time.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

NOTE: Investors may cancel an investment commitment until 48 hours prior to the deadline identified in these offering materials.

The intermediary will notify investors when the target offering amount has been met. If the Investor does not reconfirm, he or she will receive notifications disclosing that the commitment was cancelled, the reason for the cancellation, and the refund amount that the Investor is required to receive. If a material change occurs within five business days of the maximum number of days the offering is to remain open, the offering will be extended to allow for a period of five business days for the investor to reconfirm.

The Company's right to cancel. The Investment Agreement you will execute with us provides the Company the right to cancel for any reason before the offering deadline.

If the sum of the investment commitments from all investors does not equal or exceed the target offering amount at the time of the offering deadline, no securities will be sold in the offering, investment commitments will be cancelled and committed funds will be returned.

Ownership and Capital Structure

THE OFFERING

13. Describe the terms of the securities being offered.

To view a copy of the SAFE you will purchase, please see [Appendix B, Investor Contracts](#). The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides investors the right to **preferred stock** in the Company ("Preferred Stock"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **preferred stock**, investors will receive a number of shares of **preferred stock** calculated using the method that results in the greater number of **preferred stock**:

- i. the total value of the investor's investment, divided by
 - a. the price of **preferred stock** issued to new investors multiplied by
 - b. the **discount rate** (85%), or
- ii. if the valuation for the company is more than **\$5,000,000.00** (the "Valuation Cap"), the amount invested by the investor divided by the quotient of
 - a. the Valuation Cap divided by
 - b. the total amount of the Company's capitalization at that time.
- iii. for investors up to the first **\$100,000.00** of the securities, investors will receive a valuation cap of **\$4,250,000.00** and a discount rate of 85.0%.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to investors in the SAFEs receiving **preferred stock**, investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The investor's right to receive its Cash-Out Amount is:

- i. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
- ii. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
- iii. Senior to payments for Common Stock.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

An Investor in the Company will likely hold a minority position in the Company, and thus be limited as to its ability to control or influence the governance and operations of the Company.

Overview

We make government accessible to everyone. Megaphone empowers users with the same access and information that is typically reserved for Washington elite.

In five years, we want to be clear winner in the market (not guaranteed).

Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future, if any.

Milestones

Megafono Corporation was incorporated in the State of Delaware in September 2020.

Since then, we have:

- Underserved TAM (~160M people) hungry for a solution to fix the broken Beltway.
- B2C and B2B sales targets.
- 80% of surveyed would use our service, 30% would pay for premium (higher than industry standard).
- Massive data play that preserves anonymity of our users and offers multiple revenue streams.
- Experienced team w/ decades in AI, Software, Government & Politics, as well as start-ups and exits.

Historical Results of Operations

Our company was organized in September 2020 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2021, the Company had revenues of \$0 compared to the year ended December 31, 2020, when the Company had revenues of \$0.
- *Assets.* As of December 31, 2021, the Company had total assets of \$91,487, including \$1,277 in cash. As of December 31, 2020, the Company had \$20,451 in total assets, including \$20,451 in cash.
- *Net Loss.* The Company has had net losses of \$23,965 and net losses of \$4,799 for the fiscal years ended December 31, 2021 and December 31, 2020, respectively.
- *Liabilities.* The Company's liabilities totaled \$120,001 for the fiscal year ended December 31, 2021 and \$25,000 for the fiscal year ended December 31, 2020.

Liquidity & Capital Resources

To-date, the company has been financed with \$100,000 in convertibles.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 18 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 18 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Megafono Corporation cash in hand is \$21,682, as of August 2022. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$3,000/month, for an average burn rate of \$3,000 per month. Our intent is to be profitable in 36 months.

Since the date of our financials, expenses were reduced to prepare for the next round of financing. Software development will ramp up significantly as our Wefunder campaign progresses.

We plan on increasing expenditures in the first six months to an average of \$125,000 per month assuming we can raise at least \$500k in this Wefunder offering.

Megafono Corporation's Megaphone applications are still under development and at this time are not generating revenue, as such, the Company is not profitable. Financial and development projections detail that the Megaphone Dashboard will be available for release in the first quarter of the second year and the Megaphone+ application will be released in the third quarter of the second year after successfully closing this Wefunder offering.

If we are able to raise a total of \$1M, we believe we can reach a revenue-generating point in Q3 of 2023. One year after that point, we expect to generate approximately \$7M in revenue and incur \$7.1M in expenses.

Megafono Corporation raised an initial "Friends & Family" round of capital in the amount of \$100,000 via notes payable at a rate of 6% interest. Each of the note holders have converted to the SAFE offering under our WeFunder campaign. Investments from the F&F round continue to cover the existing short-term burn during our WeFunder campaign.

Any projections mentioned above are forward-looking and cannot be guaranteed.

As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity

of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

If the Proxy is not revoked during this 5-day period, it will remain in effect.
