To generate revenue, we need to target specific groups of customers who require scalable and cost-effective computing

power, such as media companies, video producers, and AI developers, and any kind of organization that needs extensive or scalable media processing. Our success depends on the number and magnitude of deals we can secure with these businesses.

In order to handle the computational demands of our customers, we plan to bring on a sizable group of suppliers, or "workers", likely around 10,000 at the beginning stages. We will offer payment incentives to these workers for the use of their devices, though there may be challenges to expanding our worker grid. Factors that could impede progress include concerns about the security of the Worker App or the amount of computing power required.

Prior to achieving profitability, the company must address the risk of insufficient liquidity. This risk may not be resolved solely through debt or equity funding and may result in disruptions to the normal course of business. Additionally, the company may be forced to raise funds under unfavorable terms as a result of liquidity risk.

In order to succeed in creating a compute-power-sharing marketplace, it is crucial to reach both the suppliers and the consumers. The smooth functioning and profitability of the business can be impacted by unexpected changes on either side of the market.

We will offer thorough Terms of Service that suit all types of customers and safeguard their data from being stolen. However, some customers may request us to sign more rigid contracts, which may not be possible due to our distributed computing method. This could hinder our ability to work with particular customer groups, such as government and security. Furthermore, as customer data is shared on untrusted devices, any data breaches that take place outside the company's Terms of Service could be attributed to the company.

There may be certain geographic areas where the company intends to operate that have stricter data protection laws or more complicated compliance frameworks. These laws and frameworks could limit or interrupt the usage of the product in those areas. This could lead to a failure to expand the business in those areas and meet revenue forecasts.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

USE OF FUNDS

9. What is the purpose of this offering?

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or

similar phrases) should be interpreted to include investments in a SPV.

The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **preferred stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **preferred stock**, **Investors will receive a number of shares of preferred stock** calculated using the method that results in the greater number of **preferred stock**:

- i. the total value of the Investor's investment, divided by the price of **preferred stock** issued to new Investors, or
- ii. if the valuation for the company is more than **\$8,000,000.00** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
 - a. the Valuation Cap divided by
 - b. the total amount of the Company's capitalization at that time.
- iii. for investors up to the first **\$125,000.00** of the securities, investors will receive a valuation cap of **\$6,000,000.00**.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **preferred stock**, Investors will receive

receiving preferred stock, investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
2. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
3. Senior to payments for Common Stock.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the

power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

Any provision of this Safe may be amended, waived or modified by written consent of the Company and either:

- i. the Investor or
- ii. the majority-in-interest of all then-outstanding Safes with the same "Post-Money Valuation Cap" and "Discount Rate" as this Safe (and Safes lacking one or both of such terms will be considered to be the same with respect to such term(s)), provided that with respect to clause (ii):
 - A. the Purchase Amount may not be amended, waived or modified in this manner,
 - B. the consent of the Investor and each holder of such Safes must be solicited (even if not obtained), and
 - C. such amendment, waiver or modification treats all such holders in the same manner. "Majority-in-interest" refers to the holders of the applicable group of Safes whose Safes have a total Purchase Amount greater than 50% of the total Purchase Amount of all of such applicable group of Safes.

Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal, Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor:

- A. Wefunder Portal may amend the terms of an investment contract, provided that the amended terms are more favorable to the investor than the original terms; and

Overview

Virtual supercomputer powered by any device

I wanted to invent a solution that can generate value from the existing technological context and help people around the world redeem their power on technology.

We use common devices' (smartphones, tablets and computers) idle computing power to solve large and multiple tasks submitted by our customers.

We want to drive the distributed computing technology and support a wide range of services, from video processing to machine learning, graphics rendering and much more, including our customers' tailored applications.

Milestones

ByteNite Inc. was incorporated in the State of Delaware in February 2022.

Since then, we have:

- Up to 10x faster than AWS EC2
- Every worker can earn up to \$150/mo from each device
- Raised \$600K and established our HQ in San Francisco
- Released a video encoding app and plan to launch an AI inference app by late 2023
- We save up to 37% energy relative to server farms

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

Historical Results of Operations

Our company was organized in February 2022 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2022, the Company had revenues of \$160.
- *Assets.* As of December 31, 2022, the Company had total assets of \$382,629, including \$53,079 in cash.
- *Net Loss.* The Company has had net losses of \$120,055 for 2022.
- *Liabilities.* The Company's liabilities totaled \$2,584 for 2022.

Related Party Transaction

Liquidity & Capital Resources

To-date, the company has been financed with \$600,000 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 3 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Except as otherwise described in this Form C, we do

not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

ByteNite Inc. cash in hand is \$25,000, as of July 2023. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$13,664/month, for an average burn rate of \$13,664 per month. Our intent is to be profitable in 20 months.

We have successfully reduced our monthly cash burn from \$35,000 down to \$13,000, demonstrating our commitment to improving the efficiency of our company and ensuring the longevity of our runway while we start generating revenue and raise the next financing round. We are also enjoying the continued support of our Italian investors, who have provided us with small investments every 2-3 months in the range of \$20,000 each. With these improvements in place, we are optimistic about our ability to maintain our financial stability and continue growing our business. However, we will need to raise more capital in order for the company to start generating revenue and eventually become profitable.

Our platform is now fully operational and capable of accepting payments, so our revenue generation plan is well on its way.

In order to make our sales campaign effective, we need to invest in sales activities like customer outreach, email campaigns, and industry events. That's why we plan to spend at least \$20,000 / month on sales and marketing over the next 3-6 months. After that period, we expect to start generating revenue. Based on our current expenses and the sales and marketing costs, we estimate that we'll need a minimum investment of \$200,000 to become revenue-generating after 6 months.

If we receive this investment, we'll be able to start generating revenue and building trust with our customers. This will lead to more deals, and we expect to generate \$5,000 in monthly recurring revenue with a 30% Month-over-Month growth rate in just 6 months' time.

Finally, to accelerate the sales process and secure deals more efficiently, as well as expand in other areas such as AI, we are seeking an investment of \$3,000,000 to hire a top-performing sales team and a specialized engineering team. With this investment, we are confident that we will exceed our revenue goals and achieve long-term success.

At present, our company is not making a profit. However, we have identified two potential avenues to achieve profitability. The first is to acquire 150 medium-sized customers, each generating around \$1000 in revenue per month. Alternatively,

generating around \$1000 in revenue per month. Alternatively, we could target 15,000 smaller users, each generating around \$10 per month.

Thanks to our Wordpress plugin for video encoding, onboarding 15,000 customers is a feasible task, as it means only 20 users per million of existing Wordpress users need to be added.

It's worth noting that companies that work with video assets tend to have high cloud computing bills, and our competitors in the video encoding space are earning hundreds of thousands of dollars per month.

Finally, to achieve our goal of scaling up and becoming highly profitable, we require a \$3 million investment to support our growth and expand our sales and marketing efforts in a self-sustainable manner.

Our business has received backing from Ksenia Security S.p.A., an Italian investor, who continues to support our expenses while we work towards a larger round of funding and profitability. While the investment from our Italian partner may not be sufficient for hiring new personnel or expanding the business, it does allow us to sustain our operations and cover administrative, research and development, and founder costs. To date, the investor has invested \$600,000 in ByteNite, and currently owns approximately 30% of the company's shares.

OTHER MATERIAL INFORMATION

31. In addition to the information expressly required to be included in this Form, include:

- (1) any other material information presented to investors; and
- (2) such further material information, if any, as may be necessary to make the required statements, in the light of the circumstances under which they are made, not misleading.

The Lead Investor. As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of

Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

Tax Filings. In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the Investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.

4. the issuer or another party purchases or repurchases all of the

securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
