8. Discuss the material factors that make an investment in the issuer speculative or risky:

Kitsbow is not yet profitable, and future sales are not assured. If future sales are below forecast, then there will be insufficient operating capital to fund production. Since Kitsbow sells Made to Order apparel, without production capacity, sales are likely to drop further. This is a significant risk.

Our future success depends on the efforts of a small, management team. The loss of services of the members of the management team may have an adverse effect

on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

In 2022 we have already seen that warmer-than-expected climate seems to stifle the sale of wool apparel, and much of the Kitsbow product line is wool. If climate change continues to elevate temperatures, Kitsbow may not be able to respond quickly enough with new, hot weather products in a way that meets the sales forecast.

Kitsbow has seen new customer acquisition drop from about 50% of all sales orders to 20%, and thus a top priority for the team is to find new ways to reach customers new to Kitsbow. With decreased effectiveness of both online ads and email, solving this challenge may not be possible in a way that meets the sales forecast.

Kitsbow has trained every single one of its production staff, since there are essentially no experienced apparel makers in the U.S. This is a risk both in terms of recruiting suitable candidate students, and an operational cost (approximately \$600,000 in wages/benefits paid for trainers and students in 2021, and \$244,000 in wages/benefits paid for trainers and students in 2022 (through July, 2022). While our establishment of the Old Fort Industrial Sewing Academy with the local community college has dramatically improved our ability to train, this obviously this is a significant cost that threatens profitability.

Kitsbow is associated with Old Fort, NC in a deep way and has invested significant staff time and marketing expenses to promoting Old Fort as a destination for recreation and great jobs at Kitsbow. If Old Fort becomes less popular as a destination, due to any number of reasons including the cost of travel and availability of lodging, this will decrease sales of Kitsbow product in the Old Fort Ride House, which will challenge the team's ability to meet the sales forecast.

Our leadership team is relatively young, and while tested by fire in the three years since re-starting Kitsbow in Old Fort, NC -- most do not have previous experience running an apparel factory, operating a brand, or running a Training Academy.

Our current cash on hand is not sufficient to cover our monthly burn rate. We may have to significantly cut costs to stay in business if we are unsuccessful in raising our minimum goal.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

Book Entry and Investment in the Co-issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a

special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

Ownership and Capital Structure

THE OFFERING

13. Describe the terms of the securities being offered.

The company is issuing promissory notes to investors. The principal amount of each note is the amount invested by the investor. The company will use 4.5% of its gross revenues to pay back principal on the notes. Each note will be paid back based on its pro rata share of all notes issued in this offering. The company will make interest payments to the investor quarterly. The company may prepay principal and interest at any time. The company will continue payments until investors have received 1.75x their principal investment (the repayment amount), provided however that at any time the company may defer up to 1 such payments upon notice to the Lender.

Investors who fund the first \$400,000.00 of the fundraiser will receive 2.0x their principal.

Borrower shall make quarterly payments to the Lender until the Repayment Amount is repaid in full. If the Repayment Amount has not been paid in full to Lender after the 23rd quarterly payment, the entire outstanding balance due shall be payable at the time the 24th quarterly payment is due.

Upon the occurrence of an event of default (as defined in each note), all unpaid principal, accrued interest and other amounts owing will automatically be immediately due, payable and collectible by the company pursuant to applicable law.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV has been formed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

Employee leaders currently own 2,268,750 of Common Stock, with a vesting requirement for each requiring a certain period of service (varies per person). No employee owns more than 17% of the total voting shares. The rights of all holders of Common Stock are the same.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

Because the Investor holds no voting rights in the company, the holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering). These decisions could affect gross revenues and diminish payments made to Investors.

Based on the risk that the company may never realize revenues or face a Default Event, the Investor may never see any returns.

20. How could the exercise of rights held by the principal shareholders identified in Question 6 above affect the purchasers of the securities being offered?

As holders of a majority-in-interest of voting rights in the Company, the shareholders may make decisions with which the Investor disagrees, or that negatively affect the gross revenues of the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, the shareholders may change the terms of the Operating Agreement for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. The shareholders may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns.

The shareholders have the right to redeem their securities at any time. shareholders could decide to force the Company to redeem their securities at a time that is not favorable to the Investor and is damaging to the Company. Investors' exit may affect the value of the Company and/or its viability.

In cases where the rights of holders of convertible debt, SAFEs, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be negatively affected.

Based on the risks described above, the Investor could lose all or part of his or her investment in the securities in this offering, and may never see positive returns.

The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

The value of the promissory notes will be determined by the Company's senior management in accordance with U.S. generally accepted accounting principles. For example, the notes may be valued based on principal plus anticipated interest payments over the course of the term of the note.

22. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

An Investor in the promissory notes holds no position in the Company and will have no voting rights in the Company, and thus will be limited as to its ability to control or influence the governance and operations of the Company.

The marketability and value of the Investor's interest in the Company will depend upon many factors outside the control of the Investor. The Company will be managed by its officers and be governed in accordance with the strategic direction and decision-making of its board of directors, and the Investor will have no independent right to name or remove an officer or member of the board of directors of the Company.

23. What are the risks to purchasers associated with corporate actions, including additional issuances of securities, issuer repurchases of securities, a sale of the issuer or of assets of the issuer or transactions with related parties?

Additional issuances of securities. Following the Investor's investment in the Company, the Company may sell interests to additional investors, which will dilute the percentage interest of the Investor in the Company. The Investor may have the opportunity to increase its investment in the Company in such a transaction, but such opportunity cannot be assured. The amount of additional financing needed by the Company, if any, will depend upon the maturity and objectives of the Company. Kitsbow Apparel, PBC was incorporated in the State of Delaware in December 2021. Kitsbow LLC, the predecessor to Kitsbow Apparel, PBC, was formed in January 2012.

Since then, we have:

- Support employee ownership and the values of a Benefit Corporation
- 30,000+ customers with 1,000+ 5-star product reviews
- Rebuilding a rural town after 30 years of economic decline and loss of jobs

- Give customers what they really want with 4,600 size/color combinations

Historical Results of Operations

Our company was organized in December 2021 and has limited operations upon which prospective investors may base an evaluation of its performance.

Kitsbow LLC, the predecessor to Kitsbow Apparel, PBC, was formed in January 2012. The financial statements presented herein represent the operating history of Kitsbow LLC.

- *Revenues & Gross Margin.* For the period ended December 31, 2021, the Company had revenues of \$2,690,522 compared to the year ended December 31, 2020, when the Company had revenues of \$2,309,138. Our gross margin was 47.12% in fiscal year 2021, compared to 33.78% in 2020.

- *Assets.* As of December 31, 2021, the Company had total assets of \$2,091,140, including \$59,429 in cash. As of December 31, 2020, the Company had \$2,702,453 in total assets, including \$301,671 in cash.

- *Net Loss.* The Company has had net losses of \$2,279,917 and net losses of \$2,321,238 for the fiscal years ended December 31, 2021 and December 31, 2020, respectively.

- *Liabilities.* The Company's liabilities totaled \$5,318,220 for the fiscal year ended December 31, 2021 and \$3,649,615 for the fiscal year ended December 31, 2020.

Liquidity & Capital Resources

To-date, Kitsbow LLC has been financed with \$232,000 in debt (was forgiven January 2021) and \$3,137,804 in convertible notes. These notes were cancelled by the Noteholders on January 3, 2022, coincident with the acquisition of the assets of Kitsbow LLC by Kitsbow Apparel, PBC.

To-date, Kitsbow Apparel, PBC has been financed with \$5,100,000 in debt and \$901,113 in equity

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 6 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Kitsbow Apparel, PBC cash in hand is \$16,444, as of November 2022. Over the last three months, revenues have averaged \$255,000/month, cost of goods sold has averaged \$178,000/month, and operational expenses have averaged \$258,000/month, for an average burn rate of \$181,000 per month. Our intent is to be profitable in 15 months.

The previous financials are nearly irrelevant, as the company's expenses were very high in 2021 due to the cost of legal/professional fees in connection with the sale of Kitsbow LLC to the newly formed Kitsbow Apparel, PBC on January 3, 2022. Also the LLC sales in 2021 was 33% sale of PPE, which is less than 5% in 2022. The LLC sales in 2022 were 66% PPE. The new company, Kitsbow Apparel, PBC does not sell PPE. Expenses trending much lower, cost of goods lower, and sales only of apparel.

We are already revenue-generating (and have been for 10 years). We expect sales to increase 30% in 2023 over 2022. We expect \$600,000 in expenses (and \$600,000 in COGS) in the next 6 months.

We are not profitable. We will need between \$1.5m and \$2.0m to reach profitability in late 2023, of which \$1.0m is the goal of this raise.

We have several term loans with a CDFI (Community Development Financial Institution) and expect several government grants to land within the short-term. We estimate we can receive \$100K in these loans, and estimate we will be able to lower monthly burn to \$25K.

The projections herein are forward looking and cannot be guaranteed.
