We are an early-stage company and there is execution risk. Our current business model and technology platform are still in early stages of commercialization. We have not yet achieved consistent profitability and expect to incur operating losses for the foreseeable future. Our success depends on our ability to execute product development, and scale subscriber acquisition. If we fail to achieve sufficient scale, manage costs, or convert user engagement into revenue, our financial performance could be materially adversely affected.

User Behavior. The economics of the company depend on the movie going habits of the users. If subscribers watch more often or attend premium and peak show times, then there are potential negative impacts to the margins of the business. High usage and increased ticket prices which are determined at the theater level may increase cost and reduce profitability.

We operate in a highly competitive and rapidly evolving entertainment landscape. The theatrical and entertainment industries are undergoing significant structural change. We compete not only with other movie-theater subscription services (including those operated by major theater chains) but also with streaming platforms, gaming, and other digital entertainment options. Consumer behavior is ever evolving. If we cannot effectively differentiate our offering or acquire and retain subscribers at sustainable costs, our business and financial performance may be materially adversely affected.

Our business model may involve novel technology, data, and regulatory risks, including digital-asset or "fan-engagement" features. Certain future aspects of our platform may incorporate loyalty or tokenized engagement features, prediction-based interactions, or gamified user experiences. These elements could be subject to complex and evolving regulation under federal or state law, including securities, gambling, consumer-protection, or privacy statutes. Regulatory authorities could determine that aspects of our program require additional licenses, registrations, or compliance measures that we do not currently possess. Any such regulatory developments could result in delays, costs, or limitations on our business model.

We may require additional capital, and future financing may dilute investors or fail to materialize. We anticipate that our growth strategy—including platform development, marketing, and theater-partner expansion—will require additional funding beyond the proceeds of this Reg CF offering. There is no assurance that we will achieve profitability or secure future capital on acceptable terms. If additional financing is unavailable, we may need to curtail operations or modify our business plan. Future financing rounds may result in dilution to current investors or the issuance of securities with rights senior to those offered in this round.

Our assumptions regarding user behavior, growth, and profitability may not prove accurate. Our projections depend on numerous assumptions, including subscriber growth, average usage frequency, churn rates, and pricing. These assumptions are inherently uncertain. Actual results may differ materially due to competition, consumer trends, marketing effectiveness, or macroeconomic factors. Failure to achieve sufficient user adoption or retention could prevent us from reaching scale or profitability. Operational risks—including delays in platform development, vendor execution, or data-security incidents—could further impact performance.

Our platform depends on complex technology and data systems that may fail or underperform. Our business relies heavily on proprietary software, third-party integrations, and mobile applications to manage user subscriptions, process transactions, and deliver personalized experiences. Any system outage, software bug, cyberattack, or integration failure could interrupt service, degrade the user experience, or compromise sensitive information. These events could damage our reputation, reduce subscriber trust, and lead to loss of revenue. Because our engineering resources are limited, it may take significant time and expense to remediate technical failures or adapt to evolving mobile-app, ticketing, or payment-platform requirements.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Raising our maximum would help us create enough runway to get us well into revenue generation on the Mogul side of the business, which is a higher margin business. Something closer to the minimum raise will help us with product development and holiday growth.

The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

MoviOne Inc. is offering up to 398,835 shares of Series A Preferred Stock, at a price per share of \$2.5073.

The campaign maximum is \$999,999.00 and the campaign minimum is \$50,000.58.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. While the Issuer may be required to pay an annual administrative fee for the maintenance of the SPV, investors should note the Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a

successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. This means that the pro-rata portion of the Company represented by the Investor's securities will decrease, which could also diminish the Investor's voting and/or economic rights. In addition, as discussed above, if a majority-in-interest of holders of securities with voting rights cause the Company to issue additional equity, an Investor's interest will typically also be diluted.

Based on the risk that an Investor's rights could be limited, diluted or otherwise qualified, the Investor could lose all or part of his or her investment in the securities in this offering, and may never see positive returns.

20. How could the exercise of rights held by the principal shareholders identified in Question 6 above affect the purchasers of the securities being offered?

As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. Other holders of securities of the Company may also have access to more information than the Investor, leaving the Investor at a disadvantage with respect to any decisions regarding the securities he or she owns. **The shareholders** have the right to redeem their securities at any time. **Shareholders** could decide to force the Company to redeem their securities at a time that is not favorable to the Investor and is damaging to the Company. Overview

The Company operates MoviePass, a movie-going subscription service that allows subscribers to purchase same-day movie tickets through a credit-based system. Members pay a monthly subscription fee to receive credits that may be redeemed for movie tickets at participating theaters nationwide. The Company relaunched MoviePass with multiple pricing tiers that vary by geographic region and market costs of moviegoing. The subscription model is designed to enhance theater attendance and offer data-driven insights to exhibitors and studios while providing consumers with flexible, cost-effective access to movies.

Milestones

MoviOne Inc. was incorporated in the State of Delaware in January 2022.

Since then, we have:

- Original Co-Founder Stacy Spikes bought MoviePass back from private equity ownership
- Epic turnaround story featured in the HBO Original documentary produced by Mark Wahlberg
- \$14M in annual recurring revenue and 2.8M movie visits booked since relaunch
- 630,000+ waitlist for Mogul by MoviePass - the first prediction market for film & entertainment
- Backed by top VCs including Lightship Capital, Harlem Capital, Wavemaker and more
- Featured in Vanity Fair, Rolling Stone, Hollywood Reporter, TIME, and the New York Times
- First-mover where movies meet fantasy sports, gaming, & prediction markets

Historical Results of Operations

Our company was incorporated in January 2022 and has limited operations upon which prospective investors may base an evaluation of its performance.

- **Revenues & Gross Margin.** For the period ended December 31, 2024, the Company had revenues of \$14,115,925 compared to the year ended December 31, 2023, when the Company had revenues of \$14,583,866. Our gross margin was 17.06% in fiscal year 2024, and 6.76% in 2023.
- **Assets.** As of December 31, 2024, the Company had total assets of \$1,656,518, including \$1,079,437 in cash. As of December 31, 2023, the Company had \$1,478,178 in total assets, including \$975,954 in cash.
- **Net Loss.** The Company has had net losses of \$5,507,317 and net losses of \$3,597,377 for the fiscal years ended December 31, 2024 and December 31, 2023, respectively.
- **Liabilities.** The Company's liabilities totaled \$1,137,812 for the fiscal year ended December 31, 2024 and \$1,695,761 for the fiscal year ended December 31, 2023.

Liquidity & Capital Resources

To-date, the company has been financed with \$250,000 in debt, \$11,375,377 in equity, and \$2,749,998 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 3 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 7 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

MoviOne Inc. cash in hand is \$537,551.25, as of October 2025. Over the last three months, revenues have averaged \$1,047,741/month, cost of goods sold has averaged \$784,520/month, and operational expenses have averaged \$375,905/month, for an average burn rate of \$112,684 per month. Our intent is to be profitable in 12 months.

The Company invested in the product development of Mogul in early 2025 through its launch in Q3 2025. As the build was completed and the product launched into Beta, the development costs have come down significantly and the Company will move into growth mode for marketing purposes and pursue licenses for Mogul.

We expect revenues and expense to be flat to slightly up over the next 3-6 months as we go into holiday season for traditional MoviePass subscription business as well as launching Mogul into revenue generation.

MoviOne is not yet profitable but expects to be in 12 months. The traditional MoviePass business will continue to scale with the cyclical nature of summer and holiday high season for movie going, while the Company focuses on monetizing the Mogul business and scaling that in 2026. Mogul will have more favorable profit margins, and to reach profitability the Company expects Mogul to outpace MoviePass subscription business in revenues by the end of Q2. We need \$10M in funding to reach profitability.

Besides Wefunder, the Company has access to credit and equity fundraising and plans to cover short-term burn with the cash balance.

All projections in the above narrative are forward-looking and not guaranteed.

3. the issuer has filed at least three annual reports and has total assets that do not exceed \$10 million;
4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
