Dependence on raising capital:Our ability to grow depends on raising capital. Without funding, we may be unable to finance production, marketing, or the team needed to reach our growth goals. As a result, projected sales may not be

achieved

Reliance on major distributors and Whole Foods Market:Much of our sales and brand visibility depend on partners like Whole Foods Market, UNFI, Dora's Naturals, and Skurnik. Any reduction in orders, shelf space, or distributor support could significantly impact our revenue.

Limited sales and marketing resources:We currently operate with a small team and modest marketing budget. Until we raise additional capital, our ability to build awareness and drive sales may be limited.

Operational and staffing risks:As a growing company, we must continue building the right team and systems to support expansion. Recruiting and retaining experienced personnel is essential, and limited staffing or execution capacity could slow growth or strain operations.

Production and working-capital constraints:Manufacturing and distribution require significant upfront cash. If we cannot raise or generate enough capital in time, we may face production delays or out-of-stock issues that hurt sales.

Competition in the beverage industry:We operate in a fast-growing but competitive non-alcoholic beverage category. Larger brands or new entrants with more resources could take market share or limit our growth.

Volatile ingredient and packaging costs:Prices for ingredients, bottles, and freight can fluctuate widely. Rising costs or supply-chain issues could reduce our profit margins.

Future dilution risk:If we raise more capital in the future, we may issue new SAFEs or shares at different valuations, which could dilute the ownership percentage of current investors.

Existing debts and financial obligationsWe have outstanding payables and prior-year debts that may limit our cash flexibility. Delays in raising new funds or slower-than-expected sales could affect our ability to repay them on time.

Operational risks from national expansionAs we expand into more regions and accounts, we face greater logistical and management challenges. Limited staff or infrastructure could make scaling nationwide more difficult than expected.

Illiquidity and SAFE-holder limitationThe company may never raise a future equity financing, convert the SAFEs, or experience a liquidity event such as a sale or IPO. SAFE holders could be left holding their securities indefinitely. These securities are illiquid, have no secondary market, no voting rights, and no claim to company assets or profits until a conversion event occurs.

Small management team and founder dependence:Our future success depends on the efforts of a small management team, including our founder and CEO, Karl Franz Williams. Karl created the brand and serves as the public face of Uncle Waithley's—his image and family story are integral to the company's identity. The loss or reduction of his involvement could materially affect product quality, brand perception, and operations until additional leadership and production capacity are in place.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

The intermediary will notify investors when the target offering amount has been met. Ownership and Capital Structure

THE OFFERING

13. Describe the terms of the securities being offered.

To view a copy of the SAFE you will purchase, please see [Appendix B, Investor Contracts](#). The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **Preferred Stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **Preferred Stock**, Investors will receive a number of shares of **Preferred Stock** calculated using the method that results in the greater number of **Preferred Stock**:

- i. the total value of the Investor's investment, divided by
 - a. the price of **Preferred Stock** issued to new Investors
- ii. if the valuation for the company is more than **\$10,800,000.00** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of
 - a. the Valuation Cap divided by
 - b. the total amount of the Company's capitalization at that time.
- iii. For investors up to the first **\$100,000.00** of the securities, investors will receive a valuation cap of **\$10,000,000.00** Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the

threshold limit noted above is met.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **Preferred Stock**, Investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

- i. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
- ii. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
- iii. Senior to payments for Common Stock.

VIP Bonus

Uncle Waitheley's Beverage Company will offer a discount to the normal terms listed in this Form C for all investments that are committed by investors who are part of Wefunder, Inc's VIP program. This means eligible Wefunder investors will receive a discount for any securities they purchased in this offering. For more specific details on the company's discount, please review the description of the terms above.

The discount is only valid until the offering closes. Investors eligible for the bonus will also receive priority if they are on a waitlist to invest and the company exceeds its maximum funding goal. They will be given the first opportunity to invest if space in the offering becomes available due to the cancellation or failure of previous investments.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. While the Issuer may be required to pay an annual administrative fee for the maintenance of the SPV, investors should note the Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her

authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

- i. the Investor or
- ii. the majority-in-interest of all then-outstanding Safes with the same "Post-Money Valuation Cap" and "Discount Rate" as this Safe (and Safes lacking one or both of such terms will be considered to be the same with respect to such term(s)), provided that with respect to clause (ii):
 - A. the Purchase Amount may not be amended, waived or modified in this manner,
 - B. the consent of the Investor and each holder of such Safes must be solicited (even if not obtained), and
 - C. such amendment, waiver or modification treats all such holders in the same manner. "Majority-in-interest" refers to the holders of the applicable group of Safes whose Safes have a total Purchase Amount greater than 50% of the total Purchase Amount of all of such applicable group of Safes.

Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal, Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor:

The Company has only one class of stock — Common Stock. All shares of Common Stock have identical rights and privileges, including dividend rights, liquidation rights, and voting rights, except as noted below. Certain investors from a prior Regulation CF offering (conducted on StartEngine) executed an irrevocable Voting Proxy, designating the Company's CEO, Karl Franz

Williams, as their proxy to vote their shares on all matters. This arrangement does not alter the economic rights of those shares but consolidates voting authority for administrative efficiency.

Other than this proxy arrangement, all Common Stock carries the same rights, and the Company has no Preferred Stock or other classes of equity outstanding. In the event the SAFE converts, it will convert into Preferred Stock. Preferred Stock will have liquidation preference over common stock.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

The initial amount invested in a SAFE is determined by the investor, and we do not guarantee that the SAFE will be converted into any particular number of **shares of Preferred Stock**. Milestones

Uncle Waithley's Beverage Company Inc was incorporated in the State of Delaware in September 2020

Delaware in September 2020.

- Added 350+ on- and off-premise accounts since April
- 166 new Whole Foods stores aboard since June 2025
- Created by Yale-educated serial entrepreneur and renown mixologist Karl Franz Williams.
- One of the only NA beverages with Scotch Bonnet pepper.
- Whole Foods is an equity investor in our brand.
- Selected for UNFI's UpNext program, opening access to 30,000+ accounts.

Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2024, the Company had revenues of \$222,494 compared to the year ended December 31, 2023, when the Company had revenues of \$154,883.
- *Assets.* As of December 31, 2024, the Company had total assets of \$132,382, including \$23,566 in cash. As of December 31, 2023, the Company had \$88,163 in total assets, including \$1,553 in cash.
- *Net Loss.* The Company has had net losses of \$347,732 and net losses of \$282,180 for the fiscal years ended December 31, 2024 and December 31, 2023, respectively.
- *Liabilities.* The Company's liabilities totaled \$256,882 for the fiscal year ended December 31, 2024 and \$139,645 for the fiscal year ended December 31, 2023.

Related Party Transaction

Liquidity & Capital Resources

To-date, the company has been financed with \$335,278 in debt, \$398,672 in equity, \$100,000 in convertibles, and \$270,000 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 2 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 18 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Uncle Waitthley's Beverage Company Inc cash in hand is \$12,497, as of November 2025. Over the last three months, revenues have averaged \$24,300/month, cost of goods sold has averaged \$14,580/month, and operational expenses have averaged \$22,450/month, for an average burn rate of \$12,730 per month. Our intent is to be profitable in 14 months.

There have been no material changes or trends in our finances or operations since the date of the financial statements published in May 2025. Any events occurring after December 31, 2024 and prior to May 15, 2025 are disclosed in Note 10 ("Subsequent Events") of the accompanying financial statements.

We anticipate generating approximately \$40,000-\$50,000 per month in revenue over the next 3-6 months. This projection is driven by accelerating sales in our new Whole Foods Market accounts and a focused commitment to grow our Tri-State business through Skurnik and Dora's Naturals.

Operating expenses are budgeted at approximately \$26,000 per month and cost of goods sold (COGs) are expected to be \$29,250 per month. We currently hold sufficient finished-goods inventory—already paid for—to support roughly 60 days of business at this sales rate. After that period, additional production will be required, which we plan to fund through an existing line of credit with 90-day repayment terms.

With this combination of existing inventory, disciplined expense management, and short-term financing in place, we expect to maintain steady operations while continuing to invest in sales and marketing growth.

We are not yet profitable. We expect to need \$1.2M in funding to reach profitability. Based on our current cost structure and margins, we estimate that annual sales of approximately \$1.2 million will allow us to reach break-even profitability.

The capital raised through this offering will be used primarily to expand sales and marketing efforts that drive new distribution and increase velocity in existing accounts. Day-to-day working capital needs are supported by operating revenue, and we have secured a 90-day line of credit to finance production runs. This structure allows us to fund inventory through short-term credit and repay it with realized sales, while directing growth capital toward the activities that accelerate our path to profitability—projected to occur in approximately 14 months (mid-

2027).

In addition to this Wefunder campaign, we have a community of over 118 existing investors from our previous crowdfunding and Friends & Family Reg D rounds who continue to support the business and represent a strong potential source of follow-on capital.

Operationally, we are generating approximately \$40-50K in monthly revenue, which supports our short-term working-capital needs. We also maintain a 90-day line of credit to fund production cycles, allowing us to manage inventory without diverting growth capital.

During the campaign, we intend to draw down funds from Wefunder as needed (consistent with platform guidelines) to support sales and marketing initiatives while maintaining sufficient cash to cover our short-term operating burn.

All projections in the above narrative are forward-looking and not guaranteed.
