We operate in a highly competitive market cybersecurity, and the size and resources of some of our larger competitors may allow them to compete more effectively than we can.

Enterprise sales cycle tend to be long (3 to 6+ months) and can impact our short term cashflow position.

We are actively addressing this challenge by adding a 'starter' SaaS offering for the enterprises that tend to have a much short (~ 30 days) sales cycle.

Current adverse macro economic trends might impact enterprise IT's short term budgets and make it hard for them to adopt a new solution like ours.

Hiring specialized and highly skilled technical resources (software programmers, cyber threat analysts, etc.) continues to be very challenging in this tight job market.

Scaling Go-To-Market for a new SaaS company requires significant marketing budgets and can negatively impact the cashflow position.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Regular shares have voting rights. Profit units are owned by employees. This SAFE will convert to Preferred units. Preferred units have liquidation preference over regular units. Preferred units do not have voting rights. Preferred Units have not yet been authorized.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

As holders of a majority-in-interest of voting rights in the Company, the unitholders may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, the unitholders may change the terms of the operating agreement for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. The unitholders may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 12 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. We are not profitable yet. We plan to reach profitability in the next 12 months. We are currently investing significant development resources in new advanced features that various enterprise customer are asking. These new features will allows to increase our average revenue per customer up by 70% and really help us to reach profitability. We are temporarily currently operating at a positive margin, but are about to hire additional engineers that will drive up our burn rate.
