Busa Beverages, Inc is offering up to 16,466 shares of Common Stock, at a price per share of \$57.41.

Investors in the first \$99,998.07 of the offering will receive stocks at a price per share of \$47.37, and a pre-money valuation of \$6,600,000.00 Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met.

The campaign maximum is \$780,000.00 and the campaign minimum is \$50,000.00.

VIP Bonus

Busa Beverages will offer a discount to the normal terms listed in this Form C for all investments that are committed by investors who are part of Wefunder, Inc's VIP program. This means eligible Wefunder investors will receive a discount for any securities they purchased in this offering. Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. While the Issuer may be required to pay an annual administrative fee for the maintenance of the SPV, investors should note the Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxv

and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

Historical Results of Operations

Our company was incorporated in August 2022 and has limited operations upon which prospective investors may base an evaluation of its performance.

- **Revenues & Gross Margin.** For the period ended December 31, 2024, the Company had revenues of \$194,504 compared to the year ended December 31, 2023, when the Company had revenues of \$129,515. Our gross margin was 40.28% in fiscal year 2024, and 42.25% in 2023.

- **Assets.** As of December 31, 2024, the Company had total assets of \$634,501, including \$0 in cash. As of December 31, 2023, the Company had \$615,841 in total assets, including \$4,151 in cash.

- **Net Loss.** The Company has had net losses of \$242,173 and net losses of \$279,060 for the fiscal years ended December 31, 2024 and December 31, 2023, respectively.

- **Liabilities.** The Company's liabilities totaled \$132,314 for the fiscal year ended December 31, 2024 and \$125,101 for the fiscal year ended December 31, 2023.

Liquidity & Capital Resources

To-date, the company has been financed with \$119,161 in debt and \$708,322 in equity.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 18 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Busa Beverages, Inc cash in hand is \$19,000, as of January 2026. Over the last three months, revenues have averaged \$14,500/month, cost of goods sold has averaged \$3,200/month, and operational expenses have averaged \$2,100/month, for an average net margin of \$9,200 per month. Our intent is to be profitable in 6 months.

Since the date our financials cover, we have shifted to a very strong direct to consumer and online platform that will help drive off premise sales in our California stores, specifically with KegnBottle online. Our proof of concept of who buys the brand and why has helped us focus heavily on this new model. We have also signed with a Northwest Distributor who handles states where Busa is considered beer and wine, allowing us to be sold in over 3000 new accounts. Alberton's NW is bringing on Busa in q2 of next year. We also signed with an Hawaiian distributor, Odom, which is targeting on premise retail and hotels starting in Q2.

We expect the revenues to triple in the next 6 months due to our new platform of online sales and bringing on Odom distributing in the Northwest and Hawaii. This launch into the social media and paid ads will help drive direct to consumer sales and brand awareness. We believe that \$250k in new capital will help drive not only future production, but also the online and direct to consumer channel that we have designed. I would expect that would happen six months after the raise as the consumer response to the product is so strong. We also have a new broker in California who is 1099 and helping push our retail and on premise retail accounts. Over the next 6 months, we expect revenues of \$210,000 and expenses of \$20,000-45,000.

We are not profitable yet, but we believe we will be profitable by Q3 of 2026 simply because we will be producing another 1800 case batch that will be ready in Q2, and with the finalized agreements with Odom distribution and the adoption in Idaho in the northwest into Albertsons, we believe it will be a strong year. We anticipate we will need \$400,000 in funding to reach profitability. We have a new agreement with Keg N Bottle online, which we will be pushing a large targeted ad campaign through to drive sales into the summer along with a very strong social media team that is focused on e-commerce specifically.

Besides funds raised through Wefunder, we do have commitments from a few of the founding members to inject capital into the company as needed, and strong restaurant sales out of the three restaurants in San Diego are helping to cover these short falls
