- Problems with the supply chain, specifically buckwheat, causes us to not be able to produce our bread
- Costs of packaging increase significantly making our product more expensive to produce and require us to raise our prices
- Costs of shipping with FedEx and UPS increase significantly causing the price to the customer for Direct to Consumer to be too expensive
- Large competitors enter the space with a similar product formulation and sell for less than we are currently priced
- The economy takes a downturn and people can not afford to pay a premium for higher quality organic products
- Our landlord does not renew our lease at the end of the term (6.5 years from now) and we have to find a new space to produce our bread.

We can not produce enough bread in our facility to meet demand for Direct to Consumer and grocery stores and grocery store accounts or direct customers as a result

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Live Pacha, LLC is offering up to 16,870 Preferred A Units, at a price per unit of \$18.43.

Investors in the first \$249,998.88 of the offering will receive units at a price per unit of \$16.43, and a pre-money valuation of \$20,001,044.07 Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met.

The campaign maximum is \$350,957 and the campaign minimum is \$50,012.92. Note that Live Pacha, LLC plans on increasing the campaign maximum over the course the campaign, but will stay under \$618,000 in aggregate over a 12-month period.

#### VIP Bonus

PACHA will offer a discount to the normal terms listed in this Form C for all investments that are committed by investors who are part of Wefunder, Inc's VIP program. This means eligible Wefunder investors will receive a discount for any securities they purchased in this offering. For more specific details on the company's discount, please review the description of the terms above.

The discount is only valid until the offering closes. Investors eligible for the bonus will also receive priority if they are on a waitlist to invest and the company exceeds its maximum funding goal. They will be given the first opportunity to invest if space in the offering becomes available due to the cancellation or failure of previous investments.

#### Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. While the Issuer may be required to pay an annual administrative fee for the maintenance of the SPV, investors should note the Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

#### Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

#### Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

As holders of a majority-in-interest of voting rights in the Company, **the unitholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the unitholders** may change the terms of the Operating Agreement for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The unitholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. Live Pacha, LLC ("the Company") was formed in California on June 4th, 2020. The Company earns revenue manufacturing and selling bread to grocery stores and direct-to consumers throughout the United States. The Company's headquarters is in Vista, CA.

#### Milestones

Live Pacha, LLC was organized in the State of California in June 2020.

Since then, we have:

- \$5M run rate (170% YOY growth)
- High-velocity sales and nationwide distribution with Whole Foods
- Profitable E-commerce channel with steady sales and reduced ad spend over time

- Our OG recipe has only TWO ingredients: Sprouted Buckwheat and Salt!

- Leading packaging innovation in the bread category with 100% home-compostable packaging
- FIRST and ONLY verified regenerative bread sold nationwide (Soil & Climate Initiative Verified)

#### Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2024, the Company had revenues of \$4,087,889 compared to the year ended December 31, 2023, when the Company had revenues of \$2,085,137. Our gross margin was 21.98% in fiscal year 2024
- *Assets.* As of December 31, 2024, the Company had total assets of \$2,632,849, including \$381,269 in cash. As of December 31, 2023, the Company had \$2,383,735 in total assets, including \$131,389 in cash.
- *Net Loss.* The Company has had net losses of \$1,135,816 and net losses of \$1,116,285 for the fiscal years ended December 31, 2024 and December 31, 2023, respectively.
- *Liabilities.* The Company's liabilities totaled \$1,910,939 for the fiscal year ended December 31, 2024 and \$2,086,278 for the fiscal year ended December 31, 2023.

#### Liquidity & Capital Resources

To-date, the company has been financed with \$1,253,242 in debt, \$2,621,355 in equity, and \$200,000 in convertibles.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 5 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 24 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### Runway & Short/Mid Term Expenses

Live Pacha, LLC cash in hand is \$186,886, as of June 2025. Over the last three months, revenues have averaged \$415,900/month, cost of goods sold has averaged \$343,724/month, and operational expenses have averaged \$171,760/month, for an average burn rate of \$99,584 per month. Our intent is to be profitable in 8 months.

Since the date of our financials, we have secured 780 new Albertsons stores that will launch in November 2025 and we will also be launching Tortillas in Whole Foods nationwide at the end of the year (date to be determined). We have been investing in raw materials and equipment to be able to produce tortillas on a larger scale.

We expect our revenue to increase significantly as we launch new stores including Sprouts (to be determined on Date), Whole Foods tortillas (to be determined on Date), Albertsons (Nov 2025). Specifically, we expect to generate \$3M in revenue in the next 3-6 months while incurring approximately \$3.6M in expenses. Each month that we launch a new store we also expect a large cash demand for slotting fees. We anticipate becoming cash positive in 8 months. The capital raised here on Wefunder plus another \$400K from direct investors will get us to that point.

We are not profitable. We could get to profitability with approximately \$1M in capital combined from Wefunder and from direct investors. We expect to reach that point in the next 8 months.

We have access to capital through direct investors and short term loans based on our Shopify sales to cover short-term burn if necessary.
