Netsave, an early-stage startup incorporated on April 15, 2021, faces the typical risks associated with new companies, such as operating losses and limited information on its business plan, operations, and financials. Investors should consider these risks, including the challenges of entering a competitive market with more established and better-funded companies. Netsave needs to conduct further research and product development, expand its sales and support teams, manage operations, develop strategic relationships, control costs, enhance its brand, and attract qualified personnel. Additionally, the company is subject to general business risks like economic conditions, regulatory changes, resource scarcity, and competition. While Netsave believes its estimates for required capital, personnel, equipment, and facilities are reasonable, the accuracy of these estimates can only be determined over time. No assurance of success can be given, and the company's potential success must be weighed against the common challenges of starting a new business.

We face challenging competitions in the industry against leading companies such as OfferUp, Mercari, Whatnot, Craigslist, and Facebook Marketplace. These competitors have more financial, technical, and human resources; superior expertise in research, development, and marketing. They may compete with us for talent and technology acquisitions. Additionally, smaller or early-stage companies, particularly those collaborating with established firms, could become significant competitors. As a result, competitors may commercialize their products faster and more effectively, negatively impacting our competitive position, market acceptance, and revenue generation.

The Company's leadership may occasionally modify the business plan, products, and model to adapt to new technologies and market changes. These adjustments may also increase the risks. Strategic responses to competition

such as changes in pricing, products/services, and marketing could negatively impact the Company's business, operational results, and financial condition.

The return on investment in startups is highly variable and not guaranteed. While some startups may succeed and provide significant returns, many will not and may generate minimal or no returns at all. The amount, frequency, and timing of any returns will vary. Therefore, you should not invest funds that you may need to earn a regular, predictable, and stable return.

Returns on startup investments may take several years to materialize, with most startups requiring five to seven years to generate returns. Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle (“SPV”). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors’ interests in the investments will be recorded in each investor’s “Portfolio” page on the Wefunder platform. All references in this Form C to an Investor’s investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **preferred stock** in the Company ("Preferred Stock"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to

other Investors.

*Conversion to Preferred Equity.* Based on our SAFEs, when we engage in an offering of equity interests involving **preferred stock**, Investors will receive a number of shares of preferred stock calculated using the method that results in the greater number of **preferred stock**: the total value of the Investor's investment, divided by the price of **preferred stock** issued to new Investors, or if the valuation for the company is more than **\$31,250,000.00** (the "Valuation Cap"), the amount invested by the Investor divided by the quotient of the Valuation Cap divided by the total amount of the Company's capitalization at that time.

For investors up to the first **\$100,000.00** of the securities, investors will receive a valuation cap of **\$25,000,000.00**. Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met.

*Additional Terms of the Valuation Cap.* For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

*Liquidity Events.* If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **preferred stock**, Investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

*Liquidity Priority.* In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
2. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and Senior to payments for Common Stock.

### **VIP Bonus**

Netsave® will offer a discount to the normal terms listed in this Form C for all investments that are committed by investors who are part of Wefunder, Inc's VIP program. This means eligible Wefunder investors will receive a discount for any securities they purchased in this offering. For more specific details on the company's discount, please review the description of the terms above.

The discount is only valid until the offering closes. Investors eligible for the bonus will also receive priority if they are on a waitlist to invest and the company exceeds its maximum funding goal. They will be given the first opportunity to invest if space in the offering becomes available due to the cancellation or failure of previous investments.

### **Securities Issued by the SPV**

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely

~~and all of the proceeds from the sale of its securities directly to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.~~

### **Voting Rights**

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

### **Proxy to the Lead Investor**

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

### **Restriction on Transferability**

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

### **Overview**

A safer and more sustainable alternative to Craigslist innovating the \$77B US resale market

OfferUp, Craigslist, and Facebook Marketplace haven't effectively tackled the user safety problem in online resale. My personal experiences on those sites led me to start Netsave, aiming to build a hassle-free and legitimate community where real people can buy and sell authentic products.

Netsave is an early-stage resale social marketplace connecting neighbors to buy and sell locally to support the growth of their local economies.

We are planning to scale and expand across the United States, and internationally in Canada, Australia, United Kingdom, Germany, France, Spain, South Korea... Our exit strategy includes to become a growth-stage and publicly traded company or get acquired by an industry. So, we hope to be a global and publicly traded company within 5 to 7 years (not guaranteed).

### **Milestones**

NETSAVE INC was incorporated in the State of Delaware in April 2021.

Since then, we have:

- A public benefit corporation with cutting-edge solutions to the resale marketplace industry
- \$ A \$77B annual US Resale Market, projected to reach \$100B by 2026
-  Expansion Plan: All US states, top 1-3 cities in CA, AU and UK in a year
- \$ Exit Strategy: Growth Stage & IPO by 2027, or Growth Stage & Acquisition (Not guaranteed)

The Company is subject to risks and uncertainties common to early-stage companies. Given the Company's limited operating history, the Company cannot reliably estimate how much revenue it will receive in the future.

Our company was organized in April 2021 and has limited operations upon which prospective investors may base an evaluation of its performance.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 6 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. ### **Runway & Short/Mid Term Expenses**

NETSAVE INC cash in hand is \$10,500, as of June 2024. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$8,000/month, for an average burn rate of \$8,000 per month. Our intent is to be profitable in 24 months.

Since the date our financials cover, we raised a SAFE note investment, founder contribution has increased, and cut down monthly operating expenses.

With a successful fundraising round invested in the company to fully launch and execute its marketing strategies, we believe we will generate between \$900K to \$1.2M (We put it down as \$1M) in the next 5-6 months. We expect expenses to scale to approximately equal revenues over the same period.

We are not profitable yet. We'll require a lot more in funding (estimated \$5M+) in order to become profitable. We're planning to increase expenses as we raise more funding and generate more revenues.

Besides the money raised through Wefunder, we are also raising funding through friends and family SAFE notes, traditionally referred to as F&F round.

The Lead Investor. As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.
