We are currently operating on a low code platform while we continue to build IP within our data science team. We have accounted for a replatform of our tech architecture in the next 18 months.

Market conditions are challenging for b2b SaaS companies but we believe we're well-positioned as the economy improves to leverage our position in the build v. buy cycles.

Our biggest focus in the next 12-18 mos. will be building a repeatable sales process and demonstrating product-market fit.

Long Sales Cycle in Enterprise Market: Selling into the enterprise market often involves longer sales cycles compared to smaller businesses or individual customers. This extended sales cycle may result in delayed revenue generation, which can strain the company's cash flow and hinder its ability to meet financial obligations.

Noisy and Competitive HR Space: The human resources (HR) industry is known for being noisy and highly competitive. The market is saturated with numerous companies offering HR solutions, making it challenging for a new entrant to stand out and gain market share. The company may face difficulty in capturing the attention of potential customers, resulting in slower adoption rates and revenue growth.

This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides investors the right to **preferred stock** in the Company ("**Preferred Stock**"). when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other investors.

Conversion to Preferred Equity. Based on our SAFEs, when we engage in an offering of equity interests involving **preferred stock**, **investors will receive a number of shares of preferred stock** calculated using the method that results in the greater number of **preferred stock**:
i. the total value of the investor's investment, divided by the price of **preferred stock** issued to new investors, or
ii. if the valuation for the company is more than **\$6,000,000.00** (the "Valuation Cap"), the amount invested by the investor divided by the quotient of
a. the Valuation Cap divided by
b. the total amount of the Company's capitalization at that time.

Additional Terms of the Valuation Cap. For purposes of option (ii) above, the Company's capitalization calculated as of immediately prior to the Equity Financing and (without double-counting, in each case calculated on an as-converted to Common Stock basis):

- Includes all shares of Capital Stock issued and outstanding;
- Includes all Converting Securities;
- Includes all (i) issued and outstanding Options and (ii) Promised Options; and
- Includes the Unissued Option Pool, except that any increase to the Unissued Option Pool in connection with the Equity Financing shall only be included to the extent that the number of Promised Options exceeds the Unissued Option Pool prior to such increase.

Liquidity Events. If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to investors in the SAFEs receiving **preferred stock**, investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

Liquidity Priority. In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock. The Investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
2. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
3. Senior to payments for Common Stock.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the Investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

The company has not yet authorized preferred stock, which investors would receive in this offering if the SAFE converts as part of an equity financing event. Preferred stock has a liquidation preference over common stock.

18. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of security identified above?

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

Milestones

Illoominus Software, Inc. was incorporated in the State of Georgia in September 2021.

Since then, we have:

- In one year, achieved a product in market with paying customers (\$100K ARR)
- Customers include the 2nd largest US Telco, Cox, and 3 unicorns: Pendo.io, Greenlight, + Clearcover.
- Data and research published in places like MIT Sloan Review.
- HR Exec, the largest HR marketplace, said if anyone is going to solve this problem, it's this team.
- Backed by groups like Techstars and Plug and Play.

Historical Results of Operations

Our company was organized in September 2021 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2022, the Company had revenues of \$45,992.60 compared to the year ended December 31, 2021, when the Company had revenues of \$0. Our gross margin was 78.44% in fiscal year 2022.
- *Assets.* As of December 31, 2022, the Company had total assets of \$76,746.48, including \$49,246.48 in cash. As of December 31, 2021, the Company had -\$1,198.92 in total assets, including -\$1,198.92 in cash.
- *Net Loss.* The Company has had net losses of \$90,263.49 and net losses of \$118.98 for the fiscal years ended December 31, 2022 and December 31, 2021, respectively.
- *Liabilities.* The Company's liabilities totaled -\$2,569 for the fiscal year ended December 31, 2022 and -\$845 for the fiscal year ended December 31, 2021.

Liquidity & Capital Resources

To-date, the company has been financed with \$100,000 in convertibles, \$20,000 in equity, and \$30,000 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 18 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 11 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Illoominus Software, Inc. cash in hand is \$38,185, as of June 2023. Over the last three months, revenues have averaged \$12,186/month, cost of goods sold has averaged \$2,140/month, and operational expenses have averaged \$19,516/month, for an average burn rate of \$9,470 per month. Our intent is to be profitable in 12 months.

Since December the date of our financials, we have brought on 3 additional sales customers. We achieved \$100K in ARR within one year of launch. We have

paying customers. We achieved \$200K in ARR within one year of launch. We have added to our Community of People Leaders now including 51 leaders from across 39 organization who have attended 9 events this year. We've signed joint GTM partnerships with leading HR consultants who are bringing us to their clients. We've made significant progress on our product development and roadmap.

We expect to see our expenses increase to closer to \$40K/month in six months. We also hope to see our monthly revenues approach \$40K at the six month mark.

We are not profitable yet. We see ourselves getting to profitability in the next 12 months as we go up for a seed round to scale assuming we are able to raise approximately \$500k in total.

For additional capital outside of this offering, we are raising a \$500K pre-seed round that is 100% committed with angels and institutional investors.
