



Offering Statement for Smart Cups, Inc. ("Smart Cups")

Smart Cups, Inc. ("Smart Cups, Inc.," the "Company," "we," or "us"), is a California Corporation incorporated on 9/28/2023. The Company was originally organized as Smart Cups, LLC, a CA Limited Liability Company on 6/8/2015. The Company is holding the following offering:

Up to \$618,000 in Class A Common Stock at \$1.00 per share with a minimum target amount of \$10,000.00.

NOTE TO INVESTORS ABOUT THE SPV

Regulation Crowdfunding allows an issuer to use a special purpose vehicle, or SPV. The technical legal term is a “crowdfunding vehicle.”

In this case, while the name of the Company itself is Smart Cups, Inc., the name of the SPV is Smart Cups SPV, LLC. You and all the other Regulation Crowdfunding investors will invest in Smart Cups SPV, LLC and Smart Cups SPV, LLC will, in turn, use your money to invest in Smart Cups, Inc. Hence, Smart Cups SPV, LLC will be reflected as one investor in Smart Cups, Inc.

Smart Cups, Inc. believes this structure – with one investor rather than many – will make it easier to raise additional capital in the future because the Offering will leave the Company with only one investor on its capitalization table.

Smart Cups SPV, LLC will conduct no business other than to invest in Smart Cups, Inc. The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. Smart Cups SPV, LLC will be managed by the Company itself. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

Although Smart Cups, Inc. is a corporation, you will be an owner of Smart Cups SPV, LLC, which is a limited liability company. Hence, you will receive IRS Form K-1 for tax reporting purposes.

All the information about “the Company” in this Form C refers to Smart Cups, Inc., not to Smart Cups SPV, LLC unless otherwise indicated.

NOTE TO INVESTORS: As explained above, you will invest in Smart Cups SPV, LLC, not in the Company directly. You will receive an interest in Smart Cups SPV, LLC called “Investor Shares” while Smart Cups SPV, LLC will receive shares of Common Shares issued by the Company. The governing documents of Smart Cups SPV, LLC, being its Certificate of Formation and Limited Liability Company Agreement (EXHIBIT E and EXHIBIT G), and the Investor Shares to be issued to you from Smart Cups SPV, LLC, are intended to put you in the same position as if you had purchased shares of Common Shares directly from the Company.

Voting Proxy to the Manager

The SPV investor shares do not have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a voting proxy granted by Investor in the subscription agreement (Exhibit C), has appointed or will appoint the Manager, Smart Cups, Inc., as the Investor's true and lawful proxy (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by PicMii Crowdfunding, LLC, and (ii) execute, in connection with such voting power any instrument or document that the Manager determines is necessary and appropriate in the exercise of his or her authority. The Investor Shares shall have one hundred percent (100%) of the economic rights and no management rights other than to replace the Manager upon a majority vote at a duly called meeting. The Manager Shares shall be held only by Smart Cups, Inc., or its affiliates or assigns. The Manager Shares will confer no economic rights but shall confer one hundred percent (100%) of the management authority to the holders of the Manager Shares. The holders of Manager Shares shall have all rights necessary to manage the business affairs of the Company, including but not limited to, the authority to direct the acquisition, holding, and disposition of the Company's assets, and to make all decisions regarding the Company's operations without requiring the consent of the holders of the Investor Shares, subject to limitations in Delaware state law, participation in tender offers, mergers, acquisitions, or any other matters requiring shareholder approval.

Business and Anticipated Business Plan

Business Overview

Smart Cups is a patented technology platform that transforms how consumable products are produced, transported, and delivered. By printing ingredients directly onto surfaces, Smart Cups eliminates the need to ship liquid—dramatically reducing shipping weight, packaging waste, refrigeration requirements, and carbon emissions.

The company converts traditional liquid-based products—including beverages, nutrition, supplements, and medications—into stable dry formulations that can be printed onto a wide range of surfaces. When water is added at the point of use, the ingredients dissolve and recreate the finished product instantly.

In simple terms, instead of shipping water around the world, Smart Cups ships only the ingredients.

After years of research, intellectual property development, and real-world product launches, Smart Cups has validated its technology and is now transitioning into a scalable platform model designed to serve multiple industries globally.

Problem / Solution

The global beverage, supplement, and pharmaceutical industries ship billions of pounds of liquid every year—most of which is water. This results in:

- high transportation costs
- excessive packaging waste
- refrigeration requirements
- increased carbon emissions
- supply chain inefficiencies

Smart Cups solves this problem by printing ingredients directly onto surfaces, eliminating the need to transport water. Consumers simply add water at the point of use, significantly reducing the weight and environmental impact of the supply chain.

A study conducted by UCLA's Institute of the Environment and Sustainability, authored by Professor Deepak Rajagopal, demonstrated the logistical advantages of this approach. The study found that a single Class 6 or 7 beverage truck filled with Smart Cups can transport **21 times more beverage volume than PET bottles and 31 times more than glass bottles.**

When printed on PLA-based materials and paired with tap water, Smart Cups can reduce packaging materials by **20% compared to aluminum, 40% compared to plastic, and up to 90% compared to glass.**

Market Opportunity

Smart Cups' printed ingredient platform has potential applications across multiple global industries where consumable products are currently delivered in liquid form.

These markets include:

- Global Beverage Market (~\$1.9 trillion)
- Nutritional Supplements (~\$400B+)
- Functional Foods & Wellness (~\$300B+)
- Pharmaceutical Delivery Systems (~\$1.5T+)
- Pet Wellness & Nutrition
- Military and Humanitarian Aid

Because Smart Cups is a **platform technology rather than a single product**, it can be applied across virtually every consumable product category.

Rather than entering each market directly, Smart Cups' strategy is to scale through a **capital-light model that includes licensing, white-label partnerships, and strategic joint ventures with established brands and manufacturers.**

This allows partners to integrate Smart Cups' technology into their existing supply chains while Smart Cups generates revenue through licensing, partnerships, and selective product commercialization.

Gordon Ramsay's Food Stars (Winner)

Smart Cups founder and CEO Chris Kanik won Season One of FOX's *Gordon Ramsay's Food Stars*, securing a \$250,000 investment and bringing global awareness to the company's technology platform.

Smart Cups has an active Cooperative Research and Development Agreement (CRADA) with the U.S. Army (DEVCOM) to explore applications in field nutrition, hydration, and micronutrient delivery.

- A **coffee company** developing printed coffee products, targeting commercialization in 2026

Additionally, early-stage companies are inherently riskier than more developed companies. Prospective Investors should consult with their legal, tax and financial advisors prior to making an investment in the Securities. The Securities should only be purchased by persons who can afford to lose all of their investment.

Risks Related to the Company's Business and Industry

We have an operating history upon which you can evaluate our performance, and accordingly, our prospects must be considered in light of the risks that any new company encounters. The Company is in a transition phase from product commercialization to platform-scale licensing. There can be no assurance that we will ever operate profitably. The likelihood of our success should be considered in light of the problems, expenses, difficulties, complications and delays usually encountered by early-stage companies. The Company may not be successful in attaining the objectives necessary for it to overcome these risks and uncertainties.

Regulatory changes and uncertainties.

The Company operates in a highly regulated industry subject to substantial change. In addition, both its labor and customer base are licensed and regulated by local, state, and federal governments. Policies may be changed for several reasons including, but not limited to economic conditions, public safety, socio-political factors, and such. As policy changes are made by regulators, there is no guarantee that the company will be able to provide services in its current form, which may place a substantial hardship on operations, causing an Investor to lose all or a portion of their investment.

The amount of capital the Company is attempting to raise in this Offering may not be enough to sustain the Company's current business plan.

In order to achieve the Company's near and long-term goals, the Company may need to procure funds in addition to the amount raised in the Offering. There is no guarantee the Company will be able to raise such funds on acceptable terms or at all. If we are not able to raise sufficient capital in the future, we may not be able to execute our business plan, our continued operations may require a significant pivot in strategy and execution, which could cause an Investor to lose all or a portion of their investment.

We may face potential difficulties in obtaining capital

We may have difficulty raising needed capital in the future as a result of, among other factors, our lack of revenue, as well as the inherent business risks associated with our Company and present and future market conditions.

The Company's success depends on the experience and skill of its manager and other key personnel.

In particular, we are dependent on our managers. The loss of the Managers, the Principals or any other key personnel could harm the Company's business, financial condition, cash flow and performance. Accordingly, you should not invest in the Company unless you are willing to entrust all aspects of the management of the Company and the investment decisions we make on the behalf of the Company.

Although dependent on certain key personnel, the Company does not have any key person life insurance policies on any such people

We are dependent on certain key personnel in order to conduct our operations and execute our business plan, however, the Company has not purchased any insurance policies with respect to those individuals in the event of their death or disability. Therefore, if any of these personnel die or become disabled, the Company will not receive any compensation to assist with such person's absence. The loss of such person could negatively affect the Company and our operations. We have no way to guarantee key personnel will stay with the Company, as many states do not enforce non-competition agreements, and therefore acquiring key man insurance will not ameliorate all of the risk of relying on key personnel.

Damage to our reputation could negatively impact our business, financial condition and results of operations.

Our reputation and the quality of our brand are critical to our business and success and will be critical to our success as we form and advise new markets. Any incident that erodes confidence in our brand could significantly reduce the Company's value and damage our business. We may be adversely affected by any negative publicity, regardless of its accuracy. Also, there has been a marked increase in the use of social media platforms and similar devices, including blogs, social media websites and other forms of internet-based communications that provide individuals with access to a broad audience. The availability of information on social media platforms is virtually immediate as is its impact. Information posted may be adverse to our interests or may be inaccurate, each of which may harm our performance, prospects or business. The harm may be immediate and may disseminate rapidly and broadly, without affording us an opportunity for redress or correct.

Risks Related to the Offering

The U.S. Securities and exchange Commission does not pass upon the merits of the Securities or the terms of the Offering, nor does it pass upon the accuracy or completeness of any Offering document or literature.

You should not rely on the fact that our Form C is accessible through the U.S. Securities and Exchange Commission's EDGAR filing system as an approval, endorsement or guarantee of compliance as it relates to this Offering. The U.S. Securities and Exchange Commission has not reviewed this Form C, nor any document or literature related to this Offering.

Neither the Offering nor the Securities have been registered under federal or state securities laws.

No governmental agency has reviewed or passed upon this Offering or the Securities. Neither the Offering nor the Securities have been registered under federal or state securities laws. Investors will not receive any of the benefits available in registered Offerings, which may include access to quarterly and annual financial statements that have been audited by an independent accounting firm. Investors must therefore assess the adequacy of disclosure and the fairness of the terms of this Offering based on the information provided in this Form C and the accompanying exhibits.

The Company's management may have broad discretion in how the Company uses the net proceeds of the Offering.

Unless the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the use of proceeds from the Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

The Company has the right to limit individual Investor commitment amounts based on the Company's determination of an Investor's sophistication.

The Company may prevent any Investor from committing more than a certain amount in this Offering based on the Company's determination of the Investor's sophistication and ability to assume the risk of the investment. This means that your desired investment amount may be limited or lowered based solely on the Company's determination and not in line with relevant investment limits set forth by the Regulation CF rules. The Company has the right to extend the Offering Deadline.

In the event of the dissolution or bankruptcy of the Company, Investors will not be treated as debt holders and therefore are unlikely to recover any proceeds.

In the event of the dissolution or bankruptcy of the Company, the holders of the Securities will be entitled to distributions as described in the Securities. This means that such holders will only receive distributions once all of the creditors and more senior security holders, including any holders of preferred membership interests, have been paid in full. Neither holders of the Securities can be guaranteed any proceeds in the event of the dissolution or bankruptcy of the Company.

There is no guarantee of a return on an Investor's investment.

There is no assurance that an Investor will realize a return on their investment or that they will not lose their entire investment. For this reason, each Investor should read this Form C and all exhibits carefully and should consult with their attorney and business advisor prior to making any investment decision.

In this case, while the name of the Company itself is Smart Cups, Inc., the name of the SPV is Smart Cups SPV, LLC. You and all the other Regulation Crowdfunding investors will invest in Smart Cups SPV, LLC and Smart Cups SPV, LLC will, in turn, use your money to invest in Smart Cups, Inc. Hence, Smart Cups SPV, LLC will be reflected as one investor in Smart Cups, Inc.

Smart Cups, Inc. believes this structure – with one investor rather than many – will make it easier to raise additional capital in the future because the Offering will leave the Company with only one investor on its capitalization table.

Smart Cups SPV, LLC will conduct no business other than to invest in Smart Cups, Inc. The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. Smart Cups SPV, LLC will be managed by the Company itself. All the information about “the Company” in this Form C refers to Smart Cups, Inc., not to Smart Cups SPV, LLC unless otherwise indicated.

NOTE TO INVESTORS: As explained above, you will invest in Smart Cups SPV, LLC, not in the Company directly. You will receive an interest in Smart Cups SPV, LLC called “Investor Shares” while Smart Cups SPV, LLC will receive shares of Common Shares issued by the Company. Voting Proxy to the Manager

With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a voting proxy granted by Investor in the subscription agreement (Exhibit C), has appointed or will appoint the Manager, Smart Cups, Inc., as the Investor's true and lawful proxy (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by PicMii Crowdfunding, LLC, and (ii) execute, in connection with such voting power any instrument or document that the Manager determines is necessary and appropriate in the exercise of his or her authority. The Investor Shares shall have one hundred percent (100%) of the economic rights and no management rights other than to replace the Manager upon a majority vote at a duly called meeting. The Manager Shares shall be held only by Smart Cups, Inc., or its affiliates or assigns. The Manager Shares will confer no economic rights but shall confer one hundred percent (100%) of the management authority to the holders of the Manager Shares. 17. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of securities?

Investors should understand the potential for dilution. The investor's stake in a company could be diluted due to the company issuing additional shares. In other words, when the company issues more shares, the percentage of the company that you own will go down, even though the value of

the company may go up. You will own a smaller piece of a larger company. This increase in number of shares outstanding could result from a stock offering (such as an initial public offering, another crowdfunding round, a venture capital round, angel investment), employees exercising stock options, or by conversion of certain instruments (e.g., convertible bonds, preferred shares or warrants) into stock. If the company decides to issue more shares, an investor could experience value dilution, with each share being worth less than before, and control dilution, with the total percentage an investor owns being less than before. There may also be earnings dilution, with a reduction in the amount earned per share (though this typically occurs only if the company offers dividends, and most early-stage companies are unlikely to offer dividends, preferring to invest any earnings into the company)

18. Are there any differences not reflected above between the securities being offered and each other class of security of the issuer?

Smart Cups has Class A Common Stock and Class B Common Stock. Each share of Class A Common Stock shall entitle the holder to 1 vote. Each share of Class B Common Stock shall entitle the holder to 5 votes. Smart Cups is offering Class A Common Stock in this offering. The Class A Common Stock does have voting rights, however, the Smart Cups SPV, LLC investor shares have voting rights, however, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a voting proxy and power of attorney granted by the Investor in the Investor Agreement, has appointed or will appoint the Manager as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the investor to: (i) vote all securities related to the Company purchased in an offering hosted by PicMii Crowdfunding, LLC and (ii) execute, in connection with such voting power, any instrument or document that the Manager determines is necessary and appropriate in the exercise of his or her authority.

19. How could the exercise of rights held by the principal owners identified in Question 5 above affect the purchasers of Securities being offered?

The holder of a majority of the voting rights in the company may make decisions with which you disagree, or that negatively affect the value of your investment in the company, and you will have no recourse to change those decisions. Your interests may conflict with the interests of other investors, and there is no guarantee that the company will develop in a way that is advantageous to you. For example, the majority shareholder may decide to issue additional shares to new investors, sell convertible debt instruments with beneficial conversion features, or make decisions that affect the tax treatment of the company in ways that may be unfavorable to you. Based on the risks described above, you may lose all or part of your investment in the securities that you purchase, and you may never see positive returns.

20. How are the securities being offered valued? Include examples of methods for how such securities may be valued by the issuer in the future, including during subsequent corporate actions.

The issuer is raising this Regulation Crowdfunding round at a \$20,771,882.00 pre-money valuation.

The securities being offered are valued at the issuer's discretion. An early-stage company typically sells its shares (or grants options over its shares) to its founders and early employees at a very low cash cost, because they are, in effect, putting their "sweat equity" into the company. When the company seeks cash investments from outside investors, like you, the new investors typically pay a much larger sum for their shares than the founders or earlier investors, which means that the cash value of your stake is immediately diluted because each share of the same type is worth the same amount, and you paid more for your shares than earlier investors did for theirs.

There are several ways to value a company, and none of them is perfect and all of them involve a certain degree of guesswork. Any of these methods, plus others, may be used to determine valuation in the future:

Liquidation Value - The amount for which the assets of the company can be sold, minus the liabilities owed, e.g., the assets of a bakery include the cake mixers, ingredients, baking tins, etc. The liabilities of a bakery include the cost of rent or mortgage on the bakery. However, this value does not reflect the potential value of a business, e.g., the value of the secret recipe. The value for most startups lies in their potential, as many early-stage companies do not have many assets.

Book Value - This is based on analysis of the company's financial statements, usually looking at the company's balance sheet as prepared by its accountants. However, the balance sheet only looks at costs (i.e., what was paid for the asset), and does not consider whether the asset has increased in value over time. In addition, some intangible assets, such as patents, trademarks or trade names, are very valuable but are not usually represented at their market value on the balance sheet.

Earnings Approach - This is based on what the investor will pay (the present value) for what the investor expects to obtain in the future (the future return), taking into account inflation, the lost opportunity to participate in other investments, the risk of not receiving the return. However, predictions of the future are uncertain and valuation of future returns is a best guess.

Different methods of valuation produce a different answer as to what your investment is worth. Typically, liquidation value and book value will produce a lower valuation than the earnings approach. However, the earnings approach is also most likely to be risky as it is based on many assumptions about the future, while liquidation value and book value are much more conservative.

Future investors (including people seeking to acquire the company) may value the company differently. They may use a different valuation method, or different assumptions about the company's business and its market. Different valuations may mean that the value assigned to your investment changes. It frequently happens that when a large institutional investor such as a venture capitalist makes an investment in a company, it values the company at a lower price than the initial investors did. If this happens, the value of the investment would go down.

21. What are the risks to purchasers of the securities relating to minority ownership in the issuer?

The company's Certificate of Incorporation or Bylaws can be amended by the holders of a majority of the issued and outstanding shares of the Company. As minority owners, the crowdfunding investors are subject to the decisions made by the majority owners. The issued and outstanding shares of common stock give management voting control of the company. As a minority owner, you may be outvoted on issues that impact your investment, such as, among other things: (a) the liquidation, dissolution or winding up of the company, or effecting any merger or consolidation; (b) amendment of any provision of the Certificate of Incorporation or Bylaws; (c) creation and issuance of other securities having rights, preferences or privileges senior to the common stock sold to the crowdfunding investors, or increasing the authorized number of shares of stock of the company; or (d) creation of any debt security.

22. What are the risks to purchasers associated with corporate actions including:

The authorization and issuance of additional shares of the company's common stock will dilute the ownership of the crowdfunding investors. As a result, if the company achieves profitable operations in the future, its net income per share will be reduced because of dilution, and the market price of the company's common stock, if there is a market price, could decline as a result of the additional issuances of securities. If the company repurchases securities, so that the above risk is mitigated, and there are fewer shares of common stock outstanding, the company may not have enough cash available for marketing expenses, growth, or operating expenses to reach our goals. If we do not have enough cash to operate and grow, we anticipate the market price of our securities would decline. A sale of the company or of all of the assets of the company may result in an entire loss of your investment. We cannot predict the market value of the company or its assets, and the proceeds of a sale may not be cash, but instead, unmarketable securities, or an assumption of liabilities. It is unlikely that in the near term, a sale would result in a premium that is significant enough over book value to generate a return to our investors. We may need to negotiate with a related party for additional capital. No assurance can be given that such funds will be available or, if available, will be on commercially reasonable terms satisfactory to us. Even if such financing is available, it may be on terms that are materially averse to your interests with respect to dilution of book value, dividend preferences, liquidation preferences, or other terms.

Financial Condition of the Issuer

26. Does the issuer have an operating history?

27. Describe the financial condition of the issuer, including, to the extent material, liquidity, capital resources and historical results of operations.

Background:

The Company has generated approximately \$2.5 million in historical revenue through direct-to-consumer product sales, validating its technology and market demand. The Company is currently transitioning from a product-focused model to a capital-efficient platform strategy centered on licensing, partnerships, and strategic collaborations.

As part of this transition, the Company is focused on reducing operational overhead while expanding higher-margin revenue opportunities. The Company will require additional capital to execute its business plan, including commercialization of partnerships, continued product development, and expansion into new markets. There can be no assurance that the Company will achieve profitability in the near term.

Operations:

In 2024, the company generated \$217,414 in revenue with a gross profit of \$123,467 (57% margin), but incurred significant operating expenses of \$1.43 million, resulting in an operating loss of \$1.31 million and a net loss of \$1.53 million.

In 2025, revenue declined to \$94,145 (down ~57% YoY), with gross profit of \$63,820. Operating expenses decreased substantially to \$731,486 (down ~49%), reflecting cost-cutting efforts. The company reported an operating loss of \$667,666 and a net loss of \$1.15 million.

Liquidity and Capital Resources:

As of December 31, 2024, the company held \$331,382 in cash, supported by \$1.99 million raised through SAFE agreements, resulting in positive financing cash flow of \$1.97 million.

By December 31, 2025, cash declined sharply to \$10,311 due to continued operating losses and negative operating cash flow of \$813,701, partially offset by \$177,286 in financing inflows.

Current assets fell from \$483,888 to \$88,513, while current liabilities increased from \$877,770 to \$1.34 million.

Capital Expenditures and Other Obligations:

In 2024, the company invested \$141,816 in property and equipment, contributing to a substantial fixed asset base of approximately \$5.0 million. Capital expenditures slowed in 2025, with no new fixed asset purchases reported, suggesting a shift from buildout to utilization.

The company carries meaningful lease obligations, with total lease liabilities of approximately \$1.11 million in 2024 and \$1.02 million in 2025, alongside right-of-use assets. Debt remains modest, with loans increasing slightly from \$100,000 to \$128,767.
