The technology sector is highly competitive and rapidly evolving. Our success depends on our ability to anticipate and adapt to changes in market conditions, emerging technologies, and customer preferences. Our competitors often enjoy significantly higher financial and other resources compared to us. We cannot guarantee that our current or potential competitors will not offer products or services that are comparable or superior to ours or adapt more swiftly to evolving industry or market trends. The intensification of competition could lead to price reductions, reduced gross margins, and a loss of market share, all of which would have a significant adverse impact on our business, prospects, financial condition, or operational results.

Because the company relies heavily on SEO/SEM and both paid and free social media, customer acquisition costs could rise if Google and other dominant platforms and social network companies significantly raise their rates or changed their business model.

A severe global recession or pandemic could cause venue closures or other events that would shut down the live music industry or severely depress the demand for live performances.

The company relies on various data and music/video streaming services for content. Any changes to their APIs or pricing models could negatively affect our product or raise expenses.

Our business model relies on the utilization of several third-party technology providers to ensure the normal operation of our service. These third-party providers offer critical infrastructure, hosting services, data storage, network connectivity, and other essential components that enable us to deliver our SaaS solution to our customers. We do not have direct control over these third-party providers, and our ability to deliver a seamless user experience may be subject to factors beyond our control. Interruption to these third-party services can cause operational delays with respect to our product experience.

We face risks as it pertains to competitors. Another player in the space could enter the independent artist market. They could be better funded or have better brand recognition than we do, making it difficult for us to secure or maintain market share.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful

in attracting and retaining other personnel we require to successfully grow our business.

This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors’ interests in the investments will be recorded in each investor’s “Portfolio” page on the Wefunder platform. Gigmor, Inc. is offering up to 1,431,298 shares of Series Seed Preferred Stock, at a price per share of \$0.5764.

Investors in the first \$249,999.88 of the offering will receive

stock at a price per share of \$0.5240, and a pre-money valuation of \$6,999,510.26. Wefunder VIP investors will be entitled to these terms for the entire duration of the offering, even if the threshold limit noted above is met.

The campaign maximum is \$750,000 and the campaign minimum is \$50,000.08.

VIP Bonus

Gigmor will offer a discount to the normal terms listed in this Form C for all investments that are committed by investors who are part of Wefunder, Inc's VIP program. This means eligible Wefunder investors will receive a discount for any securities they purchased in this offering. For more specific details on the company's discount, please review the description of the terms above.

The discount is only valid until the offering closes. Investors eligible for the bonus will also receive priority if they are on a waitlist to invest and the company exceeds its maximum funding goal. They will be given the first opportunity to invest if space in the offering becomes available due to the cancellation or failure of previous investments.

Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. Gigmor, Inc. (the “Company” or “Gigmor”) was originally formed as a California limited liability company on February 8th, 2010, under the name Trybe, LLC. Upon majority consent of the former members, the entity was converted to a Delaware corporation on November 10th, 2014. Concurrent with the conversion, the name of the entity was changed to Gigmor, Inc.

- *Assets.* As of December 31, 2022, the Company had total assets of \$220,443, including \$1,294 in cash. As of December 31, 2021, the Company had \$218,764 in total assets, including \$25,363 in cash.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 2 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Runway & Short/Mid Term Expenses

Gigmor, Inc. cash in hand is \$27,735.59, as of August 2023. Over the last three months, revenues have averaged \$17,000/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$27,000/month, for an average burn rate of \$10,000 per month. Our intent is to be profitable in 12 months.

Since the date of our financial statements, there have been no material changes or trends in our operations or finances.

In six months, we expect to get to approximately a \$500k annual revenue run-rate and roughly \$800k in an annual expense run-rate.

We expect to need approximately \$1M - \$1.2M in capital to eventually reach profitability by Q4 2024.
