8. Discuss the material factors that make an investment in the issuer speculative or risky:

Technology Risk: Reveal AI uses generative AI, specifically, large-language models, to power many features and capabilities in the product. The genAI market, and providers of LLMs, are in the early stages of development and thus, highly dynamic and unpredictable. Because Reveal AI is dependent upon the availability, affordability, performance and reliability of large-language models, any disruptions, consolidations, governmental regulations, societal pushback and technology changes impacting these models and providers may have risks and negative implications for Reveal AI's viability, ability to generate revenue and/or requirement to fund suitable alternatives.

Execution Risk: Building products which use large-language models and other generative AI technologies is relatively new. As such, there are domains in the Reveal AI product, such as prompt engineering, which are more art than science and will be for the foreseeable future. There is risk in executing the product roadmap due to more resources needed than expected, features not able to be developed, features which operate inconsistently and features or architecture or information security capabilities which must be re-built because the underlying gen AI technology changed. Any, some or all of these risks could impact Reveal AI cash flow, ability to generate revenue and ability to support customer requests at a viable quantity of resources.

Execution Risk: Reveal AI is dependent upon key personnel whose expertise, knowledge, skills, experience and/or relationship network are essential factors driving product development, customer acquisition and support and company operations, administration, talent recruiting and fundraising. Should any of these key personnel depart the company, or require a leave of absence for whatever personal reasons, there could be a risk to continued, timely execution of product development, customer acquisition and thus, a risk to company viability.

Market Risk - Customers. Reveal AI is an early stage generative AI startup innovating in a very new space subject to the pace and degree to which customers are open, willing and have budget to adopt and apply new technologies. Many large customers are moving very deliberately as they evaluate the benefits and risks of using products which employ generative AI technology. Many are taking a "wait and see" approach rather than adopting gen AI products at scale. Reveal AI's cash flow, and thus viability, is dependent upon the revenue flow from customers and thus, the pace and degree of customer adoption, from an initial pilot to broad adoption by users who employ the product every month. If customer adoption of Reveal AI's product is low or lumpy or stalls out at initial pilots or is not broad w/in a customer's organization or does not grow as hoped, there is a risk to company cash flow and company viability.

Market Risk - Competitors. The generative AI space is relatively new and represents considerable opportunity for new entrants with interesting and innovative ideas funded by VCs, angels and bootstrapped founders. The \$10B+ market in which Reveal AI is operating has attracted competitors and will continue to attract competitors. Also, some large companies may decide to build capabilities similar to Reveal AI using in-house resources. Should any

of the competitors or alternatives to Reveal AI gain substantial and durable advantages, such as in technology, product features, sales and distribution channel partnerships, capital, brand credibility, influencer recognition and referrals or other areas, there are risks to Reveal AI's ability to acquire customers, generate revenue and remain viable.

**Regulatory Risk:** Generative AI, including Large Language Models, are very new and the use cases are unfolding in unpredictable ways. There is the risk that State, National and/or Supranational government entities enact regulations or laws which impose constraints, limitations or restrictions on the use of Generative AI, including Large Language Models, which materially reduce Reveal AI's ability to deliver a valuable product to customers, thereby negatively impacting revenue and company viability.

**Capital Risk:** Reveal AI may need to raise additional capital in the future to maintain product feature parity with competitors, continue a pipeline of innovative features to spur customer adoption, scale GTM and revenue operations and achieve profitability.

The Company may never receive a future equity financing or elect to convert the Securities upon such future financing. In addition, the Company may never undergo a liquidity event such as a sale of the Company or an IPO. If neither the conversion of the Securities nor a liquidity event occurs, the Purchasers could be left holding the Securities in perpetuity. The Securities have numerous transfer restrictions and will likely be highly illiquid, with no secondary market on which to sell them. The Securities are not equity interests, have no ownership rights, have no rights to the Company's assets or profits and have no voting rights or ability to direct the Company or its actions.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we raise: **\$50,000**

Use of Proceeds: 93.1% toward additional engineering resources who will accelerate product development in response to the needs of our largest customers for enterprise-grade scale, integrations and automation; remaining 6.9% goes to Wefunder

If we raise: **\$120,000**

Use of Proceeds: 93.1% toward more engineering resources who will accelerate product development of features for AI assistance

accelerate product development or features for AI assistance in creating and designing interviews and in easily discovering the story in the interview response data; remaining 6.9% goes to Wefunder. With \$120K, Reveal would hire additional engineering resources to accelerate the development of new interview innovations, reaching a GA 1-2 quarters faster than if we only raised \$50K.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle (“SPV”). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors’ interests in the investments will be recorded in each investor’s “Portfolio” page on the Wefunder platform. All references in this Form C to an Investor’s investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

## Ownership and Capital Structure

### THE OFFERING

The main terms of the SAFEs are provided below.

The SAFEs. We are offering securities in the form of a Simple Agreement for Future Equity ("SAFE"), which provides Investors the right to **preferred stock** in the Company ("**Preferred Stock**"), when and if the Company sponsors an equity offering that involves **Preferred Stock**, on the standard terms offered to other Investors.

*Conversion to Preferred Equity.* Based on our SAFEs, when we engage in an offering of equity interests involving **preferred stock**, **Investors will receive a number of shares of preferred stock** calculated using the method that results in the greater number of **preferred stock**:

1. the total value of the Investor's investment, divided by
  1. the price of **preferred stock** issued to new Investors multiplied by
  2. the **discount rate** (80%), or
2. for investors up to the first **\$50,000.00** of the securities, investors will receive a discount rate of 70.0%.

*Liquidity Events.* If the Company has an initial public offering or is acquired by, merged with, or otherwise taken over by another company or new owners prior to Investors in the SAFEs receiving **preferred stock**, Investors will receive

- proceeds equal to the greater of (i) the Purchase Amount (the "Cash-Out Amount") or (ii) the amount payable on the number of shares of Common Stock equal to the Purchase Amount divided by the Liquidity Price (the "Conversion Amount")

*Liquidity Priority.* In a Liquidity Event or Dissolution Event, this Safe is intended to operate like standard nonparticipating Preferred Stock.

The Investor's right to receive its Cash-Out Amount is:

1. Junior to payment of outstanding indebtedness and creditor claims, including contractual claims for payment and convertible promissory notes (to the extent such convertible promissory notes are not actually or notionally converted into Capital Stock);
2. On par with payments for other Safes and/or Preferred Stock, and if the applicable Proceeds are insufficient to permit full payments to the Investor and such other Safes and/or Preferred Stock, the applicable Proceeds will be distributed pro rata to the Investor and such other Safes and/or Preferred Stock in proportion to the full payments that would otherwise be due; and
3. Senior to payments for Common Stock.

#### **Securities Issued by the SPV**

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

#### **Voting Rights**

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

#### **Proxy to the Lead Investor**

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

#### **Restriction on Transferability**

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

Any provision of this Safe may be amended, waived or modified by written consent of the Company and either:

- i. the Investor or
- ii. the majority-in-interest of all then-outstanding Safes with the same "Post-Money Valuation Cap" and "Discount Rate" as this Safe (and Safes lacking one or both of such terms will be considered to be the same with respect to such term(s)), provided that with respect to clause (ii):
  - A. the Purchase Amount may not be amended, waived or modified in this manner,
  - B. the consent of the Investor and each holder of such Safes must be solicited (even if not obtained), and
  - C. such amendment, waiver or modification treats all such holders in the same manner. "Majority-in-interest" refers to the holders of the applicable group of Safes whose Safes have a total Purchase Amount greater than 50% of the total Purchase Amount of all of such applicable group of Safes.

Pursuant to authorization in the Investor Agreement between each Investor and Wefunder Portal, Wefunder Portal is authorized to take the following actions with respect to the investment contract between the Company and an investor:

- A. Wefunder Portal may amend the terms of an investment contract, provided that the amended terms are more favorable to the investor than the original terms; and
- B. Wefunder Portal may reduce the amount of an investor's investment if the reason for the reduction is that the Company's offering is oversubscribed.

- 26,000+ AI-powered interviews conducted and 140,000+ responses analyzed so far.
- Started generating revenue in early 2023 (4 months post-launch). Entered 2024 with healthy pipeline.
- Leadership team has founded software/data businesses which generated over \$2B+ in total revenue.
- Now raising funds to accelerate product development & scale to meet needs of high-volume customers.

#### Historical Results of Operations

Our company was organized in July 2022 and has limited operations upon which prospective investors may base an evaluation of its performance.

To-date, the company has been financed with \$855,000 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 9 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

## **Runway & Short/Mid Term Expenses**

REVEAL AI INC cash in hand is \$25,500, as of March 2024. Over the last three months, revenues have averaged \$5,000/month, cost of goods sold has averaged \$2,000/month, and operational expenses have averaged \$16,500/month, for an average burn rate of \$13,500 per month. Our intent is to be profitable in 11 months.

Uploaded financials cover CY2022, which was 6 months of operations. We started generating revenue in Q1 CY2023. Monthly burn rate during CY2023 was between \$12,500 and \$20,000. Current monthly burn rate averages \$18,500, which includes operating expenses and COS expenses.

Revenue for the upcoming 9 months will range from \$110,000 to \$160,000 depending upon the timing of product usage at our largest Enterprise customers and deals in the pipeline. Operating expenses and COGS expenses for the upcoming 9 months will average \$18,500 per month (\$16,500/mo in opex and \$2,000/mo in COS). We expect to be cash flow positive on a monthly basis in December, 2024, based upon forecast product usage volume, and thus monthly revenue, from large customers.

We are not currently profitable. We plan to hold the monthly expenses to a range of \$15,000 to \$20,000 until monthly revenue grows to \$20,000 to \$25,000, leading to profitability in Q1 or Q2 of 2025. The current founders and senior leaders do not take a monthly salary and do not plan to take a monthly salary until Reveal becomes cash flow positive.

Besides funds raised through Wefunder, we have raised capital from founders and angel investors, many of whom have offered to make additional investments as needed if the revenue growth does not materialize when expected in 2024. Monthly operating expenses average \$16,500 and monthly COS is \$2,000, therefore, the monthly burn rate is about \$18,500. Thus, for the rest of 2024, 9 months (Q2, Q3, Q4), cash needed is approximately \$180K. Revenue for the upcoming 9 months is forecast between \$110K and \$160K, which equates to cash receivables of between \$110K and \$160K. Hitting the minimum of \$50K invested during this raise plus the midpoint of revenue forecast, \$135K, yields \$185K of cash to cover the rest of the year. This is a conservative view because revenue for CY2023 was \$115K.

Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. In the event the Lead Investor quits or is removed, the Company will choose a Successor Lead Investor who must be approved by Wefunder Inc. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company. In such as circumstance, the Lead Investor may act as a portfolio manager for that Fund (and as a supervised person of Wefunder Advisors) and may be compensated through that role.

Although the Lead Investor may act in multiple roles with respect to the Company's offerings and may potentially be compensated for some of its services, the Lead Investor's goal is to maximize the value of the Company and therefore maximize the value of securities issued by or related to the Company. As a result, the Lead Investor's interests should always be aligned with those of Investors. It is, however, possible that in some limited circumstances the Lead Investor's interests could diverge from the interests of Investors, as discussed in section 8 above.

Investors that wish to purchase securities related to the Company through Wefunder Portal must agree to give the Proxy described above to the Lead Investor, provided that if the Lead Investor is replaced, the Investor will have a 5-day period during which he or she may revoke the Proxy. If the Proxy is not revoked during this 5-day period, it will remain in effect.

**Tax Filings.** In order to complete necessary tax filings, the SPV is required to include information about each investor who holds an interest in the SPV, including each investor's taxpayer identification number ("TIN") (e.g., social security number or employer identification number). To the extent they have not already done so, each investor will be required to provide their TIN within the earlier of (i) two (2) years of making their investment or (ii) twenty (20) days prior to the date of any distribution from the SPV. If an investor does not provide their TIN within this time, the SPV reserves the right to withhold from any proceeds otherwise payable to the Investor an amount necessary for the SPV to satisfy its tax withholding obligations as well as the SPV's reasonable estimation of any penalties that may be charged by the IRS or other relevant authority as a result of the investor's failure to provide their TIN. Investors should carefully review the terms of the SPV Subscription Agreement for additional information about tax filings.

3. the issuer has filed at least three annual reports and has total assets that do not exceed \$10 million;
4. the issuer or another party purchases or repurchases all of the securities issued pursuant to Section 4(a)(6), including any payment in full of debt securities or any complete redemption of redeemable securities; or the issuer liquidates or dissolves in accordance with state law.
