



# Offering Statement for EVII Mission Hills Inc. ("EVII Mission Hills")

EVII Mission Hills Inc. ("EVII Mission Hills Inc.," the "Company," "we," or "us"), a California C-Corp incorporated on March 14, 2024, is holding the following offering:

Up to \$3,499,999.50 in Class B Non-Voting Common Stock at \$2.85 with a minimum target amount of \$10,000.65.

## Business and Anticipated Business Plan

**6. Describe in detail the business of the issuer and the anticipated business plan of the issuer.**

### **Business Overview:**

EV Initiative Infrastructure (EVII) is developing a next-generation EV charging destination at 15555 San Fernando Mission Blvd. in Mission Hills, Los Angeles — at the convergence of the I-405, I-5, and SR-118 freeways. The site is one of the most strategically positioned charging locations in Southern California, with over 600,000 vehicles passing within a two-mile radius daily.

The flagship hub features 19 Tesla V4 Supercharger stalls (NACS + CCS) integrated into Tesla's navigation and routing network, three iconic architectural canopies with LED lighting, and an AI-monitored Volt.ai security system across 18 cameras. Beyond charging, the site is designed as a full destination experience: a gourmet food trailer (the Nourishment Zone, serving shawarma, tacos, and salads), a KioSoft 3.5E robotic barista offering 35+ beverages (the Hydration Zone), smart vending, premium ADA-compliant washrooms, a food truck commissary, a weatherproof audio system, digital rate boards, CatStrap cable protectors, and Starlink business internet. In partnership with EV Initiative as the operating Charge Port Operator (CPO), EVII leads site development, infrastructure deployment, and ongoing operations — supporting California's accelerating transition to electric mobility.

### **Problem:**

As electric vehicle adoption accelerates across Los Angeles, public charging infrastructure is struggling to keep pace—drivers face too few high-speed chargers, outdated equipment, inconvenient locations, and unreliable service, creating long wait times and range anxiety. With California mandating 100% zero-emission new vehicle sales by 2035, the gap between EV growth and charging availability is widening rapidly.

### **Solution:**

EVII Mission Hills addresses this directly. The site puts 19 Tesla V4 Supercharger stalls — integrated into Tesla's navigation and automatically suggested to drivers routing through the area — at the most trafficked freeway interchange in the San Fernando Valley. Charging is fast, reliable, and visible from the freeway. While drivers wait, they have access to a gourmet food

trailer, a robotic barista, and premium washroom facilities. The site is monitored 24/7 by an AI-powered security system across 18 cameras. This is EV charging built around the driver experience, not just the hardware.

### **Market Opportunity:**

The electric vehicle market presents one of the largest infrastructure opportunities in a generation, and California is leading it. The state mandates 100% zero-emission new vehicle sales by 2035, EV registrations are climbing every year, and public charging infrastructure remains severely undersupplied — especially in high-traffic urban corridors like Los Angeles.

More than 600,000 vehicles pass within a two-mile radius of Mission Hills every day. The I-405/I-5/SR-118 interchange is one of the highest-volume freeway confluences in the country, and it currently has no comparable charging destination within range. That gap is the opportunity. EVII Mission Hills generates revenue across six streams: Tesla Supercharger energy sales, Low Carbon Fuel Standard (LCFS) carbon credits, food and beverage, vending, digital advertising, and audio advertising — creating a diversified, asset-backed income model that goes well beyond a typical charging station.

## **Business Model:**

EV Initiative Infrastructure (EVII) operates a vertically integrated EV charging model built around strategic real estate, ultra-fast charging technology, and centralized management. The company develops high-traffic charging hubs and partners with EV Initiative (CPO) to oversee operations through its proprietary Charging Management Software (CMS), which enables real-time monitoring, pricing control, and automated payments.

## **Key Elements:**

- Ownership and development of prime commercial EV charging sites
- Deployment of 19 Tesla V4 Supercharger stalls integrated into Tesla navigation and routing
- Centralized network operations and performance management
- Six revenue streams: Tesla Supercharger energy sales, LCFS carbon credits, food and beverage, vending, digital advertising, and audio advertising
- Community co-ownership structure offering equity participation

This streamlined, asset-backed model is designed for scalability as EV adoption accelerates.

## **Reasons to Invest:**

- 1. Prime High-Traffic Location:** Located directly off the I-405/I-5/SR-118 interchange with over 600,000 vehicles passing within two miles daily. Tesla's navigation system automatically routes drivers to Supercharger stations, making this site a built-in destination for the largest and fastest-growing EV ownership base in the country.
- 2. Scalable Infrastructure Model:** Each site is built on the same replicable model: Tesla Supercharger integration, destination amenities, six revenue streams, and direct equity ownership per location. Mission Hills is the proof-of-concept. Additional high-traffic sites in the pipeline follow the same structure.
- 3. Strong EV Market Tailwinds:** California mandates 100% zero-emission new vehicle sales by 2035. Los Angeles is the largest EV market in the United States. The gap between vehicles on the road and charging infrastructure available is widening — this site sits at the center of it.
- 4. Asset-Backed Investment:** Investors acquire direct equity in EVII Mission Hills Inc., the California corporation that owns and operates this asset. Returns are tied to the physical infrastructure, the real estate, and the long-term performance of the site — not a fund or a promise.

**The amount of capital the Company is attempting to raise in this Offering may not be enough to sustain the Company's current business plan.**

In order to achieve the Company's near and long-term goals, the Company may need to procure funds in addition to the amount raised in the Offering. There is no guarantee the Company will be able to raise such funds on acceptable terms or at all. If we are not able to raise sufficient capital in the future, we may not be able to execute our business plan, our continued operations may require a significant pivot in strategy and execution, which could cause an Investor to lose all or a portion of their investment.

**We may face potential difficulties in obtaining capital**

We may have difficulty raising needed capital in the future as a result of, among other factors, our lack of revenue, as well as the inherent business risks associated with our Company and present and future market conditions.

**The Company's success depends on the experience and skill of its manager and other key personnel.**

In particular, we are dependent on our managers. The loss of the Managers, the Principals or any other key personnel could harm the Company's business, financial condition, cash flow and performance. Accordingly, you should not invest in the Company unless you are willing to entrust all aspects of the management of the Company and the investment decisions we make on the behalf of the Company.

**Although dependent on certain key personnel, the Company does not have any key person life insurance policies on any such people**

We are dependent on certain key personnel in order to conduct our operations and execute our business plan, however, the Company has not purchased any insurance policies with respect to those individuals in the event of their death or disability. Therefore, if any of these personnel die or become disabled, the Company will not receive any compensation to assist with such person's absence. The loss of such person could negatively affect the Company and our operations. We have no way to guarantee key personnel will stay with the Company, as many states do not enforce non-competition agreements, and therefore acquiring key man insurance will not ameliorate all of the risk of relying on key personnel.

**Damage to our reputation could negatively impact our business, financial condition and results of operations.**

Our reputation and the quality of our brand are critical to our business and success and will be critical to our success as we form and advise new markets. Any incident that erodes confidence in our brand could significantly reduce the Company's value and damage our business. We may be adversely affected by any negative publicity, regardless of its accuracy. Also, there has been a marked increase in the use of social media platforms and similar devices, including blogs, social media websites and other forms of internet-based communications that provide individuals with access to a broad audience. The availability of information on social media platforms is virtually immediate as is its impact. Information posted may be averse to our interests or may be inaccurate, each of which may harm our performance, prospects or business. The harm may be immediate and may disseminate rapidly and broadly, without affording us an opportunity for redress or correct.

**Neither the Offering nor the Securities have been registered under federal or state securities laws.**

No governmental agency has reviewed or passed upon this Offering or the Securities. Neither the Offering nor the Securities have been registered under federal or state securities laws. Investors will not receive any of the benefits available in registered Offerings, which may include access to quarterly and annual financial statements that have been audited by an independent accounting firm. Investors must therefore assess the adequacy of disclosure and the fairness of the terms of this Offering based on the information provided in this Form C and the accompanying exhibits.

**The Company's management may have broad discretion in how the Company uses the net proceeds of the Offering.**

Unless the Company has agreed to a specific use of the proceeds from the Offering, the Company's management will have considerable discretion over the use of proceeds from the Offering. You may not have the opportunity, as part of your investment decision, to assess whether the proceeds are being used appropriately.

**The Company has the right to limit individual Investor commitment amounts based on the Company's determination of an Investor's sophistication.**

## Options, Warrants and Other Rights

### **17. How may the rights of the securities being offered be materially limited, diluted or qualified by the rights of any other class of securities?**

Investors should understand the potential for dilution. The investor's stake in a company could be diluted due by the company issuing additional shares. In other words, when the company issues more shares, the percentage of the company that you own will go down, even though the value of the company may go up. You will own a smaller piece of a larger company. This increase in number of shares outstanding could result from a stock offering (such as an initial public offering, another crowdfunding round, a venture capital round, angel investment), employees exercising stock options, or by conversion of certain instruments (e.g., convertible bonds, preferred shares or warrants) into stock. If the company decides to issue more shares, an investor could experience value dilution, with each share being worth less than before, and control dilution, with the total percentage an investor owns being less than before. There may also be earnings dilution, with a reduction in the amount earned per share (though this typically occurs only if the company offers dividends, and most early-stage companies are unlikely to offer dividends, preferring to invest any earnings into the company).

### **18. Are there any differences not reflected above between the securities being offered and each other class of security of the issuer?**

As a minority holder of Class B Non-Voting Common Stock of the company, you will have no voting rights in regard to the corporate actions of the company, including additional issuances of securities, company repurchases of securities, a sale of the company or its significant assets, or company transactions with related parties. Further, investors in this offering may have rights less than those of other investors and will have limited influence on the corporate actions of the company.

### **19. How could the exercise of rights held by the principal owners identified in Question 5 above affect the purchasers of Securities being offered?**

The holder of a majority of the voting rights in the company may make decisions with which you disagree, or that negatively affect the value of your investment in the company, and you will have no recourse to change those decisions. Your interests may conflict with the interests of other investors, and there is no guarantee that the company will develop in a way that is

advantageous to you. For example, the majority shareholder may decide to issue additional shares to new investors, sell convertible debt instruments with beneficial conversion features, or make decisions that affect the tax treatment of the company in ways that may be unfavorable to you. Based on the risks described above, you may lose all or part of your investment in the securities that you purchase, and you may never see positive returns.

**20. How are the securities being offered valued? Include examples of methods for how such securities may be valued by the issuer in the future, including during subsequent corporate actions.**

The issuer is raising this Regulation Crowdfunding round at a \$11,983,939.35 pre-money valuation, when including outstanding options.

The securities are valued at the issuer's discretion based on the Company's current stage of development, the strategic value of the Mission Hills site, and comparable infrastructure asset valuations. EVII Mission Hills Inc. is a pre-operational company that has secured a prime commercial real estate site at one of the most trafficked freeway interchanges in Los Angeles, completed engineering drawings for a 19-stall Tesla V4 Supercharger hub, and successfully raised over \$2,064,112 through a prior Regulation CF offering. The Company has established a partnership with Tesla for Supercharger integration, which provides a built-in driver routing advantage unavailable to competing charging operators. The valuation reflects the scarcity of comparable freeway-accessible charging sites in the Los Angeles market, the six-stream revenue model, and the progress made toward a Q1 2027 operational launch.

The Company has set its valuation internally without a formal-third party independent evaluation. The pre-money valuation has been calculated on a fully diluted basis. In making this calculation, we have assumed all outstanding options and warrants are exercised.

An early-stage company typically sells its shares (or grants options over its shares) to its founders and early employees at a very low cash cost, because they are, in effect, putting their "sweat equity" into the company. When the company seeks cash investments from outside investors, like you, the new investors typically pay a much larger sum for their shares than the founders or earlier investors, which means that the cash value of your stake is immediately diluted because each share of the same type is worth the same amount, and you paid more for your shares than earlier investors did for theirs.

There are several ways to value a company, and none of them is perfect and all of them involve a certain degree of guesswork. Any of these methods, plus others, may be used to determine valuation in the future:

**Liquidation Value** - The amount for which the assets of the company can be sold, minus the liabilities owed, e.g., the assets of a bakery include the cake mixers, ingredients, baking tins, etc. The liabilities of a bakery include the cost of rent or mortgage on the bakery. However, this value does not reflect the potential value of a business, e.g., the value of the secret recipe. The value for most startups lies in their potential, as many early-stage companies do not have many assets.

**Book Value** - This is based on analysis of the company's financial statements, usually looking at the company's balance sheet as prepared by its accountants. However, the balance sheet only looks at costs (i.e., what was paid for the asset), and does not consider whether the asset has increased in value over time. In addition, some intangible assets, such as patents, trademarks or trade names, are very valuable but are not usually represented at their market value on the balance sheet.

**Earnings Approach** - This is based on what the investor will pay (the present value) for what the investor expects to obtain in the future (the future return), taking into account inflation, the lost opportunity to participate in other investments, the risk of not receiving the return. However, predictions of the future are uncertain and valuation of future returns is a best guess.

Different methods of valuation produce a different answer as to what your investment is worth. Typically, liquidation value and book value will produce a lower valuation than the earnings approach. However, the earnings approach is also most likely to be risky as it is based on many assumptions about the future, while liquidation value and book value are much more conservative.

Future investors (including people seeking to acquire the company) may value the company differently. They may use a different valuation method, or different assumptions about the company's business and its market. Different valuations may mean that the value assigned to your investment changes. It frequently happens that when a large institutional investor such as a venture capitalist makes an investment in a company, it values the company at a lower price than the initial investors did. If this happens, the value of the investment would go down.

The company's Certificate of Incorporation or Bylaws can be amended by the holders of a majority of the issued and outstanding shares of the Company. As minority owners, the crowdfunding investors are subject to the decisions made by the majority owners. The issued and outstanding shares of common stock give management voting control of the company. As a minority owner, you may be outvoted on issues that impact your investment, such as, among other things: (a) the liquidation, dissolution or winding up of the company, or effecting any merger or consolidation; (b) amendment of any provision of the Certificate of Incorporation or Bylaws; (c) creation and issuance of other securities having rights, preferences or privileges senior to the common stock sold to the crowdfunding investors, or increasing the authorized number of shares of stock of the company; or (d) creation of any debt security.

The authorization and issuance of additional shares of the company's common stock will dilute the ownership of the crowdfunding investors. As a result, if the company achieves profitable operations in the future, its net income per share will be reduced because of dilution, and the market price of the company's common stock, if there is a market price, could decline as a result of the additional issuances of securities. If the company repurchases securities, so that the above risk is mitigated, and there are fewer shares of common stock outstanding, the company may not have enough cash available for marketing expenses, growth, or operating expenses to reach our goals. If we do not have enough cash to operate and grow, we anticipate the market price of our securities would decline. A sale of the company or of all of the assets of the company may result in an entire loss of your investment. We cannot predict the market value of the company or its assets, and the proceeds of a sale may not be cash, but instead, unmarketable securities, or an assumption of liabilities. It is unlikely that in the near term, a sale would result in a premium that is significant enough over book value to generate a return to our investors. We may need to negotiate with a related party for additional capital. No assurance can be given that such funds will be available or, if available, will be on commercially reasonable terms satisfactory to us. Even if such financing is available, it may be on terms that are materially adverse to your interests with respect to dilution of book value, dividend preferences, liquidation preferences, or other terms.

Those proceeds have been applied toward land, preliminary engineering, permitting, and organizational costs. The Company has no material debt obligations. Working capital is currently composed of funds from the prior raise and proceeds from this offering. The Company's capital resources and liquidity will be materially dependent on the proceeds raised in this offering and, in parallel, its Regulation D offering and C-PACE financing.
