### USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

Use of Proceeds: 30% towards marketing, 7.9% towards Wefunder Fees, 62.1% towards hires - brand ambassadors, sales

Use of Proceeds: 40% towards marketing, 7.9% towards Wefunder Fees, 52.1% towards hires - brand ambassadors, sales. Raising our max allows us to hire more brand ambassadors and expand our reach.

Book Entry and Investment in the Co-Issuer. Investors will make their investments by investing in interests issued by one or more co-issuers, each of which is a special purpose vehicle ("SPV"). The SPV will invest all amounts it receives from investors in securities issued by the Company. Interests issued to investors by the SPV will be in book entry form. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. All references in this Form C to an Investor's investment in the Company (or similar phrases) should be interpreted to include investments in a SPV.

12. How can an investor cancel an investment commitment?

Blind Tiger, Inc. is offering up to 338,928 shares of Series Seed-1 preferred stocks, at a price per share of \$0.3482.

Investors in the first \$50,000.00 of the offering will receive stocks at a price per share of \$0.3095, and a pre-money valuation of \$4,000,000.00.

The campaign maximum is \$124,000.00 and the campaign minimum is \$50,000.00.

#### Securities Issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. The Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

#### Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

#### Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

#### Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

Notwithstanding the foregoing, the addition of a party to this Agreement pursuant to a transfer of Shares in accordance with Section will not require any further consent. Any amendment or waiver effected in accordance with this Section will be binding upon the Purchasers, the Key Holders, each transferee of the shares of Series Seed Preferred Stock (or the Common Stock issuable upon conversion thereof) or Common Stock from a Purchaser or Key Holders, as applicable, and each future holder of all such securities, and the Company. It is specifically intended that entering into the Next Financing Agreements in a form substantially similar to the form agreements set as forth as Model Legal Documents on <http://www.nvca.org> shall be considered an amendment to this Agreement provided that it is done in accordance with this Section 8.8.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an investor's interests in the Company may be diluted. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. They may also vote to engage in new offerings and/or to register certain of the Company's securities in a way that negatively affects the value of the securities the Investor owns. The offering price for the securities offered pursuant to this Form C has been determined arbitrarily by the Company, and does not necessarily bear any relationship to the Company's book value, assets, earnings or other generally accepted valuation criteria. In determining the offering price, the Company did not employ investment banking firms or other outside organizations to make an independent appraisal or evaluation. Accordingly, the offering price should not be considered to be indicative of the actual value of the securities offered hereby.

In the future, we will perform valuations of our common stock that take into account factors such as the following:

1. unrelated third party valuations of our common stock;
2. the price at which we sell other securities, such as convertible debt or preferred Stock, in light of the rights, preferences and privileges of our those securities relative to those of our common stock;

Blind Tiger, Inc. was incorporated in the State of Pennsylvania in September 2022. Prior to that, the company was an LLC, organized in 2021.

Since then, we have:

- 100% YOY Revenue Growth; 222% in 2023
- 29 Top Tier Awards from Renowned National and International Beverage Competitions
- Sold in over 1000 retailers around the country
- Better-for-you ingredients; no artificial colors, flavors or preservatives
- Led by a team of industry experts from Sheraton, Frito Lay, Room 33, etc.

#### **Historical Results of Operations**

Our company was organized in September 2022 and has limited operations upon which prospective investors may base an evaluation of its performance.

- *Revenues & Gross Margin.* For the period ended December 31, 2023, the Company had revenues of \$326,682.46 compared to the year ended December 31, 2022, when the Company had revenues of \$109,484.32. Our gross margin was 54.95% in fiscal year 2023, compared to 43.45% in 2022.
- *Assets.* As of December 31, 2023, the Company had total assets of \$409,317.48, including \$118,780.25 in cash. As of December 31, 2022, the Company had \$136,972.11 in total assets, including \$36,036.65 in cash.
- *Net Loss.* The Company has had net losses of \$117,655.74 and net losses of \$123,148.80 for the fiscal years ended December 31, 2023 and December 31, 2022, respectively.
- *Liabilities.* The Company's liabilities totaled \$310,483.60 for the fiscal year ended December 31, 2023 and \$237,631.78 for the fiscal year ended December 31, 2022.

#### **Liquidity & Capital Resources**

To-date, the company has been financed with \$575,000 in equity, \$270,000 in convertibles, and \$50,000 in SAFES.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 12 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 4 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

#### **Runway & Short/Mid Term Expenses**

Blind Tiger, Inc. cash in hand is \$65,000, as of June 2024. Over the last three months, revenues have averaged \$30,000/month, cost of goods sold has averaged \$13,000/month, and operational expenses have averaged \$35,000/month, for an average burn rate of \$18,000 per month. Our intent is to be profitable in 12 months.

Since the date our financials cover, we increased sales volumes, market expansion (additional retailers), new distribution partners (two new statewide distributors), and product line expansion with variations on two varietals. We will reduce total SKU count from 13 to 5 in the coming year.

Based on current trends and new initiatives, we project our monthly revenues to be in the range of \$50,000 to \$75,000, culminating in total revenues of up to \$450,000 over the next 6 months. Given our revenue and expense projections, we expect a manageable net burn rate, with the goal of breaking even or achieving profitability within this period. If revenues fall short of expectations, we may require additional capital to cover operational expenses and support growth initiatives. We estimate needing an additional \$100,000 to \$200,000 to ensure financial stability and maintain momentum. Based on current projections, we expect to reach profitability within the next 12 months, contingent on successful execution of our growth strategies and market conditions.

We are not currently profitable, but with our full raise (\$1MM) we expect to be profitable in mid-2025. We will attempt to raise the majority of this amount off-Wefunder

Beyond the Wefunder capital, we have revenue from sales, Angel Investors, and a small micro-loan for \$15000. By diversifying our sources of capital and carefully managing our expenses, we are confident in our ability to navigate the path to profitability and ensure the success of Blind Tiger Spirit-Free Cocktails.
